1 AN ACT Relating to delineating charity care and notice 2 requirements without restricting charity care; amending RCW 3 70.170.020 and 70.170.060; and providing an effective date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 70.170.020 and 1995 c 269 s 2203 are each amended to 6 read as follows:

7 As used in this chapter:

8 (1) "Department" means department of health.

9 (2) "Hospital" means any health care institution which is 10 required to qualify for a license under RCW 70.41.020(((2))) <u>(7)</u>; or 11 as a psychiatric hospital under chapter 71.12 RCW.

(3) "Secretary" means secretary of health.

(4) "Charity care" means <u>medically</u> necessary hospital health care rendered to indigent persons <u>when third-party coverage</u>, if any, has <u>been exhausted</u>, to the extent that the persons are unable to pay for the care or to pay deductibles or coinsurance amounts required by a third-party payer, as determined by the department.

(5) <u>"Third-party coverage" means an obligation on the part of an</u>
insurance company, health care service contractor, health maintenance
organization, group health plan, government program, tribal health
benefits, or health care sharing ministry as defined in 26 U.S.C.

Sec. 5000A to pay for the care of covered patients and services, and may include settlements, judgments, or awards actually received related to the negligent acts of others which have resulted in the medical condition for which the patient has received hospital health care service. The pendency of such settlements, judgments, or awards must not stay hospital obligations to consider an eligible patient for charity care.

8 (6) "Sliding fee schedule" means a hospital-determined, publicly 9 available schedule of discounts to charges for persons deemed 10 eligible for charity care; such schedules shall be established after 11 consideration of guidelines developed by the department.

12 (((-6))) (7) "Special studies" means studies which have not been 13 funded through the department's biennial or other legislative 14 appropriations.

15 Sec. 2. RCW 70.170.060 and 1998 c 245 s 118 are each amended to 16 read as follows:

17 (1) No hospital or its medical staff shall adopt or maintain18 admission practices or policies which result in:

19 (a) A significant reduction in the proportion of patients who 20 have no third-party coverage and who are unable to pay for hospital 21 services;

(b) A significant reduction in the proportion of individuals admitted for inpatient hospital services for which payment is, or is likely to be, less than the anticipated charges for or costs of such services; or

(c) The refusal to admit patients who would be expected to require unusually costly or prolonged treatment for reasons other than those related to the appropriateness of the care available at the hospital.

30 (2) No hospital shall adopt or maintain practices or policies which would deny access to emergency care based on ability to pay. No 31 hospital which maintains an emergency department shall transfer a 32 patient with an emergency medical condition or who is in active labor 33 unless the transfer is performed at the request of the patient or is 34 due to the limited medical resources of the transferring hospital. 35 Hospitals must follow reasonable procedures in making transfers to 36 other hospitals including confirmation of acceptance of the transfer 37 38 by the receiving hospital.

1 (3) The department shall develop definitions by rule, as appropriate, for subsection (1) of this section and, with reference 2 federal requirements, subsection (2) of this section. 3 to The department shall monitor hospital compliance with subsections (1) and 4 (2) of this section. The department shall report individual instances 5 6 of possible noncompliance to the state attorney general or the 7 appropriate federal agency.

8 (4) The department shall establish and maintain by rule, 9 consistent with the definition of charity care in RCW 70.170.020, the 10 following:

11 (a) Uniform procedures, data requirements, and criteria for 12 identifying patients receiving charity care;

(b) A definition of residual bad debt including reasonable and uniform standards for collection procedures to be used in efforts to collect the unpaid portions of hospital charges that are the patient's responsibility.

17 (5) For the purpose of providing charity care, each hospital shall develop, implement, and maintain a charity care policy which, 18 consistent with subsection (1) of this section, shall enable people 19 below the federal poverty level access to appropriate hospital-based 20 medical services, and a sliding fee schedule for determination of 21 discounts from charges for persons who qualify for such discounts by 22 January 1, 1990. The department shall develop specific guidelines to 23 assist hospitals in setting sliding fee schedules required by this 24 25 section. All persons with family income below one hundred percent of the federal poverty standard shall be deemed charity care patients 26 for the full amount of hospital charges, ((provided that such persons 27 28 are not eligible for other private or public health coverage sponsorship. Persons who may be eligible for charity care shall be 29 notified by the hospital. 30

31 (6)) except to the extent the patient has third-party coverage 32 for those charges.

33 (6) Each hospital shall post and prominently display notice of 34 charity care availability. Notice must be posted in all languages 35 spoken by more than ten percent of the population of the hospital 36 service area. Notice must be displayed in at least the following 37 locations:

38 (a) Areas where patients are admitted or registered;

39 (b) Emergency departments, if any; and

1 <u>(c) Financial service or billing areas where accessible to</u> 2 patients.

3 (7) Current versions of the hospital's charity care policy, a 4 plain language summary of the hospital's charity care policy, and the 5 hospital's charity care application form must be available on the 6 hospital's web site. The summary and application form must be 7 available in all languages spoken by more than ten percent of the 8 population of the hospital service area.

9 <u>(8)(a) All hospital billing statements and other written</u> 10 <u>communications concerning billing or collection of a hospital bill by</u> 11 <u>a hospital must include the following or a substantially similar</u> 12 <u>statement prominently displayed on the first page of the statement in</u> 13 <u>both English and the second most spoken language in the hospital's</u> 14 <u>service area:</u>

15You may qualify for free care or a discount on your hospital16bill, whether or not you have insurance. Please contact our17financial assistance office at [web site] and [phone number].

18 (b) Nothing in (a) of this subsection requires any hospital to 19 alter any preprinted hospital billing statements existing as of 20 October 1, 2018.

(9) Hospital obligations under federal and state laws to provide 21 meaningful access for limited English proficiency and non-English-22 23 speaking patients apply to information regarding billing and charity care. Hospitals shall develop standardized training programs on the 24 25 hospital's charity care policy and use of interpreter services, and provide regular training for appropriate staff, including the 26 relevant and appropriate staff who perform functions relating to 27 28 registration, admissions, or billing.

29 <u>(10)</u> Each hospital shall make every reasonable effort to 30 determine:

31 <u>(a)</u> The existence or nonexistence of private or public 32 sponsorship which might cover in full or part the charges for care 33 rendered by the hospital to a patient;

34 <u>(b)</u> The <u>annual</u> family income of the patient as classified under 35 federal poverty income guidelines <u>as of the time the health care</u> 36 <u>services were provided, or at the time of application for charity</u> 37 <u>care if the application is made within two years of the time of</u> 38 <u>service, the patient has been making good faith efforts towards</u> 39 <u>payment of health care services rendered, and the patient</u> 40 demonstrates eligibility for charity care; and (c) The eligibility of the patient for charity care as defined in
this chapter and in accordance with hospital policy. An initial
determination of sponsorship status shall precede collection efforts
directed at the patient.

5 (((7))) (11) At the hospital's discretion, a hospital may 6 consider applications for charity care at any time, including any 7 time there is a change in a patient's financial circumstances.

(12) The department shall monitor the distribution of charity 8 care among hospitals, with reference to factors such as relative need 9 for charity care in hospital service areas and trends in private and 10 11 public health coverage. The department shall prepare reports that identify any problems in distribution which are in contradiction of 12 the intent of this chapter. The report shall include an assessment of 13 the effects of the provisions of this chapter on access to hospital 14 and health care services, as well as an evaluation of the 15 16 contribution of all purchasers of care to hospital charity care.

17 (((+8))) (13) The department shall issue a report on the subjects 18 addressed in this section at least annually, with the first report 19 due on July 1, 1990.
