27 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

28 NEW SECTION. **Sec. 1.** Increasing demands are being placed on
29 schools. It is important that schools are provided the flexibility to
30 determine how best to work with their local communities. It is the
31 intent of the legislature to provide schools increased flexibility,
32 which will assist them in better meeting the needs of their students.

33 NEW SECTION. **Sec. 2.** A new section is added to chapter 28A.320
34 RCW to read as follows:

35 (1) As specifically provided in chapters in this title, the board
36 of directors of each school district may grant waivers, or partial

1 waivers, of state laws and rules to schools within the district. The
2 school board shall grant waivers in accordance with this section.

3 (2) To apply for waivers, a school principal must prepare an
4 application to the board of directors that identifies which laws and
5 rules are being requested for waiver and the rationale for the
6 request. The rationale must identify how granting the waivers will
7 improve student learning or the delivery of education services in the
8 school.

9 (3) The school board shall provide for public review and comment
10 regarding the waiver request.

11 (4) The duration, renewal, and rescission of the waivers must be
12 determined by the school district board of directors.

13 (5) The following may not be waived:

14 (a) Compliance with local, state, and federal health, safety,
15 parents' rights, civil rights, and nondiscrimination laws;

16 (b) Provision of a program of basic education, that meets the
17 goals in RCW 28A.150.210;

18 (c) Employment of certificated instructional staff as required in
19 RCW 28A.410.025. However, school districts may hire noncertificated
20 instructional staff of unusual competence and in exceptional cases as
21 specified in RCW 28A.150.203(7);

22 (d) Compliance with the employee record check requirements in RCW
23 28A.400.303;

24 (e) Adherence to generally accepted accounting principles and be
25 subject to financial examinations and audits as determined by the
26 state auditor, including annual audits for legal and fiscal
27 compliance;

28 (f) Compliance with the annual performance report under RCW
29 28A.655.110;

30 (g) Compliance with the open public meetings act in chapter 42.30
31 RCW and public records requirements in chapter 42.56 RCW; and

32 (h) Compliance with state constitutional provisions, including
33 that a school may not engage in any sectarian practices in its
34 educational program, admissions, employment policies, or operations.

35 (6) A school district may not include provisions in a collective
36 bargaining agreement that limit the district's authority to grant
37 waivers under this section.

38 (7) School district boards of directors granting waivers to state
39 laws and rules shall submit to the superintendent of public

1 instruction and the state board of education a list of laws and rules
2 that have been waived in accordance with this section.
