AN ACT Relating to creating the Washington academic, innovation, and mentoring program; adding a new section to chapter 28A.215 RCW; and creating a new section.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 <u>NEW SECTION.</u> Sec. 1. A new section is added to chapter 28A.215 6 RCW to read as follows:

7 (1) The Washington academic, innovation, and mentoring program is 8 established.

9 (2) The purpose of the program is to enable eligible neighborhood youth development entities to provide out-of-school time programs for 10 11 youth ages six to eighteen years of age that include educational 12 services, social emotional learning, mentoring, and linkages to 13 positive, prosocial leisure, and recreational activities. The 14 programs must be designed for mentoring and academic enrichment.

(3) Eligible entities must meet the following requirements:

16 (a) Ensure that sixty percent or more of the academic, 17 innovation, and mentoring program participants must qualify for free 18 or reduced-price lunch;

(b) Have an existing partnership with the school district and acommitment to develop a formalized data-sharing agreement;

21 (c) Be facility based;

(d) Combine, or have a plan to combine, academics and social
emotional learning;

(e) Engage in a continuous program quality improvement process;

4 (f) Conduct national criminal background checks for all employees5 and volunteers who work with children; and

6 (g) Have adopted standards for care including staff training, 7 health and safety standards, and mechanisms for assessing and 8 enforcing the program's compliance with the standards.

9 (4) Nonprofit entities applying for funding as a statewide 10 network must:

11 (a) Have an existing infrastructure or network of academic, 12 innovation, and mentoring program grant-eligible entities;

13 (b) Provide after-school and summer programs with youth 14 development services; and

15 (c) Provide proven and tested recreational, educational, and 16 character-building programs for children ages six to eighteen years 17 of age.

18 (5) The office of the superintendent of public instruction must 19 submit a report to the appropriate education and fiscal committees of 20 the legislature by December 31, 2018, and an annual update by 21 December 31 each year thereafter. The report must outline the 22 programs established, target populations, and pretesting and 23 posttesting results.

24 <u>NEW SECTION.</u> Sec. 2. If specific funding for the purposes of 25 this act, referencing this act by bill or chapter number, is not 26 provided by June 30, 2017, in the omnibus appropriations act, this 27 act is null and void.
