14 On page 3, beginning on line 29 of the striking amendment, strike
15 all of subsections (b) and (c)

17 On page 4, line 17 of the striking amendment, after "each school

EFFECT: Allows, instead of requires, public schools to offer comprehensive sexual health education. Removes all content requirements for the comprehensive sexual health education. Instead, requires the content of the education to be developed by the school district based on its own standards that reflect local community standards of prevention behaviors. Removes the requirement that the Superintendent of Public Instruction review curricula not on the list developed by the Superintendent of Public Instruction. Removes the requirement that the Superintendent of Public Instruction provide technical assistance to schools to comply with the curriculum requirements. Removes the requirement that

schools describe how instruction complies with the curriculum requirements. Removes definitions of "affirmative consent," "comprehensive sexual health education," and "medically and scientifically accurate."
