- (((5))) (e) Satisfy the training requirements established by the

- $((\frac{6}{1}))$  (f) Submit a set of fingerprints; however, if an
- 23 applicant has been issued a license as a private investigator under
- 24 chapter 18.165 RCW within the last twelve months, the applicant is
- 25 not required to undergo a separate background check to become

- ((+8))) (h) Submit a fully completed application that includes
- 4 proper identification on a form prescribed by the director for each

- 6 (2) Until July 1, 2025, the annual license renewal fee may not
- 7 exceed eighty-five dollars. Beginning July 1, 2025, the director
- 8 may increase the license renewal fee by no more than five percent

- On page 1, after line 15, insert the following:
- "(3) Until July 1, 2025, the annual license renewal fee may not
- 16 exceed eighty-five dollars. Beginning July 1, 2025, the director
- 17 may increase the annual license renewal fee by no more than five
- 18 percent annually."

20 Correct the title.

EFFECT: Prohibits the annual license renewal fee for a private security guard or armed private security guard from exceeding \$85 until July 1, 2025. Allows the Director of the Department of Licensing to increase the annual license renewal fee by no more than 5 percent annually after July 1, 2025.
