1 On page 1, after line 2, insert the following:

2 "NEW SECTION. **Sec. 1.** The legislature declares its specific
3 intent to dedicate any savings generated by this act to a special
4 account to be used for purposes specified in section 3 of this act."

5 Renumber the remaining sections consecutively and correct any
6 internal references accordingly.

7 On page 3, after line 34, insert the following:

8 "NEW SECTION. **Sec. 3.** A new section is added to chapter 72.09
9 RCW to read as follows:

10 (1) The reentry and public safety account is created in the state
11 treasury.

12 (2) Expenditures from the account may be used only for:

13 (a) Reducing caseloads of community corrections officers by
14 increasing the number of community corrections officers;

15 (b) Implementing and expanding evidence-based strategies to
16 increase the effectiveness of community supervision;

17 (c) Funding medication-assisted treatment in jails; and

18 (d) Establishing and expanding reentry services for individuals
19 leaving incarceration from prisons and jails.

20 (3) It is the express intent of the legislature that moneys in
21 the reentry and public safety account may not be transferred to any
22 other account or spent for any purposes other than provided under
23 this section.

24 (4) Revenues to the reentry and public safety account consist of:

25 (a) Funds transferred to the account pursuant to this act; and

26 (b) Any other revenues appropriated to or deposited into the
27 account.

28 (5)(a) For the fiscal year beginning July 1, 2020, the state
29 treasurer shall transfer fourteen million eight hundred two thousand
30 dollars from the general fund to the reentry and public safety

1 account. For the fiscal year beginning July 1, 2021, the state
2 treasurer shall transfer fifteen million eight hundred fifty-three
3 thousand dollars from the general fund to the reentry and public
4 safety account. For the fiscal year beginning July 1, 2022, the state
5 treasurer shall transfer twenty-four million eight hundred forty-two
6 thousand dollars from the general fund to the reentry and public
7 safety account. For the fiscal year beginning July 1, 2023, the state
8 treasurer shall transfer thirty million five hundred ninety-five
9 thousand dollars from the general fund to the reentry and public
10 safety account. For the fiscal year beginning July 1, 2024, and each
11 subsequent fiscal year, the state treasurer shall transfer twenty-
12 eight million six hundred forty-five thousand dollars from the
13 general fund to the reentry and public safety account.

14 (b) Moneys transferred to the reentry and public safety account
15 in (a) of this subsection may only be used by the department for the
16 purposes of subsection (2) of this section.

17 (c) Moneys in the account may be spent only after appropriation.

18 (6) Moneys appropriated to the reentry and public safety account
19 may not be used to supplant existing funding or levels of service."

20 Renumber the remaining section consecutively and correct any
21 internal references accordingly.

22 On page 4, line 7, after "RCW;" strike "and creating a new
23 section" and insert "adding a new section to chapter 72.09 RCW; and
24 creating new sections"

EFFECT: Provides an intent section; establishes the reentry and public safety account in the state treasury; specifies the Legislature's intent that money in the account may not be transferred to any other account or spent for any other purpose; specifies the allowable uses of funds in the account; requires the state treasurer to transfer specified amounts from the general fund to the reentry and public safety account in certain fiscal years; and prohibits

money from the reentry and public safety account from being used to supplant existing funding or levels of services.
