1 Strike everything after the enacting clause and insert the  
2 following:

3 **"Sec. 1.** RCW 28B.15.012 and 2019 c 126 s 1 are each amended to  
4 read as follows:

5 Whenever used in this chapter:

6 (1) The term "institution" shall mean a public university,  
7 college, or community or technical college within the state of  
8 Washington.

9 (2) The term "resident student" shall mean:

10 (a) A financially independent student who has had a domicile in  
11 the state of Washington for the period of one year immediately prior  
12 to the time of commencement of the first day of the semester or  
13 quarter for which the student has registered at any institution and  
14 has in fact established a bona fide domicile in this state primarily  
15 for purposes other than educational;

16 (b) A dependent student, if one or both of the student's parents  
17 or legal guardians have maintained a bona fide domicile in the state  
18 of Washington for at least one year immediately prior to commencement  
19 of the semester or quarter for which the student has registered at  
20 any institution;

21 (c) A student classified as a resident based upon domicile by an  
22 institution on or before May 31, 1982, who was enrolled at a state  
23 institution during any term of the 1982-1983 academic year, so long  
24 as such student's enrollment (excepting summer sessions) at an  
25 institution in this state is continuous;

26 (d) Any student who has spent at least seventy-five percent of  
27 both his or her junior and senior years in high schools in this  
28 state, whose parents or legal guardians have been domiciled in the  
29 state for a period of at least one year within the five-year period  
30 before the student graduates from high school, and who enrolls in a  
31 public institution of higher education within six months of leaving

1 high school, for as long as the student remains continuously enrolled  
2 for three quarters or two semesters in any calendar year;

3 (e) Any person who has completed the full senior year of high  
4 school and obtained a high school diploma, both at a Washington  
5 public high school or private high school approved under chapter  
6 28A.195 RCW, or a person who has received the equivalent of a  
7 diploma; who has lived in Washington for at least three years  
8 immediately prior to receiving the diploma or its equivalent; who has  
9 continuously lived in the state of Washington after receiving the  
10 diploma or its equivalent and until such time as the individual is  
11 admitted to an institution of higher education under subsection (1)  
12 of this section; and who provides to the institution an affidavit  
13 indicating that the individual will file an application to become a  
14 permanent resident at the earliest opportunity the individual is  
15 eligible to do so and a willingness to engage in any other activities  
16 necessary to acquire citizenship, including but not limited to  
17 citizenship or civics review courses;

18 (f) Any person who has lived in Washington, primarily for  
19 purposes other than educational, for at least one year immediately  
20 before the date on which the person has enrolled in an institution,  
21 and who holds lawful nonimmigrant status pursuant to 8 U.S.C. Sec.  
22 (a)(15) (E)(iii), (H)(i), or (L), or who holds lawful nonimmigrant  
23 status as the spouse or child of a person having nonimmigrant status  
24 under one of those subsections, or who, holding or having previously  
25 held such lawful nonimmigrant status as a principal or derivative,  
26 has filed an application for adjustment of status pursuant to 8  
27 U.S.C. Sec. 1255(a);

28 (g) A student who is on active military duty stationed in the  
29 state or who is a member of the Washington national guard;

30 (h) A student who is on active military duty or a member of the  
31 Washington national guard who (~~entered service as a Washington~~  
32 ~~resident and who has maintained Washington as his or her domicile but~~  
33 ~~is not stationed in the state)) meets the following conditions:~~

34 (i) Entered service as a Washington resident;

35 (ii) Has maintained a Washington domicile; and

36 (iii) Is stationed out-of-state;

37 (i) A student who is the spouse or a dependent of a person (~~who~~  
38 ~~is on active military duty or a member of the national guard who~~

3 the student maintains the status as a resident student so long as the

5 (i) Admitted to an institution before the reassignment and  
6 enrolls in that institution for the term the student was admitted; or

7 (ii) Enrolled in an institution and remains continuously enrolled  
8 at the institution;

9 (j) A student who is the spouse or a dependent of a person  
10 defined in (h) of this subsection;

11 (k) A student who is eligible or entitled to transferred federal  
12 post-9/11 veterans educational assistance act of 2008 (38 U.S.C. Sec.  
13 3301 et seq.) benefits based on the student's relationship as a  
14 spouse, former spouse, or child to an individual who is on active  
15 duty in the uniformed services;

16 ~~((k))~~ (l) A student who resides in the state of Washington and  
17 is the spouse or a dependent of a person who is a member of the  
18 Washington national guard;

19 ~~((l))~~ (m) A student who has separated from the uniformed  
20 services with any period of honorable service after at least ninety  
21 days of active duty service; is eligible for educational assistance  
22 benefits under Title 38 U.S.C.; and enters an institution of higher  
23 education in Washington within three years of the date of separation;

24 ~~((m))~~ (n) A student who is on terminal, transition, or  
25 separation leave pending separation, or release from active duty,  
26 from the uniformed services with any period of honorable service  
27 after at least ninety days of active duty service and is eligible for  
28 educational assistance benefits under Title 38 U.S.C.;

29 (o) A student who is entitled to veterans administration  
30 educational assistance benefits based on the student's relationship  
31 as a spouse, former spouse, or child to an individual who has  
32 separated from the uniformed services with any period of honorable  
33 service after at least ninety days of active duty service, and who  
34 enters an institution of higher education in Washington within three  
35 years of the service member's date of separation;

36 ~~((n))~~ (p) A student who is the spouse or child to an individual  
37 who has separated from the uniformed services with at least ten years  
38 of honorable service and at least ninety days of active duty service,  
39 and who enters an institution of higher education in Washington  
40 within three years of the service member's date of separation;

1 (q) A student who has separated from the uniformed services who  
2 was discharged due to the student's sexual orientation or gender  
3 identity or expression;

4 (r) A student who is entitled to veterans administration  
5 educational assistance benefits based on the student's relationship  
6 with a deceased member of the uniformed services who died in the line  
7 of duty;

8 ~~((+o))~~ (s) A student who is entitled to federal vocational  
9 rehabilitation and employment services for veterans with service-  
10 connected disabilities under 38 U.S.C. Sec. 3102(a);

11 ~~((+p))~~ (t) A student who is defined as a covered individual in  
12 38 U.S.C. Sec. 3679(c)(2) as it existed on July 28, 2019, or such  
13 subsequent date as the student achievement council may determine by  
14 rule;

15 ~~((+q))~~ (u) A student of an out-of-state institution of higher  
16 education who is attending a Washington state institution of higher  
17 education pursuant to a home tuition agreement as described in RCW  
18 28B.15.725;

19 ~~((+r))~~ (v) A student who meets the requirements of RCW  
20 28B.15.0131 or 28B.15.0139: PROVIDED, That a nonresident student  
21 enrolled for more than six hours per semester or quarter shall be  
22 considered as attending for primarily educational purposes, and for  
23 tuition and fee paying purposes only such period of enrollment shall  
24 not be counted toward the establishment of a bona fide domicile of  
25 one year in this state unless such student proves that the student  
26 has in fact established a bona fide domicile in this state primarily  
27 for purposes other than educational;

29 military duty stationed in the Oregon counties of Columbia, Gilliam,  
30 Hood River, Multnomah, Clatsop, Clackamas, Morrow, Sherman, Umatilla,  
31 Union, Wallowa, Wasco, or Washington; or

32 ~~((+t))~~ (x) A student who resides in Washington and is the spouse  
33 or a dependent of a person (~~who resides in Washington and is on~~  
34 active military duty stationed in the Oregon counties of Columbia,

2 so long as the student resides in Washington and is either:

3 (i) Admitted to an institution before the reassignment and  
4 enrolls in that institution for the term the student was admitted; or

5 (ii) Enrolled in an institution and ((is)) remains continuously  
6 enrolled ((in a degree program)) at the institution.

7 (3) (a) A student who qualifies under subsection (2) ~~((j), (l),~~  
8 ~~(m), (n), (o), or (p))~~ (k), (m), (n), (o), (p), (q), (r), (s), or  
9 (t) of this section and who remains continuously enrolled at an  
10 institution of higher education shall retain resident student status.

11 (b) Nothing in subsection (2) ~~((j), (l), (m), (n), (o), or (p))~~  
12 (k), (m), (n), (o), (p), (q), (r), (s), or (t) of this section  
13 applies to students who have a dishonorable discharge from the  
14 uniformed services, or to students who are the spouse or child of an  
15 individual who has had a dishonorable discharge from the uniformed  
16 services, unless the student is receiving veterans administration  
17 educational assistance benefits.

18 (4) The term "nonresident student" shall mean any student who  
19 does not qualify as a "resident student" under the provisions of this  
20 section and RCW 28B.15.013. Except for students qualifying under  
21 subsection (2) (e) or ~~((q))~~ (u) of this section, a nonresident  
22 student shall include:

23 (a) A student attending an institution with the aid of financial  
24 assistance provided by another state or governmental unit or agency  
25 thereof, such nonresidency continuing for one year after the  
26 completion of such semester or quarter. This condition shall not  
27 apply to students from Columbia, Multnomah, Clatsop, Clackamas, or  
28 Washington county, Oregon participating in the border county pilot  
29 project under RCW 28B.76.685, 28B.76.690, and 28B.15.0139.

30 (b) A person who is not a citizen of the United States of  
31 America, unless the person meets and complies with all applicable  
32 requirements in this section and RCW 28B.15.013 and is one of the  
33 following:

34 (i) A lawful permanent resident;

35 (ii) A temporary resident;

36 (iii) A person who holds "refugee-parolee," "conditional  
37 entrant," or U or T nonimmigrant status with the United States  
38 citizenship and immigration services;

39 (iv) A person who has been issued an employment authorization  
40 document by the United States citizenship and immigration services

1 that is valid as of the date the person's residency status is  
2 determined;

3 (v) A person who has been granted deferred action for childhood  
4 arrival status before, on, or after June 7, 2018, regardless of  
5 whether the person is no longer or will no longer be granted deferred  
6 action for childhood arrival status due to the termination,  
7 suspension, or modification of the deferred action for childhood  
8 arrival program; or

9 (vi) A person who is otherwise permanently residing in the United  
10 States under color of law, including deferred action status.

11 (5) The term "domicile" shall denote a person's true, fixed and  
12 permanent home and place of habitation. It is the place where the  
13 student intends to remain, and to which the student expects to return  
14 when the student leaves without intending to establish a new domicile  
15 elsewhere. The burden of proof that a student, parent or guardian has  
16 established a domicile in the state of Washington primarily for  
17 purposes other than educational lies with the student.

18 (6) The term "dependent" shall mean a person who is not  
19 financially independent. Factors to be considered in determining  
20 whether a person is financially independent shall be set forth in  
21 rules adopted by the student achievement council and shall include,  
22 but not be limited to, the state and federal income tax returns of  
23 the person and/or the student's parents or legal guardian filed for  
24 the calendar year prior to the year in which application is made and  
25 such other evidence as the council may require.

26 (7) The term "active military duty" means the person is serving  
27 on active duty in:

28 (a) The armed forces of the United States government; or

29 (b) The Washington national guard; or

30 (c) The coast guard, merchant mariners, or other nonmilitary  
31 organization when such service is recognized by the United States  
32 government as equivalent to service in the armed forces.

33 (8) The term "active duty service" means full-time duty, other  
34 than active duty for training, as a member of the uniformed services  
35 of the United States. Active duty service as a national guard member  
36 under Title 32 U.S.C. for the purpose of organizing, administering,  
37 recruiting, instructing, or training and active service under 32  
38 U.S.C. Sec. 502(f) for the purpose of responding to a national  
39 emergency is recognized as active duty service.

1 (9) The term "uniformed services" is defined by Title 10 U.S.C.;  
2 subsequently structured and organized by Titles 14, 33, and 42  
3 U.S.C.; consisting of the United States army, United States marine  
4 corps, United States navy, United States air force, United States  
5 coast guard, United States public health service commissioned corps,  
6 and the national oceanic and atmospheric administration commissioned  
7 officer corps."

8 On page 1, line 2 of the title, after "residency;" strike the  
9 remainder of the title and insert "and amending RCW 28B.15.012."

EFFECT: Merges the contents of Substitute House Bill 2185 into Substitute House Bill 2543, which does the following:

(1) Modifies the definition of in-state resident to include spouses and dependents of active duty military stationed in the state and who are accepted to a higher education institution before the military member is reassigned out-of-state, as long as the spouse or dependent enrolls for the term in which they were admitted;

(2) Allows residency to be decided at the time of acceptance for spouses and dependents of active duty military residing in Washington, but stationed in an Oregon border county, if the military member is reassigned out of the Oregon border county after acceptance; and

(3) Restructures the residency statute for students who are active duty military and National Guard members and their spouses and dependents.

(4) Establishes that a student who has separated from the uniformed services who was discharged due to their sexual orientation or gender identity may qualify for residency for the purposes of tuition.
