In recognition of 8 the merits of the United States District Court for the Eastern 9 District of Pennsylvania's ruling in Anderson v. Franklin Institute, 10 185 F. Supp. 3d 628 (E.D. Pa. 2016), the legislature intends to 11 12 provide individuals with disabilities who use a personal caregiver or 13 personal care attendant with full and equal access to places of public resort, accommodation, assemblage, or amusement. 14
- 15 **Sec. 2.** RCW 49.60.040 and 2018 c 176 s 2 are each amended to 16 read as follows:
 - The definitions in this section apply throughout this chapter unless the context clearly requires otherwise.
 - (1) "Aggrieved person" means any person who: (a) Claims to have been injured by an unfair practice in a real estate transaction; or (b) believes that he or she will be injured by an unfair practice in a real estate transaction that is about to occur.
 - (2) "Any place of public resort, accommodation, assemblage, or amusement" includes, but is not limited to, any place, licensed or unlicensed, kept for gain, hire, or reward, or where charges are made for admission, service, occupancy, or use of any property or facilities, whether conducted for the entertainment, housing, or lodging of transient guests, or for the benefit, use, or accommodation of those seeking health, recreation, or rest, or for the burial or other disposition of human remains, or for the sale of goods, merchandise, services, or personal property, or for the

1 (((24))) (26) "Service animal" means any dog or miniature horse, as discussed in RCW 49.60.214, that is individually trained to do 2 3 work or perform tasks for the benefit of an individual with a disability, including a physical, sensory, psychiatric, intellectual, 4 or other mental disability. The work or tasks performed by the 5 6 service animal must be directly related to the individual's disability. Examples of work or tasks include, but are not limited 7 to, assisting individuals who are blind or have low vision with 8 navigation and other tasks, alerting individuals who are deaf or hard 9 of hearing to the presence of people or sounds, providing nonviolent 10 protection or rescue work, pulling a wheelchair, assisting 11 12 individual during a seizure, alerting individuals to the presence of allergens, retrieving items such as medicine or the telephone, 13 providing physical support and assistance with balance and stability 14 to individuals with mobility disabilities, and helping persons with 15 16 psychiatric and neurological disabilities by preventing or 17 interrupting impulsive or destructive behaviors. The crime deterrent effects of an animal's presence and the provision of emotional 18 support, well-being, comfort, or companionship do not constitute work 19 or tasks. This subsection does not apply to RCW 49.60.222 through 20 49.60.227 with respect to housing accommodations or real estate 21 22 transactions.

 $((\frac{(26)}{(26)}))$ "Sexual orientation" means heterosexuality, homosexuality, bisexuality, and gender expression or identity. As used in this definition, "gender expression or identity" means having or being perceived as having a gender identity, self-image, appearance, behavior, or expression, whether or not that gender identity, self-image, appearance, behavior, or expression is different from that traditionally associated with the sex assigned to that person at birth.

Sec. 3. RCW 49.60.215 and 2018 c 176 s 3 are each amended to read as follows:

(1) It shall be an unfair practice for any person or the person's agent or employee to commit an act which directly or indirectly results in any distinction, restriction, or discrimination, or the requiring of any person to pay a larger sum than the uniform rates charged other persons, or the refusing or withholding from any person the admission, patronage, custom, presence, frequenting, dwelling,

- staying, or lodging in any place of public resort, accommodation, assemblage, or amusement, except for conditions and limitations established by law and applicable to all persons, regardless of race, creed, color, national origin, sexual orientation, sex, honorably discharged veteran or military status, status as a mother breastfeeding her child, the presence of any sensory, mental, or physical disability, or the use of a trained dog guide or service animal by a person with a disability: PROVIDED, That this section shall not be construed to require structural changes, modifications, or additions to make any place accessible to a person with a disability except as otherwise required by law: PROVIDED, behavior or actions constituting a risk to property or other persons can be grounds for refusal and shall not constitute an unfair practice.
 - (2) (a) Subject to the requirements of (b) of this subsection, it is an unfair practice for a place of public resort, accommodation, assemblage, or amusement that charges for admission, to deny complimentary admission for one caregiver accompanying a person with a disability who pays admission. If the place of public resort, accommodation, assemblage, or amusement provides seating to people who pay admission, the caregiver shall be provided one accompanying seat, removable adjacent chair, or a space to stand in reasonable proximity to the patron with a disability which may or may not have a view of the event and may or may not have an associated ticket.

- (b) The caregiver must supply essential help for basic activities of daily living as defined in RCW 49.60.040. The caregiver or the person with a disability must affirmatively make the request for complimentary admission and assert that the companion is a caregiver that performs essential help for basic activities of daily living in order to qualify for this protection.
- (c) When it is not obvious what service a caregiver provides, only limited inquiries are allowed. Staff may ask two questions: (i) Is the caregiver required because of a disability? and (ii) what essential help for basic activities of daily living does the caregiver provide? Staff cannot ask about the person's disability, require medical documentation, require a special identification card or training documentation, or ask that the caregiver demonstrate the ability to perform the work or task.
