State operating expenses are paid from the state general fund and from various dedicated funds and accounts.

Summary of Bill (Proposed Substitute): Biennial appropriations for the 2019-21 fiscal biennium for the various agencies and programs of the state are enacted, including appropriations for general government agencies, human services programs, natural resources agencies, and education institutions.
