1 AN ACT Relating to creating sales and use tax exemptions for  
2 firearms; adding a new section to chapter 82.08 RCW; adding a new  
3 section to chapter 82.12 RCW; and creating a new section.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** A new section is added to chapter 82.08  
6 RCW to read as follows:

7 (1) The tax levied by RCW 82.08.020 does not apply to sales of  
8 the following specifically identified firearms, or to sales of any  
9 other firearm that is permitted to be possessed under federal law:
