## LIMITING ANNUAL MOTOR VEHICLE LICENSE FEES TO \$30

- 9 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 46.17 10 RCW to read as follows:
- 11 (1) State and local motor vehicle license fees may not exceed \$30 12 per year for motor vehicles, regardless of year, value, make, or model.
  - (2) For the purposes of this section, "state and local motor vehicle license fees" means the general license tab fees paid annually for licensing motor vehicles, including but not limited to cars, sport utility vehicles, light trucks under RCW 46.17.355, motorcycles, and motor homes, and do not include charges approved by voters after the effective date of this section. - NEW SECTION. Sec. 8. SHORT TITLE. This act may be known and cited as the bring back our \$30 car tabs act.
- NEW SECTION. Sec. 9. This act is necessary for the immediate preservation of the public peace, health, or safety, or support of the state government and its existing public institutions, and takes effect immediately.
