## SENATE BILL 5407

State of Washington 67th Legislature 2021 Regular Session

- AN ACT Relating to firearm theft; amending RCW 9.94A.515; adding
- 2  $\,$  a new section to chapter 9A.56 RCW; and prescribing penalties.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 9A.56 5 RCW to read as follows:
- (1) A person is guilty of theft of a firearm from a residence, store, shop, sales outlet, or vehicle if he or she commits a theft of any firearm from a residence, store, shop, or sales outlet where firearms are sold, or from any vehicle.
- 10 (2) This section applies regardless of the value of the firearm 11 taken in the theft.
- 12 (3) Each firearm taken in the theft under this section is a 13 separate offense.
- 14 (4)(a) For the purposes of this section, "theft" has the same 15 meaning as defined in RCW 9A.56.020.
- 16 (b) The defense allowed against the prosecution for theft under 17 RCW 9A.56.020 shall apply to the crime of theft of a firearm.
  - (5) For the purposes of this section:
