5 (1) ~~(a)~~ A person commits the crime of stalking if, without lawful  
6 authority ~~((and under circumstances not amounting to a felony attempt~~  
7 ~~of another crime:~~

8 ~~(a) He or she intentionally))~~ the person:

9 (i) Intentionally and repeatedly harasses ((or repeatedly  
10 follows)) another person;

11 (ii) Intentionally and repeatedly follows another person;

12 (iii) Intentionally contacts, follows, tracks, or monitors, or  
13 attempts to contact, follow, track, or monitor another person after  
14 being given actual notice that the person does not want to be  
15 contacted, followed, tracked, or monitored; or

16 (iv) Knowingly and without consent installs or monitors an  
17 electronic tracking device, or causes an electronic tracking device  
18 to be installed, placed, or used, to track the location of another  
19 person; and

20 (b) The person being harassed ~~((or)),~~ followed, tracked, or  
21 monitored suffers substantial emotional distress or is placed in fear  
22 that the stalker intends to injure ((the person)) him or her, or  
23 another person, or his or her property ((of the person)) or the  
24 property of another person, or, in the circumstances identified in  
25 (a)(iv) of this subsection, the victim's knowledge of the tracking  
26 device would reasonably elicit substantial emotional distress or  
27 fear. The feeling of substantial emotional distress or fear must be  
28 one that a reasonable person in the same situation would experience  
29 ((under all)) given the totality of the circumstances(;; and

31 ~~(i) Intends to frighten, intimidate, or harass the person; or~~

1 ~~(ii) Knows or reasonably should know that the person is afraid,~~  
2 ~~intimidated, or harassed even if the stalker did not intend to place~~  
3 ~~the person in fear or intimidate or harass the person)).~~

4 (2) (a) It is not a defense to the crime of stalking under  
5 subsection (1) ~~((e)-(i))~~ (a) (i), (ii), or (iv) of this section that  
6 the stalker was not given actual notice that the person did not want  
7 the stalker to contact ~~((or)),~~ follow ((the person)), track, or  
8 monitor him or her; and

9 (b) It is not a defense to the crime of stalking under subsection  
10 (1) ~~((e)-(ii))~~ (a) (i) of this section that the stalker did not intend  
11 to frighten ~~((r))~~ or intimidate ~~((r or harass))~~ the person or place the  
12 person in substantial emotional distress.

13 (3) It shall be a defense to the crime of stalking that the  
14 defendant is a licensed private investigator acting within the  
15 capacity of his or her license as provided by chapter 18.165 RCW.

16 (4) ~~((Attempts to contact or follow the person after being given~~  
17 ~~actual notice that the person does not want to be contacted or~~  
18 ~~followed constitutes prima facie evidence that the stalker intends to~~  
19 ~~intimidate or harass the person. "Contact" includes, in addition to~~  
20 ~~any other form of contact or communication, the sending of an~~  
21 ~~electronic communication to the person.))~~ The provisions of this  
22 section do not apply to the installation, placement, or use of an  
23 electronic tracking device by any of the following:

24 (a) A law enforcement officer, judicial officer, probation or  
25 parole officer, or other public employee when any such person is  
26 engaged in the lawful performance of official duties and in  
27 accordance with state or federal law;

28 (b) The installation, placement, or use of an electronic tracking  
29 device authorized by an order of a state or federal court;

30 (c) A legal guardian for a disabled adult or a legally authorized  
31 individual or organization designated to provide protective services  
32 to a disabled adult when the electronic tracking device is installed,  
33 placed, or used to track the location of the disabled adult for which  
34 the person is a legal guardian or the individual or organization is  
35 designated to provide protective services;

36 (d) A parent or legal guardian of a minor when the electronic  
37 tracking device is installed, placed, or used to track the location  
38 of that minor unless the parent or legal guardian is subject to a  
39 court order that orders the parent or legal guardian not to assault,  
40 threaten, harass, follow, or contact that minor;

1 (e) An employer, school, or other organization, who owns the  
2 device on which the tracking device is installed and provides the  
3 device to a person for use in connection with the person's  
4 involvement with the employer, school, or other organization and the  
5 use of the device is limited to recovering lost or stolen items; or

6 (f) The owner of fleet vehicles, when tracking such vehicles. For  
7 the purposes of this section, "fleet vehicle" means any of the  
8 following:

9 (i) One or more motor vehicles owned by a single entity and  
10 operated by employees or agents of the entity for business or  
11 government purposes;

12 (ii) Motor vehicles held for lease or rental to the general  
13 public; or

14 (iii) Motor vehicles held for sale, or used as demonstrators,  
15 test vehicles, or loaner vehicles, by motor vehicle dealers.

16 (5) (a) Except as provided in (b) of this subsection, a person who  
17 stalks another person is guilty of a gross misdemeanor.

18 (b) A person who stalks another person is guilty of a class B  
19 felony if any of the following applies:

20 (i) The stalker has previously been convicted in this state or  
21 any other state of any crime of harassment, as defined in RCW  
22 9A.46.060 (~~(, of the same victim or members of the victim's family or~~  
23 ~~household or any person specifically named in a protective order));~~

24 (ii) ~~((the))~~ The stalking violates any protective order  
25 protecting the ~~((person being stalked))~~ victim;

26 (iii) ~~((the))~~ The stalker has previously been convicted of a  
27 gross misdemeanor or felony stalking offense under this section for  
28 stalking another person;

29 (iv) ~~((the))~~ The stalker was armed with a deadly weapon, as  
30 defined in RCW 9.94A.825, while stalking the ~~((person))~~ victim;

31 (v) (A) ~~((the stalker's))~~ The victim is or was a law enforcement  
32 officer; judge; juror; attorney; victim advocate; legislator;  
33 community corrections' officer; an employee, contract staff person,  
34 or volunteer of a correctional agency; court employee, court clerk,  
35 or courthouse facilitator; or an employee of the child protective,  
36 child welfare, or adult protective services division within the  
37 department of social and health services; and

38 (B) ~~((the))~~ The stalker stalked the victim to retaliate against  
39 the victim for an act the victim performed during the course of

1 official duties or to influence the victim's performance of official  
2 duties; or

3 (vi) (~~the stalker's~~) The victim is a current, former, or  
4 prospective witness in an adjudicative proceeding, and the stalker  
5 stalked the victim to retaliate against the victim as a result of the  
6 victim's testimony or potential testimony.

7 (6) As used in this section:

8 (a) "Actual notice" includes, in addition to any other form of  
9 actual notice, circumstances in which the other person has a  
10 protective order in effect protecting him or her from the person.

11 (b) "Contact" includes, in addition to any other form of contact  
12 or communication, the sending of an electronic communication to the  
13 other person.

14 (c) "Correctional agency" means a person working for the  
15 department of natural resources in a correctional setting or any  
16 state, county, or municipally operated agency with the authority to  
17 direct the release of a person serving a sentence or term of  
18 confinement and includes but is not limited to the department of  
19 corrections, the indeterminate sentence review board, and the  
20 department of social and health services.

21 (~~(b)~~) (d) "Course of conduct" means a pattern of conduct  
22 composed of a series of acts over a period of time, however short,  
23 evidencing a continuity of purpose. "Course of conduct" includes, in  
24 addition to any other form of communication, contact, or conduct, the  
25 sending of an electronic communication, but does not include  
26 constitutionally protected free speech. Constitutionally protected  
27 activity is not included within the meaning of "course of conduct."

28 (~~(e)~~) (e) "Electronic tracking device" means an electronic  
29 device that permits a person to remotely determine or monitor the  
30 position and movement of another person, vehicle, device, or other  
31 personal possession. As used in this subsection (6)(e), "electronic  
32 device" includes computer code or other digital instructions that  
33 once installed on a digital device, allows a person to remotely track  
34 the position of that device.

35 (f) "Follows" means deliberately maintaining visual or physical  
36 proximity to a specific person over a period of time. A finding that  
37 the (~~alleged~~) stalker repeatedly and deliberately appears at the  
38 person's home, school, place of employment, business, or any other  
39 location to maintain visual or physical proximity to the person is  
40 sufficient to find that the (~~alleged~~) stalker follows the person.

1 It is not necessary to establish that the (~~alleged~~) stalker follows  
2 the person while in transit from one location to another.

3 (~~(d)~~) (g) "Harasses" means a knowing and willful course of  
4 conduct directed at a specific person which seriously alarms, annoys,  
5 (~~harasses~~) torments, or is detrimental to such person, and which  
6 serves no legitimate or lawful purpose. (~~The course of conduct shall~~  
7 ~~be such as would cause a reasonable person to suffer substantial~~  
8 ~~emotional distress, and shall actually cause substantial emotional~~  
9 ~~distress to the petitioner, or when the course of conduct would cause~~  
10 ~~a reasonable parent to fear for the well-being of his or her child.~~

11 ~~(e)~~) (h) "Protective order" means any temporary or permanent  
12 court order prohibiting or limiting violence against, harassment of,  
13 contact or communication with, or physical proximity to another  
14 person.

15 (~~(f)~~) (i) "Repeatedly" means on two or more separate occasions.

16 (j) "Substantial emotional distress" means a mental, emotional,  
17 or physical reaction such as anxiety, apprehension, or loss of  
18 ability to concentrate or other symptoms, whether or not medical or  
19 other professional treatment or counseling is sought or required,  
20 which degrades the victim's quality of life.
