- "NEW SECTION. Sec. 1. The legislature finds and declares that 3 2022 was the deadliest year on Washington roads 4 since Washington state saw 698 fatal crashes resulting in the death of more 5 than 740 people. Half of all serious and fatal crashes are caused by 6 7 driver impairment from drugs and alcohol, and the state saw a 31.3 percent increase in crashes as the result of an impaired driver 8 between 2019 and 2022. This alarming upward trend must be addressed 9 if Washington state is going to meet its goal of target zero. The 10 increase in Washingtonians choosing to drive while impaired points to 11 12 a need to adjust Washington's impaired driving laws. Utah lowered the 13 blood alcohol concentration limit for operating a motor vehicle from .08 to .05 in 2019 and found that its fatal crash rate dropped 14 by 19.89 percent, and its fatality rate decreased by 18.3 percent. 15 Additionally, 22 percent of people who drank alcohol said they 16 17 changed their behavior as a result of the new law. The legislature 18 further finds that this is a well calibrated policy based on evidence implemented a .05 19 shows if all states blood 20 concentration level, 538 to 1,790 lives would be saved each year, and 21 alcohol-related fatalities would decrease by 11.1 percent overall. 22 Given the increase in traffic fatalities from impaired driving, the legislature declares that it is time to keep Washington's roads safer 23 24 and lower the number of fatal crashes caused by impaired drivers by 25 lowering the blood alcohol limit to .05.

  - (a) Order the use of an ignition interlock or other device for an additional ((twelve)) 12 months for each passenger under the age of ((sixteen)) 16 when the person is subject to the penalties under subsection (1)(a), (2)(a), or (3)(a) of this section; and order the use of an ignition interlock device for an additional ((eighteen)) 18 months for each passenger under the age of ((sixteen)) 16 when the person is subject to the penalties under subsection (1)(b), (2)(b), (3)(b), or (4) of this section;
- (b) In any case in which the person has no prior offenses within seven years, and except as provided in RCW 46.61.502(6) or 46.61.504(6), order an additional ((twenty-four)) 24 hours of imprisonment to be served consecutively for each passenger under the age of ((sixteen)) 16, and a fine of not less than ((one thousand dollars)) \$1,000 and not more than ((five thousand dollars)) \$5,000 for each passenger under the age of ((sixteen)) 16. ((One thousand dollars)) \$1,000 of the fine for each passenger under the age of ((sixteen)) 16 may not be suspended unless the court finds the offender to be indigent;
- (c) In any case in which the person has one prior offense within seven years, and except as provided in RCW 46.61.502(6) or 46.61.504(6), order an additional five days of imprisonment to be served consecutively for each passenger under the age of ((sixteen)) 16, and a fine of not less than ((two thousand dollars)) 22,000 and not more than ((tive thousand dollars)) 55,000 for each passenger under the age of ((sixteen)) 16. One thousand dollars of the fine for each passenger under the age of ((sixteen)) 16 may not be suspended unless the court finds the offender to be indigent;
- (d) In any case in which the person has two prior offenses within seven years, and except as provided in RCW 46.61.502(6) or 46.61.504(6), order an additional ten days of imprisonment to be served consecutively for each passenger under the age of ((sixteen)) 16, and a fine of not less than ((three thousand dollars)) \$3,000 and Code Rev/AI:jlb 12 S-4427.2/24 2nd draft

  - (A) Where there has been no prior offense within seven years, be revoked or denied by the department for one year or until the person is evaluated by a substance use disorder agency or probation department pursuant to RCW 46.20.311 and the person completes or is enrolled in a one hundred twenty day period of 24/7 sobriety program monitoring. In no circumstances shall the license revocation be for fewer than four days;
  - (B) Where there has been one prior offense within seven years, be revoked or denied by the department for ((nine hundred)) 900 days; or
  - (C) Where there have been two or more prior offenses within seven years, be revoked or denied by the department for four years; or
  - (iii) **Penalty for refusing to take test.** If by reason of the person's refusal to take a test offered under RCW 46.20.308, there is no test result indicating the person's alcohol concentration:
  - (A) Where there have been no prior offenses within seven years, be revoked or denied by the department for two years;
  - (B) Where there has been one prior offense within seven years, be revoked or denied by the department for three years; or
  - (C) Where there have been two or more previous offenses within seven years, be revoked or denied by the department for four years.
  - (b)(i) The department shall grant credit on a day-for-day basis for a suspension, revocation, or denial imposed under this subsection (9) for any portion of a suspension, revocation, or denial already served under RCW 46.20.3101 arising out of the same incident.

- (b) For purposes of this section, "prima facie evidence" is evidence of sufficient circumstances that would support a logical and reasonable inference of the facts sought to be proved. In assessing whether there is sufficient evidence of the foundational facts, the court or administrative tribunal is to assume the truth of the prosecution's or department's evidence and all reasonable inferences from it in a light most favorable to the prosecution or department.
- (c) Nothing in this section shall be deemed to prevent the subject of the test from challenging the reliability or accuracy of the test, the reliability or functioning of the instrument, or any maintenance procedures. Such challenges, however, shall not preclude the admissibility of the test once the prosecution or department has made a prima facie showing of the requirements contained in (a) of this subsection. Instead, such challenges may be considered by the trier of fact in determining what weight to give to the test result.

  - (5) The test or tests of breath must be administered pursuant to RCW 46.20.308. The officer shall warn the person that if the person refuses to take the test, the person will be issued a class 1 civil infraction under RCW 7.80.120.
- 22 (6) A violation of subsection (1) of this section is a 23 misdemeanor. A violation of subsection (2) of this section is a gross 24 misdemeanor. In addition to the statutory penalties imposed, the 25 court may order the defendant to pay restitution for any damages or 26 injuries resulting from the offense.
- 27 (7) For the purposes of this subsection, "cannabis" has the 28 meaning provided in RCW 69.50.101.
- NEW SECTION. Sec. 11. A new section is added to chapter 43.59 RCW to read as follows:
- 31 The Washington traffic safety commission shall develop and 32 implement a public information campaign related to this act. In 33 developing and implementing the public information campaign, the 34 commission must:
- 35 (1) Ensure television, radio, and online advertisements are 36 provided in all areas of the state;
- 37 (2) Include multiple print advertisements in the largest 38 newspapers in each county;

- 1 (3) Provide content of the public information campaign in the top 2 nine most significant non-English-speaking languages spoken in the 3 state;
- 4 (4) Consider equity outcomes on overburdened communities as defined in RCW 70A.02.010; and
- (5) Ensure that at least 10 percent of the advertisements are developed in conjunction with in-state hospitality stakeholders and educate drivers about safe alternatives to driving while patronizing hospitality businesses.
- NEW SECTION. Sec. 12. A new section is added to chapter 66.44
  RCW to read as follows:

The legislature finds that current civil law relating to civil 12 liability is that a licensed commercial vendor or quasi-commercial 13 vendor owes a duty to third persons not to sell, serve, or furnish 14 15 alcohol to a person who is apparently under the influence of alcohol, 16 or who is obviously intoxicated. This current civil law is both 17 statutory and also developed in case law. The legislature further finds that civil liability to third persons under the civil law does 18 not depend upon a finding of the blood or breath alcohol 19 concentration. Therefore, nothing in this act shall be construed to 20 21 change current civil law for civil liability of a licensed commercial 22 vendor or quasi-commercial vendor.

- NEW SECTION. Sec. 13. A new section is added to chapter 66.08 RCW to read as follows:
- 25 (1) The Washington state institute for public policy must conduct 26 an evaluation of the impacts of this act during the first two years 27 of implementation. By March 1, 2027, the institute must submit a 28 report to the appropriate committees of the legislature detailing the 29 results of its evaluation. The evaluation must include, but is not 30 limited to, the impact of this act on:
  - (a) The number of serious and fatal traffic accidents;
- 32 (b) Driving under the influence arrests and adjudications for driving under the influence offenses;
- 34 (c) Equity outcomes on overburdened communities as defined in RCW 35 70A.02.010;
- 36 (d) Sales and other business effects on the hospitality industry 37 in the state; and

- 1 (e) Sales and other business effects on breweries, wineries, and 2 distilleries in the state.
- 3 (2) This section expires November 1, 2027.
- 4 <u>NEW SECTION.</u> **Sec. 14.** This act takes effect January 1, 2025."

# <u>2SSB 5002</u> - S AMD **501** By Senator Lovick

On page 1, line 1 of the title, after "concentration;" strike the remainder of the title and "amending RCW 46.61.502, 46.61.504, 46.61.5055, 46.61.506, 46.20.308, 46.20.3101, 46.25.090, 38.38.760, and 79A.60.040; adding a new section to chapter 43.59 RCW; adding a new section to chapter 66.44 RCW; adding a new section to chapter 66.08 RCW; creating a new section; prescribing penalties; providing an effective date; and providing an expiration date."

- $\underline{\text{EFFECT:}}$  (1) Disqualifies a person from driving a commercial motor vehicle for one year if the person has been convicted of a first violation of driving a noncommercial motor vehicle with a blood alcohol level of 0.05 or higher.
- (2) Requires a person subject to the Washington code of military justice, who commits a DUI offense with a blood alcohol level of 0.05 or higher, to be punished as a court-martial may direct.
- (3) Reduces the blood alcohol limit for the crime of operating a recreational vessel while under the influence to 0.05.
- (4) Changes the effective date from July 1, 2024, to January 1, 2025.
- (5) Adjusts the submission date for the Washington state institute for public policy evaluation of the impacts of the act from October 1, 2026, to March 1, 2027.
- (6) Modifies legislative intent section with more recent figures on traffic fatalities.
