AN ACT Relating to the sale or lease of manufactured/mobile home communities and the property on which they sit; amending RCW 59.20.060, 59.20.073, 59.20.080, 59.20.300, 59.20.305, and 59.21.030; reenacting and amending RCW 59.20.030; adding new sections to chapter 59.20 RCW; creating a new section; and prescribing penalties.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 NEW SECTION. Sec. 1. (1) The legislature finds that:

- (a) Manufactured/mobile homes provide a significant source of homeownership opportunities for Washington state residents. However, the increasing number of closures and conversions to other uses of manufactured housing communities and mobile home parks, combined with low vacancy rates in existing parks and communities and the extremely high cost of moving homes when these parks and communities close, make this type of affordable housing option increasingly insecure for the tenants who reside in these parks and communities.
- (b) Many tenants who reside in these parks and communities are senior citizens or low-income households and are, therefore, the residents most in need of reasonable security or permanency in the siting of their home because of the adverse impacts on the health, safety, and welfare of tenants forced to move due to closure or

conversion to another use of the manufactured housing community or mobile home park.

- (2) It is the intent of the legislature to encourage and facilitate the preservation of existing manufactured/mobile home communities in the event of voluntary sales of the manufactured/mobile home communities and, to the extent necessary and possible, involve manufactured/mobile home community tenants or an eligible organization, such as a nonprofit organization, housing authority, community land trust, resident nonprofit cooperative, or local government, in the preservation of manufactured/mobile home communities.
- (3) The legislature further finds that when the sale of a manufactured/mobile home park to the community tenants or an eligible organization is not possible, a minimum notification period of three years before the closure or conversion of a community or park is a reasonable balancing of the rights and interests of both community and park owners and the manufactured/mobile home owners, unless the owners justly compensate the homeowners for the loss of their homes.
- Sec. 2. RCW 59.20.030 and 2019 c 342 s 1 and 2019 c 23 s 4 are each reenacted and amended to read as follows:

For purposes of this chapter:

- (1) "Abandoned" as it relates to a mobile home, manufactured home, or park model owned by a tenant in a mobile home park, mobile home park cooperative, or mobile home park subdivision or tenancy in a mobile home lot means the tenant has defaulted in rent and by absence and by words or actions reasonably indicates the intention not to continue tenancy;
- (2) "Active duty" means service authorized by the president of the United States, the secretary of defense, or the governor for a period of more than thirty consecutive days;
- (3) "Eligible organization" includes <u>community land trusts</u>, <u>resident nonprofit cooperatives</u>, local governments, local housing authorities, nonprofit community or neighborhood-based organizations, federally recognized Indian tribes in the state of Washington, and regional or statewide nonprofit housing assistance organizations;
- (4) "Housing and low-income assistance organization" means an organization that provides tenants living in mobile home parks, manufactured housing communities, and manufactured/mobile home

- 1 communities with information about their rights and other pertinent 2 information;
 - (5) "Housing authority" or "authority" means any of the public body corporate and politic created in RCW 35.82.030;

- (6) "Landlord" means the owner of a mobile home park and includes the agents of a landlord;
- (7) "Local government" means a town government, city government, code city government, or county government in the state of Washington;
- (8) "Manufactured home" means a single-family dwelling built according to the United States department of housing and urban development manufactured home construction and safety standards act, which is a national preemptive building code. A manufactured home also: (a) Includes plumbing, heating, air conditioning, and electrical systems; (b) is built on a permanent chassis; and (c) can be transported in one or more sections with each section at least eight feet wide and ((forty)) 40 feet long when transported, or when installed on the site is three hundred twenty square feet or greater;
- (9) "Manufactured/mobile home" means either a manufactured home or a mobile home;
- (10) "Mobile home" means a factory-built dwelling built prior to June 15, 1976, to standards other than the United States department of housing and urban development code, and acceptable under applicable state codes in effect at the time of construction or introduction of the home into the state. Mobile homes have not been built since the introduction of the United States department of housing and urban development manufactured home construction and safety act;
- (11) "Mobile home lot" means a portion of a mobile home park or manufactured housing community designated as the location of one mobile home, manufactured home, or park model and its accessory buildings, and intended for the exclusive use as a primary residence by the occupants of that mobile home, manufactured home, or park model;
- (12) "Mobile home park cooperative" or "manufactured housing cooperative" means real property consisting of common areas and two or more lots held out for placement of mobile homes, manufactured homes, or park models in which both the individual lots and the common areas are owned by an association of shareholders which leases

or otherwise extends the right to occupy individual lots to its own members;

- (13) "Mobile home park subdivision" or "manufactured housing subdivision" means real property, whether it is called a subdivision, condominium, or planned unit development, consisting of common areas and two or more lots held for placement of mobile homes, manufactured homes, or park models in which there is private ownership of the individual lots and common, undivided ownership of the common areas by owners of the individual lots;
- (14) "Mobile home park," "manufactured housing community," or "manufactured/mobile home community" means any real property which is rented or held out for rent to others for the placement of two or more mobile homes, manufactured homes, or park models for the primary purpose of production of income, except where such real property is rented or held out for rent for seasonal recreational purpose only and is not intended for year-round occupancy;
- (15) "Notice of opportunity to purchase" means a notice required under section 7 of this act;
- (16) "Notice of sale" means a notice required under RCW 59.20.300 to be delivered to all tenants of a manufactured/mobile home community and other specified parties within ((fourteen)) 14 days after the date on which any advertisement, ((multiple)) listing, or public or private notice ((advertises)) is first made advertising that a manufactured/mobile home community or the property on which it sits is for sale or lease;
- $((\frac{16}{10}))$ <u>(17)</u> "Occupant" means any person, including a live-in care provider, other than a tenant, who occupies a mobile home, manufactured home, or park model and mobile home lot;
- (((17))) (18) "Orders" means written official military orders, or any written notification, certification, or verification from the service member's commanding officer, with respect to the service member's current or future military status;
- (((18))) <u>(19)</u> "Park model" means a recreational vehicle intended for permanent or semi-permanent installation and is used as a primary residence;
- (((19))) <u>(20)</u> "Permanent change of station" means: (a) Transfer to a unit located at another port or duty station; (b) change of a unit's home port or permanent duty station; (c) call to active duty for a period not less than ((ninety)) <u>90</u> days; (d) separation; or (e) retirement;

 $((\frac{(20)}{(20)}))$ (21) "Qualified sale of manufactured/mobile home community" means the sale, as defined in RCW 82.45.010, of land and improvements comprising a manufactured/mobile home community that is transferred in a single purchase to a qualified tenant organization or to an eligible organization for the purpose of preserving the property as a manufactured/mobile home community;

- $((\frac{(21)}{(21)}))$ <u>(22)</u> "Qualified tenant organization" means a formal organization of tenants within a manufactured/mobile home community, with the only requirement for membership consisting of being a tenant;
- (((22))) <u>(23)</u> "Recreational vehicle" means a travel trailer, motor home, truck camper, or camping trailer that is primarily designed and used as temporary living quarters, is either self-propelled or mounted on or drawn by another vehicle, is transient, is not occupied as a primary residence, and is not immobilized or permanently affixed to a mobile home lot;
 - (((23))) (24) "Resident nonprofit cooperative" means a nonprofit cooperative corporation formed by a group of manufactured/mobile home community residents for the purpose of acquiring the manufactured/mobile home community in which they reside and converting the manufactured/mobile home community to a mobile home park cooperative or manufactured housing cooperative;
- 23 (25) "Service member" means an active member of the United States 24 armed forces, a member of a military reserve component, or a member 25 of the national guard who is either stationed in or a resident of 26 Washington state;
- $((\frac{(24)}{)})$ (26) "Tenant" means any person, except a transient, who 28 rents a mobile home lot;
- $((\frac{(25)}{(25)}))$ <u>(27)</u> "Transient" means a person who rents a mobile home lot for a period of less than one month for purposes other than as a primary residence.
- **Sec. 3.** RCW 59.20.060 and 2022 c 95 s 4 are each amended to read 33 as follows:
- 34 (1) Any mobile home space tenancy regardless of the term, shall 35 be based upon a written rental agreement, signed by the parties, 36 which shall contain:
- 37 (a) The terms for the payment of rent, including time and place, 38 and any additional charges to be paid by the tenant. Additional

charges that occur less frequently than monthly shall be itemized in a billing to the tenant;

- (b) Reasonable rules for guest parking which shall be clearly stated;
 - (c) The rules and regulations of the park;

- (d) The name and address of the person who is the landlord, and if such person does not reside in the state there shall also be designated by name and address a person who resides in the county where the mobile home park is located who is authorized to act as agent for the purposes of service of notices and process. If no designation is made of a person to act as agent, then the person to whom rental payments are to be made shall be considered the agent;
- (e) The name and address of any party who has a secured interest in the mobile home, manufactured home, or park model;
- (f) A forwarding address of the tenant or the name and address of a person who would likely know the whereabouts of the tenant in the event of an emergency or an abandonment of the mobile home, manufactured home, or park model;
- (g)(((i) A covenant by the landlord that, except for acts or events beyond the control of the landlord, the mobile home park will not be converted to a land use that will prevent the space that is the subject of the lease from continuing to be used for its intended use for a period of three years after the beginning of the term of the rental agreement;
- (ii))) A ((rental agreement may, in the alternative, contain a)) statement that: "The park may be sold or otherwise transferred at any time with the result that subsequent owners may close the mobile home park, or that the landlord may close the park at any time after the required closure notice as provided in RCW 59.20.080." The ((covenant or)) statement required by this subsection must: ((A)) (i) Appear in print that is in boldface and is larger than the other text of the rental agreement; ((B)) (ii) be set off by means of a box, blank space, or comparable visual device; and ((C)) (iii) be located directly above the tenant's signature on the rental agreement;
- (h) A copy of a closure notice, as required in RCW 59.20.080, if such notice is in effect;
- (i) The terms and conditions under which any deposit or portion thereof may be withheld by the landlord upon termination of the rental agreement if any moneys are paid to the landlord by the tenant

- (j) A listing of the utilities, services, and facilities which will be available to the tenant during the tenancy and the nature of the fees, if any, to be charged together with a statement that, in the event any utilities are changed to be charged independent of the rent during the term of the rental agreement, the landlord agrees to decrease the amount of the rent charged proportionately;
- 9 (k) A written description, picture, plan, or map of the 10 boundaries of a mobile home space sufficient to inform the tenant of 11 the exact location of the tenant's space in relation to other 12 tenants' spaces;
- (1) A written description, picture, plan, or map of the location of the tenant's responsibility for utility hook-ups, consistent with RCW 59.20.130(6);
- 16 (m) A statement of the current zoning of the land on which the 17 mobile home park is located;
 - (n) A statement of the expiration date of any conditional use, temporary use, or other land use permit subject to a fixed expiration date that is necessary for the continued use of the land as a mobile home park; and
- 22 (o) A written statement containing accurate historical 23 information regarding the past five years' rental amount charged for 24 the lot or space.
 - (2) Any rental agreement executed between the landlord and tenant shall not contain any provision:
 - (a) Which allows the landlord to charge a fee for guest parking unless a violation of the rules for guest parking occurs: PROVIDED, That a fee may be charged for guest parking which covers an extended period of time as defined in the rental agreement;
 - (b) Which authorizes the towing or impounding of a vehicle except upon notice to the owner thereof or the tenant whose guest is the owner of the vehicle;
 - (c) Which allows the landlord to alter the due date for rent payment or increase the rent: (i) During the term of the rental agreement if the term is less than two years, or (ii) more frequently than annually if the initial term is for two years or more: PROVIDED, That a rental agreement may include an escalation clause for a pro rata share of any increase in the mobile home park's real property taxes or utility assessments or charges, over the base taxes or

utility assessments or charges of the year in which the rental 1 agreement took effect, if the clause also provides for a pro rata 2 reduction in rent or other charges in the event of a reduction in 3 real property taxes or utility assessments or charges, below the base 4 year: PROVIDED FURTHER, That a rental agreement for a term exceeding 5 6 two years may provide for annual increases in rent in specified 7 amounts or by a formula specified in such agreement. Any rent increase authorized under this subsection (2)(c) that occurs within 8 the closure notice period pursuant to RCW 59.20.080(1)(e) may not be 9 more than one percentage point above the United States consumer price 10 11 index for all urban consumers, housing component, published by the 12 United States bureau of labor statistics in the periodical "Monthly Labor Review and Handbook of Labor Statistics" as established 13 14 annually by the department of commerce;

15 (d) By which the tenant agrees to waive or forego rights or 16 remedies under this chapter;

- (e) Allowing the landlord to charge an "entrance fee" or an "exit fee." However, an entrance fee may be charged as part of a continuing care contract as defined in RCW 70.38.025;
- (f) Which allows the landlord to charge a fee for guests: PROVIDED, That a landlord may establish rules charging for guests who remain on the premises for more than ((fifteen)) 15 days in any 60-day period;
- (g) By which the tenant agrees to waive or forego homestead rights provided by chapter 6.13 RCW. This subsection shall not prohibit such waiver after a default in rent so long as such waiver is in writing signed by the husband and wife or by an unmarried claimant and in consideration of the landlord's agreement not to terminate the tenancy for a period of time specified in the waiver if the landlord would be otherwise entitled to terminate the tenancy under this chapter;
- 32 (h) By which, at the time the rental agreement is entered into, 33 the landlord and tenant agree to the selection of a particular 34 arbitrator; or
- 35 (i) By which the tenant agrees to make rent payments through 36 electronic means only.

Sec. 4. RCW 59.20.073 and 2019 c 342 s 5 are each amended to 2 read as follows:

- (1) Any rental agreement shall be assignable by the tenant to any person to whom he or she sells or transfers title to the mobile home, manufactured home, or park model.
- (2) A tenant who sells a mobile home, manufactured home, or park model within a park must provide the buyer with a copy of a closure notice provided by the landlord pursuant to RCW 59.20.080, if such notice is in effect, at least 15 days in advance of the intended sale and transfer.
- (3) A tenant who sells a mobile home, manufactured home, or park model within a park shall notify the landlord in writing of the date of the intended sale and transfer of the rental agreement at least ((fifteen)) 15 days in advance of such intended transfer and shall notify the buyer in writing of the provisions of this section. A landlord may not accept payment for rent or deposit from the buyer until the landlord has provided the buyer with these copies.
 - (((4))) <u>(5)</u> The landlord may require the mobile home, manufactured home, or park model to meet applicable fire and safety standards if a state or local agency responsible for the enforcement of fire and safety standards has issued a notice of violation of those standards to the tenant and those violations remain uncorrected. Upon correction of the violation to the satisfaction of the state or local agency responsible for the enforcement of that notice of violation, the landlord's refusal to permit the transfer is deemed withdrawn.
- $((\frac{(5)}{(5)}))$ (6) The landlord shall approve or disapprove of the 40 assignment of a rental agreement on the same basis that the landlord

- (e) Change of land use of the mobile home park including, but not limited to, closure of the mobile home park or conversion to a use other than for mobile homes, manufactured homes, or park models or conversion of the mobile home park to a mobile home park cooperative or mobile home park subdivision. The landlord shall give the tenants ((twelve months!)) three years! notice, in the form of a closure notice meeting the requirements of RCW 59.21.030, in advance of the effective date of such change. The three-year closure notice requirement does not apply if:
- (i) The mobile home park or manufactured housing community has been acquired for or is under imminent threat of condemnation;
- (ii) The mobile home park or manufactured housing community is sold to an <u>eligible</u> organization ((comprised of park or community tenants, to a nonprofit organization, to a local government, or to a housing authority for the purpose of preserving the park or community)); ((or))
- (iii) The landlord ((compensates)) provides relocation assistance of at least \$17,000 for a multisection home or of at least \$11,000 for a single section home, establishes a simple, straightforward, and timely process for compensating the tenants for the loss of their homes and actually compensates the tenants for the loss of their homes, at the greater of their ((assessed)) market value, as determined ((by the county assessor as of the date the closure notice is issued)) prior to a change of use or sale of the property, or \$5,000, at any point during the closure notice period and prior to a change of use or sale of the property. At such time as the compensation is paid, the tenant shall be given written notice of at least ((ninety days)) 12 months in which to vacate, and the tenant shall continue to pay rent for as much time as he or she remains in the mobile home park or manufactured housing community. Nothing in this subsection (1) (e) (iii) prevents a tenant from relocating his or her home out of the mobile home park or manufactured housing community pursuant to chapter 59.21 RCW. In the event that a home remains in the mobile home park or manufactured housing community

1 <u>after a tenant vacates, the landlord shall be responsible for its</u> 2 <u>demolition or disposal; or</u>

- (iv) The landlord provides relocation assistance of at least \$17,000 for a multisection home and of at least \$11,000 for a single section home at any point during the closure notice period and prior to a change of use or sale of the property. At such time as the assistance is paid, the tenant shall be given written notice of at least 24 months in which to vacate, and the tenant shall continue to pay rent for as much time as he or she remains in the mobile home park or manufactured housing community. Nothing in this subsection (1) (e) (iv) prevents a tenant from relocating his or her home out of the mobile home park or manufactured housing community pursuant to chapter 59.21 RCW. In the event that a home remains in the mobile home park or manufactured housing community after a tenant vacates, the landlord shall be responsible for its demolition or disposal;
- (f) Engaging in "criminal activity." "Criminal activity" means a criminal act defined by statute or ordinance that threatens the health, safety, or welfare of the tenants. A park owner seeking to evict a tenant or occupant under this subsection need not produce evidence of a criminal conviction, even if the alleged misconduct constitutes a criminal offense. Notice from a law enforcement agency of criminal activity constitutes sufficient grounds, but not the only grounds, for an eviction under this subsection. Notification of the seizure of illegal drugs under RCW 59.20.155 is evidence of criminal activity and is grounds for an eviction under this subsection. The requirement that any tenant or occupant register as a sex offender under RCW 9A.44.130 is grounds for eviction of the sex offender under this subsection. If criminal activity is alleged to be a basis of termination, the park owner may proceed directly to an unlawful detainer action;
- (g) The tenant's application for tenancy contained a material misstatement that induced the park owner to approve the tenant as a resident of the park, and the park owner discovers and acts upon the misstatement within one year of the time the resident began paying rent;
- (h) If the landlord serves a tenant three ((twenty-day)) 20-day notices, each of which was valid under (a) of this subsection at the time of service, within a ((twelve-month)) 12-month period to comply or vacate for failure to comply with the material terms of the rental agreement or an enforceable park rule, other than failure to pay rent

by the due date. The applicable ((twelve-month)) 12-month period shall commence on the date of the first violation;

- (i) Failure of the tenant to comply with obligations imposed upon tenants by applicable provisions of municipal, county, and state codes, statutes, ordinances, and regulations, including this chapter. The landlord shall give the tenant written notice to comply immediately. The notice must state that failure to comply will result in termination of the tenancy and that the tenant shall vacate the premises within ((fifteen)) 15 days;
- (j) The tenant engages in disorderly or substantially annoying conduct upon the park premises that results in the destruction of the rights of others to the peaceful enjoyment and use of the premises. The landlord shall give the tenant written notice to comply immediately. The notice must state that failure to comply will result in termination of the tenancy and that the tenant shall vacate the premises within ((fifteen)) 15 days;
- (k) The tenant creates a nuisance that materially affects the health, safety, and welfare of other park residents. The landlord shall give the tenant written notice to cease the conduct that constitutes a nuisance immediately. The notice must describe the nuisance and state (i) what the tenant must do to cease the nuisance and (ii) that failure to cease the conduct will result in termination of the tenancy and that the tenant shall vacate the premises in five days;
- (1) Any other substantial just cause that materially affects the health, safety, and welfare of other park residents. The landlord shall give the tenant written notice to comply immediately. The notice must describe the harm caused by the tenant, describe what the tenant must do to comply and to discontinue the harm, and state that failure to comply will result in termination of the tenancy and that the tenant shall vacate the premises within ((fifteen)) 15 days; or
- (m) Failure to pay rent by the due date provided for in the rental agreement three or more times in a ((twelve-month)) 12-month period, commencing with the date of the first violation, after service of a ((fourteen-day)) 14-day notice to comply or vacate.
- (2) Within five days of a notice of eviction as required by subsection (1)(a) of this section, the landlord and tenant shall submit any dispute to mediation. The parties may agree in writing to mediation by an independent third party or through industry mediation procedures. If the parties cannot agree, then mediation shall be

A duty is imposed upon both parties to participate in the mediation process in good faith for a period of ((ten)) 10 days for an eviction under subsection (1)(a) of 3 this section. It is a defense to an eviction under subsection (1)(a) 4 of this section that a landlord did not participate in the mediation 5 6 process in good faith.
 - (3) Except for a tenant evicted under subsection (1)(c) or (f) of this section, a tenant evicted from a mobile home park under this section shall be allowed ((one hundred twenty)) 120 days within which to sell the tenant's mobile home, manufactured home, or park model in place within the mobile home park: PROVIDED, That the tenant remains current in the payment of rent incurred after eviction, and pays any past due rent, reasonable attorneys' fees and court costs at the time the rental agreement is assigned. The provisions of RCW 59.20.073 regarding transfer of rental agreements apply.
 - Chapters 59.12 and 59.18 RCW govern the eviction recreational vehicles, as defined in RCW 59.20.030, from mobile home parks. This chapter governs the eviction of mobile homes, manufactured homes, park models, and recreational vehicles used as a primary residence from a mobile home park.
