1 AN ACT Relating to transferring the responsibilities for the
2 transportation revenue forecast for the transportation budget to the
3 economic and revenue forecast council; amending RCW 82.33.010 and
4 82.33.040; reenacting and amending RCW 82.33.020; and repealing RCW
5 43.88.125.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 **Sec. 1.** RCW 82.33.010 and 2012 1st sp.s. c 8 s 2 are each
8 amended to read as follows:

9 (1) (a) The economic and revenue forecast council is hereby
10 created. The council shall consist of (~~two individuals appointed by~~
11 ~~the governor, the state treasurer, and four individuals, one of whom~~
12 ~~is appointed by the chairperson of each of the two largest political~~
13 ~~caucuses in the senate and house of representatives. The)) the
14 following members:~~

15 (i) The director of the office of financial management;

16 (ii) The state treasurer;

17 (iii) The chair and ranking member of the house appropriations
18 committee, the chair and ranking member of the house finance
19 committee, the chair and ranking member of the senate ways and means
20 committee, and the vice-chair and assistant ranking member of the
21 senate ways and means committee, who shall sit with the council and

1 serve as voting members only at such time as the consideration of the
2 economic and revenue forecast for the operating budget and the state
3 budget outlook;

4 (iv) The director of the department of revenue, who shall sit
5 with the council and serve as a voting member only at such times as
6 the consideration of the economic and revenue forecast for the
7 operating budget and the state budget outlook;

8 (v) The chair and ranking member of the house transportation
9 committee, and chair and ranking member of the senate transportation
10 committee, who shall sit with the council and serve as voting members
11 only at such time as the consideration of the transportation revenue
12 forecast for the transportation budget; and

13 (vi) The director of the department of licensing, who shall sit
14 with the council and serve as a voting member only at such times as
15 the consideration of the transportation revenue forecast for the
16 transportation budget.

17 (b) Except as provided in (c) of this subsection, the chair of
18 the council shall be selected from among the four caucus appointees.
19 The council may select such other officers as the members deem
20 necessary.

21 (c) The chair of the council when conducting business related to
22 the transportation revenue forecast for the transportation budget
23 shall be selected from among the four legislative appointees from the
24 transportation budget committees.

25 (d) A quorum of the council consists of a majority of members
26 appointed for the business to be conducted.

27 (2) The council shall employ an economic and revenue forecast
28 supervisor to supervise the preparation of all economic and revenue
29 forecasts and the presentation of state budget outlooks. As used in
30 this chapter, "supervisor" means the economic and revenue forecast
31 supervisor. Approval by an affirmative vote of at least (~~five~~) nine
32 members of the council is required for any decisions regarding
33 employment of the supervisor. For purposes of this vote, all members
34 of the council set forth in subsection (1)(a) of this section are
35 voting members. Employment of the supervisor shall terminate after
36 each term of three years. At the end of the first year of each three-
37 year term the council shall consider extension of the supervisor's
38 term by one year. The council may fix the compensation of the
39 supervisor. The supervisor shall employ staff sufficient to
40 accomplish the purposes of this section.

1 (3) The economic and revenue forecast council shall oversee
2 ((the)):

3 (a) The preparation of and approve, by an affirmative vote of at
4 least ((five)) seven members eligible to vote for the economic and
5 revenue forecast for the operating budget, the official, optimistic,
6 and pessimistic state economic and revenue forecasts prepared under
7 RCW 82.33.020; and

8 (b) The preparation of and approval, by an affirmative vote of at
9 least five members of those members eligible to vote for, the
10 transportation revenue forecast for the transportation budget
11 prepared under RCW 82.33.020.

12 If the council is unable to approve ((a)) any forecast before a
13 date required in RCW 82.33.020, the supervisor shall submit the
14 forecast without approval and the forecast shall have the same effect
15 as if approved by the council.

16 (4) The economic and revenue forecast council shall oversee the
17 preparation of and approve, by an affirmative vote of at least
18 ((five)) seven members of those members eligible to vote for, the
19 state budget outlook prepared under RCW 82.33.060. If the council is
20 unable to approve a state budget outlook before a date required in
21 RCW 82.33.060, the supervisor shall submit the outlook prepared under
22 RCW 82.33.060 without approval and the outlook shall have the same
23 effect as if approved by the council.

24 (5) A councilmember who does not cast an affirmative vote for
25 approval of the official economic and revenue forecast ((or)) for the
26 operating budget, the state budget outlook, or the transportation
27 revenue forecast for the transportation budget may request, and the
28 supervisor shall provide, an alternative economic and revenue
29 forecast or state budget outlook based on assumptions specified by
30 the member including, for purposes of the state budget outlook,
31 revenues to and expenditures from additional funds.

32 (6) Members of the economic and revenue forecast council shall
33 serve without additional compensation but shall be reimbursed for
34 travel expenses in accordance with RCW 44.04.120 while attending
35 sessions of the council or on official business authorized by the
36 council. Nonlegislative members of the council shall be reimbursed
37 for travel expenses in accordance with RCW 43.03.050 and 43.03.060.

38 **Sec. 2.** RCW 82.33.020 and 2015 c 3 s 14 are each reenacted and
39 amended to read as follows:

1 (1) Four times each year the supervisor must prepare, subject to
2 the approval of the economic and revenue forecast council under RCW
3 82.33.010:

4 (a) An official state economic and revenue forecast;

5 (b) An unofficial state economic and revenue forecast based on
6 optimistic economic and revenue projections; (~~and~~)

7 (c) An unofficial state economic and revenue forecast based on
8 pessimistic economic and revenue projections; and

9 (d) Beginning with the September 2024 forecast, an official
10 transportation revenue forecast for the transportation budget. For
11 purposes of this subsection, the transportation revenue forecast for
12 the transportation budget includes, but is not limited to,
13 transportation taxes, vehicle fees, drivers' fees, fares and tolls,
14 and aircraft and vessel fees.

15 (2) The supervisor must submit forecasts prepared under this
16 section, along with any unofficial forecasts provided under RCW
17 82.33.010, to the governor and the members of the (~~committees on~~)
18 ways and means committee of the senate and appropriations committee
19 of the house of representatives and the chairs of the committees on
20 transportation of the senate and house of representatives, including
21 one copy to the staff of each of the committees, on or before
22 November 20th, February 20th in the even-numbered years, March 20th
23 in the odd-numbered years, June 27th, and September 27th. (~~In fiscal~~
24 ~~year 2015, the March 20th forecast shall be submitted on or before~~
25 ~~February 20, 2015.)) All forecasts must be based on the most recent
26 economic and revenue forecast council economic forecast. All
27 forecasts must include both estimated receipts and estimated revenues
28 in conformance with generally accepted accounting principles as
29 provided by RCW 43.88.037. In odd-numbered years, the period covered
30 by forecasts for the state general fund and related funds must cover
31 the current fiscal biennium and the next ensuing fiscal biennium, and
32 the period for the transportation related funds must cover the
33 current fiscal biennium and the next two ensuing fiscal biennia. In
34 even-numbered years, the period covered by the forecasts for the
35 state general fund and related funds shall be current fiscal and the
36 next two ensuing fiscal biennia, and the period for the
37 transportation related funds shall be the current fiscal and the next
38 two ensuing fiscal biennia.~~

39 (3) All agencies of state government must provide to the
40 supervisor immediate access to all information relating to economic

1 and revenue forecasts. Revenue collection information must be
2 available to the supervisor the first business day following the
3 conclusion of each collection period.

4 (4) The economic and revenue forecast supervisor and staff must
5 (~~relocate and~~) share information, data, and files with the tax
6 research section of the department of revenue and the department of
7 licensing but may not duplicate the duties and functions of one
8 another.

9 (5) As part of its forecasts under subsection (1) of this
10 section, the supervisor must provide estimated revenue from tuition
11 fees as defined in RCW 28B.15.020.

12 (6) The economic and revenue forecast council must, in
13 consultation with the economic and revenue forecast work group
14 created in RCW 82.33.040, review the existing economic and revenue
15 forecast council revenue model, data, and methodologies and in light
16 of recent economic changes, engage outside experts if necessary, and
17 recommend changes to the economic and revenue forecast council
18 revenue forecasting process to increase confidence and promote
19 accuracy in the revenue forecast. The recommendations are due by
20 September 30, 2012, and every five years thereafter.

21 **Sec. 3.** RCW 82.33.040 and 1986 c 158 s 23 are each amended to
22 read as follows:

23 (1) To promote the free flow of information and to promote
24 legislative input in the preparation of forecasts, immediate access
25 to all information relating to economic and revenue forecasts shall
26 be available to the economic and revenue forecast work group, hereby
27 created. Revenue collection information shall be available to the
28 economic and revenue forecast work group the first business day
29 following the (~~conclusion of each collection period~~) close of each
30 fiscal month. The economic and revenue forecast work group shall
31 consist of one staff member selected by the executive head or
32 chairperson of each of the following agencies or committees:

33 (a) Department of revenue;

34 (b) Office of financial management;

35 (c) Legislative evaluation and accountability program committee;

36 (d) Ways and means committee of the senate; (~~and~~)

37 (e) (~~Ways and means~~) Appropriations committee of the house of
38 representatives;

39 (f) Transportation committee of the senate;

1 (g) Transportation committee of the house of representatives;

2 (h) Washington state department of transportation; and

3 (i) Department of licensing.

4 (2) The economic and revenue forecast work group shall provide
5 technical support to the economic and revenue forecast council.
6 Meetings of the economic and revenue forecast work group may be
7 called by any member of the group for the purpose of assisting the
8 economic and revenue forecast council, reviewing the state economic
9 and revenue forecasts, or reviewing monthly revenue collection data
10 or for any other purpose which may assist the economic and revenue
11 forecast council.

12 (3) Staff members from the Washington state department of
13 transportation, department of licensing, transportation committee of
14 the senate, and transportation committee of the house of
15 representatives shall only provide technical support for the
16 transportation revenue forecast for the transportation budget.
