1 AN ACT Relating to guardianship and conservatorship; amending RCW  
2 11.130.090, 11.130.100, 11.130.270, 11.130.280, 11.130.315,  
3 11.130.320, 11.130.345, 11.130.365, 11.130.380, 11.130.425,  
4 11.130.430, 11.130.435, and 11.130.530; adding a new section to  
5 chapter 11.130 RCW; and adding a new section to chapter 2.72 RCW.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 **Sec. 1.** RCW 11.130.090 and 2019 c 437 s 118 are each amended to  
8 read as follows:

9 (1) Any suitable person over the age of (~~twenty-one~~) 21 years,  
10 or any parent under the age of (~~twenty-one~~) 21 years or, if the  
11 petition is for appointment of a professional guardian or  
12 conservator, any individual or guardianship or conservatorship  
13 service that meets any certification requirements established by the  
14 administrator for the courts, may, if not otherwise disqualified, be  
15 appointed guardian or conservator of a person subject to  
16 guardianship, conservatorship, or both. A financial institution  
17 subject to the jurisdiction of the department of financial  
18 institutions and authorized to exercise trust powers, and a federally  
19 chartered financial institution when authorized to do so, may be  
20 appointed to act as a guardian or conservator of a person subject to  
21 guardianship, conservatorship, or both without having to meet the

1 certification requirements established by the administrator for the  
2 courts. No person is qualified to serve as a guardian or conservator  
3 who is:

4 (a) Under (~~eighteen~~) 18 years of age except as otherwise  
5 provided herein;

6 (b)(i) Except as provided otherwise in (b)(ii) of this  
7 subsection, convicted of a crime involving dishonesty, neglect, or  
8 use of physical force or other crime relevant to the functions the  
9 individual would assume as guardian;

10 (ii) A court may, upon consideration of the facts, find that a  
11 relative convicted of a crime is qualified to serve as a guardian or  
12 conservator;

13 (c) A nonresident of this state who has not appointed a resident  
14 agent to accept service of process in all actions or proceedings with  
15 respect to the estate and caused such appointment to be filed with  
16 the court;

17 (d) A corporation not authorized to act as a fiduciary, guardian,  
18 or conservator in the state;

19 (e) A person whom the court finds unsuitable.

20 (2) If a guardian, or conservator is not a certified professional  
21 guardian, conservator, or financial institution authorized under this  
22 section, the guardian or conservator must complete any standardized  
23 training video or web cast for lay guardians or conservators made  
24 available by the administrative office of the courts and the superior  
25 court where the petition is filed unless granted a waiver by the  
26 court. The training video or web cast must be provided at no cost to  
27 the guardian, or conservator.

28 (a) If a petitioner requests the appointment of a specific  
29 individual to act as a guardian or conservator, the petition for  
30 guardianship or conservatorship must include evidence of the  
31 successful completion of the required training video or web cast by  
32 the proposed guardian or conservator. The superior court may defer  
33 the completion of the training requirement to a date no later than  
34 ninety days after appointment if the petitioner requests expedited  
35 appointment due to emergent circumstances.

36 (b) If no person is identified to be appointed guardian or  
37 conservator at the time the petition is filed, then the court must  
38 require that the petitioner identify within (~~fourteen~~) 14 days from  
39 the filing of the petition a specific individual to act as guardian  
40 or conservator subject to the training requirements set forth herein.

1 If the petitioner fails to identify a guardian or conservator within  
2 14 days of filing, the court shall dismiss the guardianship or  
3 conservatorship.

4 **Sec. 2.** RCW 11.130.100 and 2020 c 312 s 304 are each amended to  
5 read as follows:

6 (1) Unless otherwise compensated or reimbursed, an attorney for a  
7 respondent in a proceeding under this chapter is entitled to  
8 reasonable compensation for services and reimbursement of reasonable  
9 expenses from the property of the respondent.

10 (2) Unless otherwise compensated or reimbursed, an attorney, or  
11 other person whose services resulted in an order beneficial to an  
12 individual subject to guardianship or conservatorship or for whom a  
13 protective arrangement under Article 5 of this chapter was ordered,  
14 is entitled to reasonable compensation for services and reimbursement  
15 of reasonable expenses from the property of the individual.

16 (3) Where the person subject to guardianship or conservatorship  
17 is a department of social and health services client, or health care  
18 authority client, and is required to contribute a portion of their  
19 income towards the cost of long-term care services or room and board,  
20 the amount of compensation or reimbursement shall not exceed the  
21 amount allowed by the department of social and health services or  
22 health care authority by rule.

23 (4) Where the person subject to guardianship or conservatorship  
24 receives guardianship, conservatorships, or other protective services  
25 from the office of public guardianship and conservatorship, the  
26 amount of compensation or reimbursement shall not exceed the amount  
27 allowed by the office of public guardianship and conservatorship.

28 (5) The court must approve compensation and expenses payable  
29 under this section before payment. Approval is not required before a  
30 service is provided or an expense is incurred.

31 (6) If the court dismisses a petition under this chapter and  
32 determines the petition was filed in bad faith or without the  
33 requisite investigation necessary to constitute good faith, the court  
34 may assess the cost of any court-ordered professional evaluation,  
35 court-appointed attorney, or court visitor against the petitioner.

36 **Sec. 3.** RCW 11.130.270 and 2019 c 437 s 302 are each amended to  
37 read as follows:

1 (1) A person interested in an adult's welfare, including the  
2 adult for whom the order is sought, may petition for appointment of a  
3 guardian for the adult.

4 (2) A person interested in the welfare of a minor who, within 45  
5 days of the filing of the petition, will attain the age of majority,  
6 may petition for appointment of a guardian for the minor. The minor  
7 may petition on the minor's own behalf.

8 (3) A petition under subsection (1) or (2) of this section must  
9 state the petitioner's name, principal residence, current street  
10 address, if different, relationship to the respondent, interest in  
11 the appointment, the name and address of any attorney representing  
12 the petitioner, and, to the extent known, the following:

13 (a) The respondent's name, age, principal residence, current  
14 street address, if different, and, if different, address of the  
15 dwelling in which it is proposed the respondent will reside if the  
16 petition is granted;

17 (b) The name and address of the respondent's:

18 (i) Spouse or domestic partner or, if the respondent has none, an  
19 adult with whom the respondent has shared household responsibilities  
20 for more than six months in the (~~twelve~~) 12-month period  
21 immediately before the filing of the petition;

22 (ii) Adult children or, if none, each parent and adult sibling of  
23 the respondent, or, if none, at least one adult nearest in kinship to  
24 the respondent who can be found with reasonable diligence; (~~and~~)

25 (iii) Adult stepchildren whom the respondent actively parented  
26 during the stepchildren's minor years and with whom the respondent  
27 had an ongoing relationship in the two-year period immediately before  
28 the filing of the petition; and

29 (iv) Parents, if living and involved in the respondent's life;

30 (c) The name and current address of each of the following, if  
31 applicable:

32 (i) A person responsible for care of the respondent;

33 (ii) Any attorney currently representing the respondent;

34 (iii) Any representative payee appointed by the social security  
35 administration for the respondent;

36 (iv) A guardian or conservator acting for the respondent in this  
37 state or in another jurisdiction;

38 (v) A trustee or custodian of a trust or custodianship of which  
39 the respondent is a beneficiary;

1 (vi) Any fiduciary for the respondent appointed by the department  
2 of veterans affairs;

3 (vii) An agent designated under a power of attorney for health  
4 care in which the respondent is identified as the principal;

5 (viii) An agent designated under a power of attorney for finances  
6 in which the respondent is identified as the principal;

7 (ix) A person nominated as guardian by the respondent;

8 (x) A person nominated as guardian by the respondent's parent or  
9 spouse or domestic partner in a will or other signed record;

10 (xi) A proposed guardian and the reason the proposed guardian  
11 should be selected; and

12 (xii) A person known to have routinely assisted the respondent  
13 with decision making during the six months immediately before the  
14 filing of the petition;

15 (d) The reason a guardianship is necessary, including a brief  
16 description of:

17 (i) The nature and extent of the respondent's alleged need;

18 (ii) Any protective arrangement instead of guardianship or other  
19 less restrictive alternatives for meeting the respondent's alleged  
20 need which have been considered or implemented;

21 (iii) If no protective arrangement instead of guardianship or  
22 other less restrictive alternatives have been considered or  
23 implemented, the reason they have not been considered or implemented;  
24 and

25 (iv) The reason a protective arrangement instead of guardianship  
26 or other less restrictive alternative is insufficient to meet the  
27 respondent's alleged need;

28 (e) Whether the petitioner seeks a limited guardianship or full  
29 guardianship;

30 (f) If the petitioner seeks a full guardianship, the reason a  
31 limited guardianship or protective arrangement instead of  
32 guardianship is not appropriate;

33 (g) If a limited guardianship is requested, the powers to be  
34 granted to the guardian;

35 (h) The name and current address, if known, of any person with  
36 whom the petitioner seeks to limit the respondent's contact;

37 (i) If the respondent has property other than personal effects, a  
38 general statement of the respondent's property, with an estimate of  
39 its value, including any insurance or pension, and the source and  
40 amount of other anticipated income or receipts; and

1 (j) Whether the respondent needs an interpreter, translator, or  
2 other form of support to communicate effectively with the court or  
3 understand court proceedings.

4 **Sec. 4.** RCW 11.130.280 and 2020 c 312 s 309 are each amended to  
5 read as follows:

6 (1) On receipt of a petition under RCW 11.130.270 for appointment  
7 of a guardian for an adult, the court shall appoint a court visitor.  
8 The court visitor must be an individual with training or experience  
9 in the type of abilities, limitations, and needs alleged in the  
10 petition.

11 (2) The court, in the order appointing a court visitor, shall  
12 specify the hourly rate the court visitor may charge for his or her  
13 services, and shall specify the maximum amount the court visitor may  
14 charge without additional court review and approval. The fee shall be  
15 charged to the person subject to a guardianship or conservatorship  
16 proceeding unless the court finds that such payment would result in  
17 substantial hardship upon such person, in which case the county shall  
18 be responsible for such costs: PROVIDED, That the court may charge  
19 such fee to the petitioner, the person subject to a guardianship or  
20 conservatorship proceeding, or any person who has appeared in the  
21 action; or may allocate the fee, as it deems just. If the petition is  
22 found to be frivolous or not brought in good faith, the court visitor  
23 fee shall be charged to the petitioner. The court shall not be  
24 required to provide for the payment of a fee to any salaried employee  
25 of a public agency.

26 (3)(a) The court visitor appointed under subsection (1) of this  
27 section shall within five days of receipt of notice of appointment  
28 file with the court and serve, either personally or by certified mail  
29 with return receipt, the respondent or his or her legal counsel, the  
30 petitioner or his or her legal counsel, and any interested party  
31 entitled to notice under RCW 11.130.080 with a statement including:  
32 His or her training relating to the duties as a court visitor; his or  
33 her criminal history as defined in RCW 9.94A.030 for the period  
34 covering (~~ten~~) 10 years prior to the appointment; his or her hourly  
35 rate, if compensated; whether the court visitor has had any contact  
36 with a party to the proceeding prior to his or her appointment; and  
37 whether he or she has an apparent conflict of interest. Within three  
38 days of the later of the actual service or filing of the court  
39 visitor's statement, any party may set a hearing and file and serve a

1 motion for an order to show cause why the court visitor should not be  
2 removed for one of the following three reasons:

3 (i) Lack of expertise necessary for the proceeding;

4 (ii) An hourly rate higher than what is reasonable for the  
5 particular proceeding; or

6 (iii) A conflict of interest.

7 (b) Notice of the hearing shall be provided to the court visitor  
8 and all parties. If, after a hearing, the court enters an order  
9 replacing the court visitor, findings shall be included, expressly  
10 stating the reasons for the removal. If the court visitor is not  
11 removed, the court has the authority to assess to the moving party  
12 attorneys' fees and costs related to the motion. The court shall  
13 assess attorneys' fees and costs for frivolous motions.

14 (4) A court visitor appointed under subsection (1) of this  
15 section shall interview the respondent in person and, in a manner the  
16 respondent is best able to understand:

17 (a) Explain to the respondent the substance of the petition, the  
18 nature, purpose, and effect of the proceeding, the respondent's  
19 rights at the hearing on the petition, and the general powers and  
20 duties of a guardian;

21 (b) Determine the respondent's views about the appointment sought  
22 by the petitioner, including views about a proposed guardian, the  
23 guardian's proposed powers and duties, and the scope and duration of  
24 the proposed guardianship; and

25 (c) Inform the respondent that all costs and expenses of the  
26 proceeding, including the respondent's attorney's fees, may be paid  
27 from the respondent's assets.

28 (5) If the respondent objects to the petition or requests  
29 appointment of an attorney, the court visitor shall petition the  
30 court to have an attorney appointed within five days of meeting the  
31 respondent.

32 (6) The court visitor appointed under subsection (1) of this  
33 section shall:

34 (a) Interview the petitioner and proposed guardian, if any;

35 (b) Visit the respondent's present dwelling and any dwelling in  
36 which it is reasonably believed the respondent will live if the  
37 appointment is made;

38 (c) Obtain information from any physician or other person known  
39 to have treated, advised, or assessed the respondent's relevant  
40 physical or mental condition; and

1 (d) Investigate the allegations in the petition and any other  
2 matter relating to the petition the court directs.

3 (~~(6)~~) (7) A court visitor appointed under subsection (1) of  
4 this section shall file a report in a record with the court and  
5 provide a copy of the report to the respondent, petitioner, and any  
6 interested party entitled to notice under RCW 11.130.080 at least  
7 (~~fifteen~~) 15 days prior to the hearing on the petition filed under  
8 RCW 11.130.270, which must include:

9 (a) A summary of self-care and independent living tasks the  
10 respondent can manage without assistance or with existing supports,  
11 could manage with the assistance of appropriate supportive services,  
12 technological assistance, or supported decision making, and cannot  
13 manage;

14 (b) A recommendation regarding the appropriateness of  
15 guardianship, including whether a protective arrangement instead of  
16 guardianship or other less restrictive alternative for meeting the  
17 respondent's needs is available and:

18 (i) If a guardianship is recommended, whether it should be full  
19 or limited; and

20 (ii) If a limited guardianship is recommended, the powers to be  
21 granted to the guardian;

22 (c) A statement of the qualifications of the proposed guardian  
23 and whether the respondent approves or disapproves of the proposed  
24 guardian;

25 (d) A statement whether the proposed dwelling meets the  
26 respondent's needs and whether the respondent has expressed a  
27 preference as to residence;

28 (e) A statement whether the respondent declined a professional  
29 evaluation under RCW 11.130.290 and what other information is  
30 available to determine the respondent's needs and abilities without  
31 the professional evaluation;

32 (f) A statement whether the respondent is able to attend a  
33 hearing at the location court proceedings typically are held;

34 (g) A statement whether the respondent is able to participate in  
35 a hearing and which identifies any technology or other form of  
36 support that would enhance the respondent's ability to participate;  
37 and

38 (h) Any other matter the court directs.

39 (~~(7)~~) (8) The appointment of a court visitor has no effect on  
40 the determination of the adult respondent's legal capacity and does

1 not overcome the presumption of legal capacity or full legal and  
2 civil rights of the adult respondent.

3 **Sec. 5.** RCW 11.130.315 and 2019 c 437 s 311 are each amended to  
4 read as follows:

5 ~~((1)) A guardian appointed under RCW 11.130.305 shall give the~~  
6 ~~adult subject to guardianship and all other persons given notice~~  
7 ~~under RCW 11.130.275 a copy of the order of appointment, together~~  
8 ~~with notice of the right to request termination or modification. The~~  
9 ~~order and notice must be given not later than fourteen days after the~~  
10 ~~appointment.~~

11 ~~(2))~~ Not later than ~~((thirty))~~ 14 days after appointment of a  
12 guardian under RCW 11.130.305, the guardian shall give to the adult  
13 subject to guardianship and any other person entitled to notice under  
14 RCW 11.130.310 (5) or (6) or a subsequent order a statement of the  
15 rights of the adult subject to guardianship and procedures to seek  
16 relief if the adult is denied those rights. The statement must be in  
17 at least sixteen-point font, in plain language, and, to the extent  
18 feasible, in a language in which the adult subject to guardianship is  
19 proficient. The statement must notify the adult subject to  
20 guardianship of the right to:

21 ~~((a))~~ (1) Seek termination or modification of the guardianship,  
22 or removal of the guardian, and choose an attorney to represent the  
23 adult in these matters;

24 ~~((b))~~ (2) Be involved in decisions affecting the adult,  
25 including decisions about the adult's care, dwelling, activities, or  
26 social interactions, to the extent reasonably feasible;

27 ~~((c))~~ (3) Be involved in health care decision making to the  
28 extent reasonably feasible and supported in understanding the risks  
29 and benefits of health care options to the extent reasonably  
30 feasible;

31 ~~((d))~~ (4) Be notified at least fourteen days before a change in  
32 the adult's primary dwelling or permanent move to a nursing home,  
33 mental health facility, or other facility that places restrictions on  
34 the individual's ability to leave or have visitors unless the change  
35 or move is proposed in the guardian's plan under RCW 11.130.340 or  
36 authorized by the court by specific order;

37 ~~((e))~~ (5) Object to a change or move described in ~~((d)) of~~  
38 ~~this))~~ subsection (4) of this section and the process for objecting;

1       ~~((f))~~ (6) Communicate, visit, or interact with others,  
2 including receiving visitors, and making or receiving telephone  
3 calls, personal mail, or electronic communications, including through  
4 social media, unless:

5       ~~((i))~~ (a) The guardian has been authorized by the court by  
6 specific order to restrict communications, visits, or interactions;

7       ~~((ii))~~ (b) A protective order or protective arrangement instead  
8 of guardianship is in effect that limits contact between the adult  
9 and a person; or

10       ~~((iii))~~ (c) The guardian has good cause to believe restriction  
11 is necessary because interaction with a specified person poses a risk  
12 of significant physical, psychological, or financial harm to the  
13 adult, and the restriction is:

14       ~~((A))~~ (i) For a period of not more than seven business days if  
15 the person has a relative or preexisting social relationship with the  
16 adult; or

17       ~~((B))~~ (ii) For a period of not more than sixty days if the  
18 person does not have a relative or preexisting social relationship  
19 with the adult;

20       ~~((g))~~ (7) Receive a copy of the guardian's plan under RCW  
21 11.130.340 and the guardian's report under RCW 11.130.345;

22       ~~((h))~~ (8) Object to the guardian's plan or report; and

23       ~~((i))~~ (9) Associate with persons of their choosing as provided  
24 in RCW 11.130.335(5).

25       **Sec. 6.** RCW 11.130.320 and 2020 c 312 s 204 are each amended to  
26 read as follows:

27       (1) A person interested in an adult's welfare, including the  
28 adult for whom the order is sought, may petition for appointment of  
29 an emergency guardian for the adult.

30       (2) An emergency petition under subsection (1) of this section  
31 must state the petitioner's name, principal residence, and current  
32 street address, if different, and~~((r))~~    to the extent known, the  
33 following:

34       (a) The respondent's name, age, principal residence~~((r))~~    and  
35 current street address, if different;

36       (b) The name and address of the respondent's:

37       (i) Spouse or domestic partner or, if the respondent has none, an  
38 adult with whom the respondent has shared household responsibilities

1 for more than six months in the twelve-month period immediately  
2 before the filing of the emergency petition;

3 (ii) Adult children or, if none, each parent and adult sibling of  
4 the respondent, or, if none, at least one adult nearest in kinship to  
5 the respondent who can be found with reasonable diligence; and

6 (iii) Adult stepchildren whom the respondent actively parented  
7 during the stepchildren's minor years and with whom the respondent  
8 had an ongoing relationship in the two-year period immediately before  
9 the filing of the emergency petition;

10 (c) The name and current address of each of the following, if  
11 applicable:

12 (i) A person responsible for care of the respondent;

13 (ii) Any attorney currently representing the respondent;

14 (iii) Any representative payee appointed by the social security  
15 administration for the respondent;

30 spouse or domestic partner in a will or other signed record;

31 (xii) A proposed emergency guardian, and the reason the proposed  
32 emergency guardian should be selected; and

33 (xiii) A person known to have routinely assisted the respondent  
34 with decision making during the six months immediately before the  
35 filing of the emergency petition;

36 (d) The reason an emergency guardianship is necessary, including  
37 a specific description of:

38 (i) The nature and extent of the emergency situation;

39 (ii) The nature and extent of the respondent's alleged emergency  
40 need that arose because of the emergency situation;

1 (iii) The substantial and irreparable harm to the respondent's  
2 health, safety, welfare, or rights that is likely to be prevented by  
3 the appointment of an emergency guardian;

4 (iv) All protective arrangements or other less restrictive  
5 alternatives that have been considered or implemented to meet the  
6 respondent's alleged emergency need instead of emergency  
7 guardianship;

8 (v) If no protective arrangements or other less restrictive  
9 alternatives have been considered or implemented instead of emergency  
10 guardianship, the reason they have not been considered or  
11 implemented; and

12 (vi) The reason a protective arrangement or other less  
13 restrictive alternative instead of emergency guardianship is  
14 insufficient to meet the respondent's alleged emergency need;

15 (e) The reason the petitioner believes that a basis for  
16 appointment of a guardian under RCW 11.130.265 exists;

17 (f) Whether the petitioner intends to also seek guardianship for  
18 an adult under RCW 11.130.270;

19 (g) The reason the petitioner believes that no other person  
20 appears to have authority and willingness to act to address the  
21 respondent's identified needs caused by the emergency circumstances;

22 (h) The specific powers to be granted to the proposed emergency  
23 guardian and a description of how those powers will be used to meet  
24 the respondent's alleged emergency need;

25 (i) If the respondent has property other than personal effects, a  
26 general statement of the respondent's property, with an estimate of  
27 its value, including any insurance or pension, and the source and  
28 amount of other anticipated income or receipts; and

29 (j) Whether the respondent needs an interpreter, translator, or  
30 other form of support to communicate effectively with the court or  
31 understand court proceedings.

32 (3) The requirements of RCW 11.130.090 apply to an emergency  
33 guardian appointed for an adult with the following exceptions for any  
34 proposed emergency guardian required to complete the training under  
35 RCW 11.130.090:

36 (a) The proposed emergency guardian shall present evidence of the  
37 successful completion of the required training video or web cast to  
38 the court no later than the hearing on the petition for appointment  
39 of an emergency guardian for an adult; and

1 (b) The superior court may defer the completion of the training  
2 requirement to a date no later than fourteen days after appointment  
3 if the petitioner requests an extension of time to complete the  
4 training due to emergent circumstances beyond the control of  
5 (~~the~~) the petitioner.

6 (4) On its own after a petition has been filed under RCW  
7 11.130.270, or on petition for appointment of an emergency guardian  
8 for an adult, the court may appoint an emergency guardian for the  
9 adult if the court makes specific findings based on clear and  
10 convincing evidence that:

11 (a) An emergency exists such that appointment of an emergency  
12 guardian is likely to prevent substantial and irreparable harm to the  
13 adult's physical health, safety, or welfare;

14 (b) The respondent's identified needs caused by the emergency  
15 cannot be met by a protective arrangement or other less restrictive  
16 alternative instead of emergency guardianship;

17 (c) No other person appears to have authority and willingness to  
18 act to address the respondent's identified needs caused by the  
19 emergency circumstances; and

20 (d) There is reason to believe that a basis for appointment of a  
21 guardian under RCW 11.130.265 exists.

22 (5) If the court acts on its own to appoint an emergency guardian  
23 after a petition has been filed under RCW 11.130.270, all  
24 requirements of this section shall be met.

25 (6) A court order appointing an emergency guardian for an adult  
26 shall:

27 (a) Grant only the specific powers necessary to meet the adult's  
28 identified emergency need and to prevent substantial and irreparable  
29 harm to the adult's physical health, safety, or welfare;

35 of the respondent cannot be met by a protective arrangement instead  
36 of guardianship or other less restrictive alternative, including any  
37 relief available under chapter 74.34 RCW or use of appropriate  
38 supportive services, technological assistance, or supported decision  
39 making;

1 (d) Include a specific finding that clear and convincing evidence  
2 established the respondent was given proper notice of the hearing on  
3 the petition;

4 (e) State that the adult subject to emergency guardianship  
5 retains all rights the adult enjoyed prior to the emergency  
6 guardianship with the exception of the rights not retained during the  
7 period of emergency guardianship;

32 digits of the account numbers and social security number redacted;

33 (f) Anything of more than de minimis value which the conservator,  
34 any individual who resides with the conservator, or the spouse,  
35 domestic partner, parent, child, or sibling of the conservator has  
36 received from a person providing goods or services to the individual  
37 subject to conservatorship;

1 (g) Any business relation the conservator has with a person the  
2 conservator has paid or that has benefited from the property of the  
3 individual subject to conservatorship; and

4 (h) Whether any co-conservator or successor conservator appointed  
5 to serve when a designated event occurs is alive and able to serve.

6 (3) The court may appoint a court visitor to review a report  
7 under this section or conservator's plan under RCW 11.130.510,  
8 interview the individual subject to conservatorship or conservator,  
9 or investigate any other matter involving the conservatorship. In  
10 connection with the report, the court may order the conservator to  
11 submit the conservatorship estate to appropriate examination in a  
12 manner the court directs.

13 (4) Notice of the filing under this section of a conservator's  
14 report, together with a copy of the report, must be provided to the  
15 individual subject to conservatorship, a person entitled to notice  
16 under RCW 11.130.420(6) or a subsequent order, and other persons the  
17 court determines. The notice and report must be given not later than  
18 fourteen days after filing.

19 (5) The court shall establish procedures for monitoring a report  
20 submitted under this section and review each report at least annually  
21 to determine whether:

22 (a) The reports provide sufficient information to establish the  
23 conservator has complied with the conservator's duties;

24 (b) The conservatorship should continue; and

25 (c) The conservator's requested fees, if any, should be approved.

26 (6) If the court determines there is reason to believe a  
27 conservator has not complied with the conservator's duties or the  
28 conservatorship should not continue, the court:

29 (a) Shall notify the individual subject to conservatorship, the  
30 conservator, and any other person entitled to notice under RCW  
31 11.130.420(6) or a subsequent order;

32 (b) May require additional information from the conservator;

33 (c) May appoint a court visitor to interview the individual  
34 subject to conservatorship or conservator or investigate any matter  
35 involving the conservatorship; and

36 (d) Consistent with RCW 11.130.565 and 11.130.570, may hold a  
37 hearing to consider removal of the conservator, termination of the  
38 conservatorship, or a change in the powers granted to the conservator  
39 or terms of the conservatorship.

1 (7) If the court has reason to believe fees requested by a  
2 conservator are not reasonable, the court shall hold a hearing to  
3 determine whether to adjust the requested fees.

4 (8) A conservator must petition the court for approval of a  
5 report filed under this section. The court after review may approve  
6 the report. If the court approves the report, there is a rebuttable  
7 presumption the report is accurate as to a matter adequately  
8 disclosed in the report.

9 (9) An order, after notice and hearing, approving an interim  
10 report of a conservator filed under this section adjudicates  
11 liabilities concerning a matter adequately disclosed in the report,  
12 as to a person given notice of the report or accounting.

13 (10) If the court approves a report filed under this section, the  
14 order approving the report shall set the due date for the filing of  
15 the next report to be filed under this section. The court may set the  
16 review at annual, biennial, or triennial intervals with the report  
17 due date to be within ninety days of the anniversary date of  
18 appointment. When determining the report interval, the court can  
19 consider: The length of time the conservator has been serving the  
20 person under conservatorship; whether the conservator has timely  
21 filed all required reports with the court; whether the conservator is  
22 monitored by other state or local agencies; the income of the person  
23 subject to conservatorship; the value of the property of the person  
24 subject to conservatorship; the adequacy of the bond and other  
25 verified receipt; and whether there have been any allegations of  
26 abuse, neglect, or a breach of fiduciary duty against the  
27 conservator.

28 (11) If the court approves a report filed under this section, the  
29 order approving the report shall contain a conservatorship summary or  
30 accompanied by a conservatorship summary in the form or substantially  
31 in the same form as set forth in RCW 11.130.665.

32 (12) If the court approves a report filed under this section, the  
33 order approving the report shall direct the clerk of the court to  
34 reissue letters of office in the form or substantially in the same  
35 form as set forth in RCW 11.130.660 to the conservator containing an  
36 expiration date which will be within one hundred eighty days (~~after~~  
37 ~~the date the court directs the conservator file its next report~~) of  
38 the anniversary date of appointment.

39 (13) An order, after notice and hearing, approving a final report  
40 filed under this section discharges the conservator from all

1 liabilities, claims, and causes of action by a person given notice of  
2 the report and the hearing as to a matter adequately disclosed in the  
3 report.

4 (14) Any requirement to establish a monitoring program under this  
5 section is subject to appropriation.

6 NEW SECTION. **Sec. 14.** A new section is added to chapter 11.130  
7 RCW to read as follows:

8 The court shall have authority to bring before it, in the manner  
9 prescribed by RCW 11.48.070, any person or persons suspected of  
10 having in their possession or having concealed, embezzled, conveyed,  
11 or disposed of any of the property of the estate of the individual  
12 subject to conservatorship subject to administration of this title.

13 NEW SECTION. **Sec. 15.** A new section is added to chapter 2.72  
14 RCW to read as follows:

15 (1) Subject to the availability of funds appropriated for this  
16 specific purpose, the office shall contract with public or private  
17 entities or individuals to provide public guardianship services to  
18 persons who are:

19 (a) Age 18 or older whose income does not exceed 400 percent of  
20 the federal poverty level determined annually by the United States  
21 department of health and human services or who are eligible to  
22 receive long-term care services through the Washington state  
23 department of social and health services;

24 (b) In an acute care hospital licensed under chapter 70.41 RCW, a  
25 psychiatric hospital licensed under chapter 71.12 RCW, or a state  
26 psychiatric hospital licensed under chapter 72.23 RCW, or in a  
27 location funded by such a hospital;

28 (c) Medically ready for discharge, or will soon be medically  
29 ready for discharge, to a postacute care and community setting; and

30 (d) Without a qualified person who is willing and able to serve  
31 as a guardian.

32 (2) For public guardianship services provided pursuant to  
33 subsection (1) of this section, the office shall establish a  
34 streamlined process to review requests for guardianship for persons  
35 who meet the requirement in subsection (1) of this section on a  
36 weekly basis.

37 (3) Subject to the availability of funds appropriated for this  
38 specific purpose, the office shall establish a navigator service to

1 provide assistance and support for hospitals and persons in  
2 hospitals, including assistance to navigate options for guardianship,  
3 public conservatorship, decision-making assistance, and estate  
4 administration services as appropriate for the person.

5 (4) Subject to the availability of funds appropriated for this  
6 specific purpose, the office shall fund training for guardians  
7 regarding considerations for specific populations, including  
8 behavioral health, involuntary treatment, disability, family law, and  
9 medicaid programs.
