AN ACT Relating to open motor vehicle safety recalls; adding a new section to chapter 46.32 RCW; adding a new section to chapter 46.16A RCW; creating a new section; and providing an effective date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

This act requires an official motor 5 NEW SECTION. Sec. 1. 6 vehicle inspection facility or licensed private inspection facility 7 to provide written notice to the owner of a motor vehicle being inspected for all open safety recalls applicable to the motor vehicle 8 9 at the time the motor vehicle is inspected. The recall notice must 10 include a description of each open safety recall and a statement that 11 each open safety recall may be repaired by certain motor vehicle 12 dealers at no cost to the owner, except in certain circumstances. 13 This act requires the department of licensing to provide written 14 notice to the owner of a motor vehicle, at the time a vehicle is registered or upon mailing a motor vehicle's registration renewal 15 16 notice, of all open safety recalls applicable to the motor vehicle. 17 The recall notice is to include a statement that each open safety 18 recall may be repaired by certain motor vehicle dealers at no cost to 19 the owner, except in certain circumstances.

1 Nothing in this act may alter the liability of any motor vehicle 2 manufacturer or motor vehicle dealer approved by a manufacturer to 3 repair an open safety recall.

<u>NEW SECTION.</u> Sec. 2. A new section is added to chapter 46.32
RCW to read as follows:

(1) During a motor vehicle inspection, an official inspection 6 facility, or licensed private inspection facility, shall check 7 information made available by the national highway traffic safety 8 administration to determine whether the motor vehicle being inspected 9 is subject to an open safety recall. If the vehicle is subject to one 10 or more open safety recalls, the official inspection facility or 11 licensed private inspection facility, shall provide the owner of the 12 motor vehicle, at the time of inspection, written notice of all open 13 safety recalls applicable to the motor vehicle. The recall notice 14 15 must include the following:

(a) A description of each open safety recall; and

(b) A statement that each open safety recall may be repaired by a motor vehicle dealer approved by the manufacturer of the motor vehicle at no cost to the owner of the motor vehicle, except as provided in 49 U.S.C. Sec. 30120.

(2) Nothing in this section alters the liability of any motor vehicle manufacturer or motor vehicle dealer approved by the manufacturer to repair an open safety recall.

(3) (a) The chief of the Washington state patrol and the chief of the Washington state patrol's designees, for the purposes of discharging their duties pursuant to this act are not liable for any act or omission related to the provision of an open safety recall notice and are immune from any related civil suit or action.

(b) For the purposes of discharging their duties pursuant to this act, a private inspection facility or its owner and employees are not liable to any person for any act or omission related to the open safety recall notice provided pursuant to this section, except for cases of gross negligence.

(4) For the purposes of this section, "open safety recall" means a safety-related recall, for which notification by a manufacturer is required to be provided under 49 U.S.C. Secs. 30118 and 30119, that necessitates repairs or modifications to a motor vehicle by an authorized motor vehicle dealer. "Open safety recall" does not include: Recalls related to defects or failures to comply with

1 requirements relating to labeling or notification in a motor 2 vehicle's owner's manual; or recalls where the remedy is for the 3 manufacturer to repurchase the motor vehicle or otherwise provide 4 financial compensation to the owner of the motor vehicle.

5 <u>NEW SECTION.</u> Sec. 3. A new section is added to chapter 46.16A 6 RCW to read as follows:

7 (1) (a) The department shall, before issuing a motor vehicle registration or mailing a motor vehicle registration renewal notice, 8 check information made available by the national highway traffic 9 safety administration to determine whether the motor vehicle is 10 subject to an open safety recall. For a vehicle that is subject to 11 one or more open safety recalls, the department shall provide the 12 owner of the motor vehicle written notice of all open safety recalls 13 applicable to the motor vehicle. The recall notice must be provided 14 15 at the time the vehicle is registered as well as be included in any 16 registration renewal notices sent to consumers by the department. The renewal notice must include a statement that the vehicle has one or 17 18 more open safety recalls that may be repaired by a motor vehicle dealer approved by the manufacturer of the motor vehicle at no cost 19 20 to the owner of the motor vehicle, except as provided in 49 U.S.C. 21 Sec. 30120.

(b) The department shall include as part of any reminder notices sent to consumers before the expiration of their registration a notice that their vehicle has one or more open safety recalls and that each open safety recall may be repaired by a motor vehicle dealer approved by the manufacturer of the motor vehicle at no cost to the owner of the motor vehicle, except as provided in 49 U.S.C. Sec. 30120.

(2) Nothing in this section alters the liability of any motor
 vehicle manufacturer or motor vehicle dealer approved by the
 manufacturer to repair an open safety recall.

32 (3) The director and director's designees including, pursuant to 33 RCW 46.01.140, county auditors, agents, and subagents, for the 34 purposes of discharging their duties pursuant to this act are not 35 liable for any act or omission related to the provision of an open 36 safety recall notice and are immune from any related civil suit or 37 action, consistent with RCW 46.01.310.

38 (4) For the purposes of this section, "open safety recall" means39 a safety-related recall, for which notification by a manufacturer is

1 required to be provided under 49 U.S.C. Secs. 30118 and 30119, that necessitates repairs or modifications to a motor vehicle by an 2 authorized motor vehicle dealer.
