INTERPRETIVE STATEMENT ISSUED

The department of revenue has issued the following excise tax advisory (ETA):

ETA 3043.2022 Low-Density Light and Power Utility Deduction

The department of revenue has revised ETA 3043. This ETA explains the public utility tax deduction provided by RCW 82.16.053 to qualifying power and light businesses.

RCW 82.16.053 requires the department to determine the state average electric power rate each year and inform taxpayers of this rate. This rate is used by power and light businesses to compute the amount of the deduction. The revised ETA 3043 updates the information to provide the rate for the period of July 1, 2022, through June 30, 2023.

CALL FOR DATA FOR

THE WASHINGTON STATE 2022 WATER QUALITY ASSESSMENT

The Washington state department of ecology (ecology) is seeking data to include in our next statewide water quality assessment (assessment). The assessment fulfills Washington state's obligation under the Clean Water Act to identify polluted waters (known as the §303(d) list) as well as report on the status of water quality in the state (called the §305(b) Report).

The assessment is developed using readily available water quality data and information to determine the status of water quality for a given waterbody segment. For more information on the assessment, view our water quality assessment web page at ecology.wa.gov/303d.

Ecology is seeking new water quality data collected between January 1, 2012, and December 31, 2021, during this "call for data." **The call-for-data window closes on September 30, 2022.** To ensure inclusion of your data in the next assessment, please submit data before this date. Ecology will only use scientifically credible data for the assessment. All data submitted must have been collected in accordance with a quality assurance project plan, or equivalent guidance document, and must be representative of ambient water quality conditions. Persons submitting data must be able to attest that quality assurance procedures were followed and must provide ecology with a copy of the plan upon request. **Data previously submitted to ecology does not need to be submitted again.**

Please submit numeric data to ecology's Environmental Information Management System (EIM). Submit relevant nonnumeric data, such as published research or peer-reviewed reports, directly to assessment staff at 303d@ecy.wa.gov.

Following the closure of the call for data window on September 30, 2022, ecology will begin reviewing and analyzing data for use in the 2022 assessment. We anticipate a draft will be available for public review in early 2024.

Rules Development Agenda for August 2022 through January 2023

The Administrative Procedure Act requires state agencies to prepare a biannual rules development agenda that includes the issues under consideration for rule making for the upcoming six-month period. RCW 34.05.314. Agendas are published in the State Register at the end of January and July each year. Staff proposes the following rule-making agenda for the period from August 2022 through January 2023:

- Update campaign reporting for digital political advertising (chapter 390-16 WAC).
- Over the last few years, the commission has reviewed and analyzed the policy and mechanisms for improving disclosure in the evolving area of digital political advertising. A product of this work was the adoption of rules earlier this year updating the requirements for commercial advertisers to maintain records of the digital political advertising they sell. Another step in this work is focusing on the detail of campaign reporting of expenditures on political advertising. The commission will consider making improvements in disclosure requirements for campaigns to report on political advertising and other activities.
- Update the registration and reporting requirements for continuing political committees (chapter 390-16 WAC). Under current law, a continuing political committee may register and identify multiple campaigns it supports or opposes in its registration. It also may amend its registration to add or delete campaigns. The identification of multiple campaigns can make it difficult to track the history of a continuing PAC and to attribute its spending on any particular campaign. The commission will consider ways to identify the campaigns in which a continuing PAC is actively participating, and to match the reported funding and expenditures with each specific campaign.
- Adjustments to the inflationary index (chapters 390-20 and 390-24 WAC).* Under RCW 42.17A.125, the commission must periodically consider revising the values set for contribution limits, reporting thresholds, and code values, in reference to any economic changes reflected by the inflationary index. Such revisions must be adopted in rules. The period for consideration is between every two and five years. The current values will be evaluated and considered for possible adjustments in rule.

Description: The health care authority (HCA) intends to submit SPA 22-0022 to increase the excess home equity limit when determining a person's eligibility for SSI-related long-term care services as described in WAC 182-513-1350, to the federal maximum allowed. On January 1 of each year, this standard may change by the percentage in the consumer price index for all consumers. Title or Subject: Medicaid State Plan Amendment (SPA) 22-0029
Provider and Facility July Rates.

Effective Date: July 1, 2022.

Description: The health care authority (HCA) in conjunction with the aging and long-term support administration (ALTSA) of the department of social and health services (DSHS) intend to submit medicaid SPA 22-0029 in order to increase daily rates for adult family homes, assisted living facilities, adult day health, agency providers, and individual providers. This amendment will also amend the private duty nursing methodology, nursing facility methodology, swing bed rate, and budget dial. SPA 22-0029 is expected to:

- Increase the daily rate for adult family homes on average by one percent. The weighted average increase is expected to be \$1.39, though this amount will vary based on the CARE classification of each individual client.
- Increase the daily rate for assisted living facilities on average by 25 percent. The weighted average increase is expected to be \$20.68, though this amount will vary based on the CARE classification of each individual client.
- Increase the daily rate for adult day health by \$11.08.
- Increase the hourly rate of agency providers by four percent. The weighted average increase is expected to be \$1.46.
- Increase the hourly rate of individual providers by three percent. The weighted average increase is expected to be \$0.80.
- Increase the private duty nursing hourly rate for agency providers by 20 percent.
- Increase the nursing facility swing bed rate by \$22.03, to \$254.61.
- Increase the nursing facility budget dial by \$59.98, to \$319.82.
- Adjust the direct care median and indirect care median in accordance with ESSB 5693, section 204(53). The direct care median will be raised to 111 percent and the indirect care median will be raised to 92 percent. These adjustments are specifically to raise wages for certain low wage employees of the nursing facilities. The department will review spending of this additional money to verify compliance.

Announcing the Reissuance of the Boatyard General permit

The Washington state department of ecology (ecology) is reissuing the Boatyard National Pollutant Discharge Elimination System (NPDES) and state waste discharge general permit (permit) on July 20, 2022. The permit becomes effective on September 1, 2022, and expires on August 31, 2027.

Purpose of the Permit: The permit addresses various legal requirements and responsibilities, and regulates the discharge of pollutants to protect water quality in Washington state. This permit authorizes the discharge of stormwater runoff and wastewater from boatyards. The permit is a combined NPDES and permit that limits the discharge of pollutants to surface waters under the authority of the Federal Water Pollution Control Act (33 U.S.C. 1251) and limits the discharge of pollutants to surface and groundwater under the authority of the State Water Pollution Control Act (chapter 90.48 RCW).

Public Notice Process and Comments: Ecology accepted public comments on the draft permit and fact sheet from March 3, 2021, *through* April 16, 2021. Ecology held informational public workshops and hearings during this time via online statewide webinars on April 12, 2021, and April 13, 2021. Ecology received written public comments and emails. The comments and ecology's responses are included as Appendix D of the fact sheet.

Applying for Coverage Under the Permit: Your boatyard facility covered under the existing permit that reapplied for permit coverage will be covered under the new permit. New or unpermitted boatyards may obtain coverage under the permit by submitting a complete permit application to ecology and satisfying all applicable public notice and State Environmental Policy Act requirements (WAC 173-226-200).
