Description: The health care authority (HCA) and the department of social and health services (DSHS) previously filed notice under WSR 23-02-061 of the intent to submit medicaid SPA 23-0001, which would incorporate tribal adult family homes as medicaid providers of the community first choice (CFC) program. Subsequent to that notice, DSHS received feedback from tribes expressing a preference for facilities to be tribally licensed rather than state licensed. Therefore, HCA and DSHS will not submit SPA 23-0001 and instead intend to submit SPA 23-0023 to incorporate tribal residential providers as medicaid providers of the CFC program.

To provide CFC services, tribal residential providers must meet the tribal licensing requirements and be approved as qualified providers by the Center for Medicare and Medicaid Services. The federally recognized tribe will perform initial licensing, inspections, routine inspections, and complaint investigations for tribal residential providers. Tribal residential providers will be paid an enhanced rate for providing culturally relevant personal care services.

At this time, HCA and DSHS do not have sufficient data to determine whether SPA 23-0023 will have an effect on annual aggregate payments/expenditures/reimbursements.

Description: On March 21, 2023, under WSR 23-07-114, the health care authority (HCA) filed notice of the intent to submit medicaid SPA 23-0002 to:

- Address changes made by the Centers for Medicare and Medicaid Services (CMS) to the payment methodology for biosimilar drugs in the average sales price (ASP) file. The percentage for these drugs will change from 106 percent to 108 percent. In order to avoid making changes to the medicaid state plan to reflect future percentage changes, HCA is removing the specific percentage amount and replacing it with a reference to the CMS ASP file.
- Address the level of the professional dispensing fees paid to pharmacies for providing services to medicaid clients in the feefor-service program. In addition to the professional dispensing fees, HCA pays a drug ingredient cost.

That notice stated SPA 23-0002 was expected to increase the annual aggregate expenditures/reimbursement/payments for the payment methodology for biosimilar drugs in the ASP file by an estimated \$250,000 annually, combined state and federal funds. It also stated that while SPA 23-0002 was also expected to increase the annual aggregate expenditures/reimbursement/payments in the fee-for-service pharmacy program for professional dispensing fees, HCA did not yet have a formal estimate of the anticipated amount of the potential increase and that HCA did not anticipate changes to the ingredient cost methodology.

At this time, HCA anticipates SPA 23-0002 to increase the annual aggregate expenditures/reimbursement/payments in the fee-for-service pharmacy program for professional dispensing fees. Please note the following amounts are tentative:
