Notice of Metropolitan Park District Dollar Threshold Adjustment

Compensation limits for metropolitan park commissioners are set in statute. RCW 35.61.150 provides that the daily compensation maximum amount is one hundred twenty-eight dollars (\$128) and the annual compensation maximum amount is twelve thousand two hundred eighty-eight dollars (\$12,288). However, for any metropolitan park district with facilities including an aquarium, a wildlife park, and a zoo, accredited by a nationally recognized accrediting agency, the annual compensation maximum amount is twenty-four thousand five hundred seventy-six dollars (\$24,576). RCW 35.61.150 also provides for the Office of Financial Management to adjust this dollar threshold for inflation every five years, beginning January 1, 2024. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, U.S. Department of Labor during that time period. The new dollar threshold shall be transmitted to the Office of the Code Reviser for publication in the Washington State Register at least one month before the new threshold takes effect.

Over the five-year period from October 2018 to October 2023, the Consumer Price Index for Urban Wage Earners and Clerical Workers for the Seattle-Tacoma-Bellevue, WA area as reported by the Bureau of Labor Statistics, U.S. Department of Labor, increased by 26.16 percent.

In accordance with the requirements set forth above, the Office of Financial Management submits for publication the new dollar threshold. The new dollar threshold is one hundred and sixty-one dollars (\$161) per day with a new annual compensation limit of fifteen thousand four hundred and fifty-six dollars (\$15,456). However, for any metropolitan park district with facilities including an aquarium, a wildlife park, and a zoo, accredited by a nationally recognized accrediting agency, the annual compensation maximum amount is thirty thousand nine hundred and twelve dollars (\$30,912). The new dollar threshold takes effect January 1, 2024.

Office of Financial Management Notice of Fire District Dollar Threshold Adjustment

Compensation limits for fire district board members are set in statute. RCW 52.14.010 provides that payment of compensation for each board member shall be at a rate of one hundred and four dollars (\$104) per day, with compensation for each board member not to exceed nine thousand nine hundred and eighty-four dollars (\$9,984) per year. RCW 52.14.010 also provides for the Office of Financial Management to adjust this dollar threshold for inflation every five years, beginning January 1, 2019. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, U.S. Department of Labor during that time period. The new dollar threshold shall be transmitted to the Office of the Code Reviser for publication in the Washington State Register at least one month before the new threshold takes effect.

Over the five-year period from October 2018 to October 2023, the Consumer Price Index for Urban Wage Earners and Clerical Workers for the Seattle-Tacoma-Bellevue, WA area as reported by the Bureau of Labor Statistics, U.S. Department of Labor, increased by 26.16 percent.

Compensation limits for port district commissioners are set in statute. RCW 53.12.260 provides that payment of per diem compensation for each commissioner may be at a rate of ninety dollars (\$90) per day, with per diem compensation for each commissioner not to exceed eight thousand six hundred and forty dollars (\$8,640) per year or ten thousand eight hundred dollars (\$10,800) per year for districts with a gross operating income of twenty-five million or more in the preceding calendar year. Commissioners also receive a salary of five hundred dollars (\$500) per month for districts with a gross operating income of twenty-five million or more in the preceding calendar year or two hundred dollars (\$200) per month for districts with a gross operating income of from one million to less than twenty-five million in the preceding calendar year. RCW 53.12.260 also provides for the Office of Financial Management to adjust the dollar thresholds for per diem compensation and salaries for inflation every five years, beginning January 1, 2024. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, U.S. Department of Labor during that time period. The new dollar threshold shall be transmitted to the Office of the Code Reviser for publication in the Washington State Register at least one month before the new threshold takes effect.

Over the five-year period from October 2018 to October 2023, the Consumer Price Index for Urban Wage Earners and Clerical Workers for the Seattle-Tacoma-Bellevue, WA area as reported by the Bureau of Labor Statistics, U.S. Department of Labor, increased by 26.16 percent.

Notice of Public Utility District Dollar Threshold Adjustment

Compensation limits for public utility district commissioners are set in statute. RCW 54.12.080 provides that payment of per diem compensation for each commissioner may be at a rate not exceeding ninety dollars (\$90) per day, with per diem compensation for each commissioner not to exceed twelve thousand six hundred dollars (\$12,600) per year. Commissioners also receive a salary of one thousand eighty [eight] hundred dollars (\$1,800) per month for districts with a gross revenue of over fifteen million in the preceding fiscal year or one thousand three hundred dollars (\$1,300) per month for districts with a gross revenue of from two million to fifteen million in the preceding fiscal year, or six hundred dollars (\$600) per month for other districts. RCW 54.12.080 also provides for the Office of Financial Management to adjust the dollar thresholds for per diem compensation and salaries for inflation every five years, beginning January 1, 2024. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, U.S. Department of Labor during that time period. The new dollar threshold shall be transmitted to the Office of the Code Reviser for publication in the Washington State Register at least one month before the new threshold takes effect.

Compensation limits for members of a public transportation benefit authority are set in statute. RCW 36.57A.050 provides that payment of compensation for each member may be at a rate up to forty-four dollars (\$44) per day, except that the authority by resolution may increase the payment of per diem compensation to up to ninety dollars (\$90) per day. The compensation for each regular member may not exceed

seventy-five days per year, which equals three thousand three hundred dollars (\$3,300) at the per diem rate of forty four dollars (\$44) or six thousand seven hundred and fifty dollars (\$6,750) at the per diem rate of ninety dollars (\$90). The compensation for the chair may not exceed one hundred days per year, which equals four thousand four hundred dollars (\$4,400) at the per diem rate of forty-four dollars (\$44) or nine thousand dollars (\$9,000) at the per diem rate of ninety dollars (\$90). RCW 36.57A.050 also provides for the Office of Financial Management to adjust the dollar thresholds for inflation every five years, beginning January 1, 2024. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, U.S. Department of Labor during that time period. Office of Financial Management Notice of Special District Governing Body Dollar Threshold Adjustment

Compensation limits for special district governing body members are set in statute. RCW 85.38.075 provides that payment of compensation for each member may be at a rate up to ninety dollars (\$90) per day, with compensation for each member not to exceed eight thousand six hundred and forty dollars (\$8,640) per year. RCW 85.38.075 also provides for the Office of Financial Management to adjust this dollar threshold for inflation every five years, beginning January 1, 2024. The adjustment is to be based upon changes in the consumer price index for "wage earners and clerical workers, all items" compiled by the Bureau of Labor and Statistics, U.S. Department of Labor during that time period. The new dollar threshold shall be transmitted to the Office of the Code Reviser for publication in the Washington State Register at least one month before the new threshold takes effect.

Over the five-year period from October 2018 to October 2023, the Consumer Price Index for Urban Wage Earners and Clerical Workers for the Seattle-Tacoma-Bellevue, WA area as reported by the Bureau of Labor Statistics, U.S. Department of Labor, increased by 26.16 percent.

In accordance with the requirements set forth above, the Office of Financial Management submits for publication the new dollar threshold. The new dollar threshold is one hundred and sixty-one dollars (\$161) per day with a new annual compensation limit of fifteen thousand four hundred and fifty-six dollars (\$15,456). The new dollar threshold takes effect January 1, 2024.

Project background: In 2019, the Washington state legislature directed ecology to implement a regulatory program to reduce toxic chemicals in consumer products under chapter 70A.350 RCW. The implementation program is called safer products for Washington. The law requires ecology, in consultation with Washington department of health, to determine regulatory actions that will increase transparency and reduce the use of priority chemicals in priority consumer products.

In 2022, the Washington state legislature amended chapter 70A.350 RCW to require ecology to make regulatory determinations on additional products containing PFAS as part of our work under the safer products for Washington implementation program. The amended law allows ecology to consider firefighting PPE and products identified in the 2021 PFAS CAP as priority products without taking the actions outlined in RCW 70A.350.030. We are required to make an initial set of regulatory determinations on these products by June 2024 and adopt rules by Decem-

ber 2025. As this work falls between the due dates for our first two review cycles, we are referring to this new review as "Cycle 1.5."

Effective Date: January 1, 2024.

Description: In compliance with Title 42, Chapter IV, Subchapter C, Part 433 C.F.R., Washington pursues reimbursement from liable third parties, other than health insurance or medicare, when medicaid has paid for certain services provided to a medicaid client when that client has primary insurance coverage. A casualty case to recover such costs is opened when the medicaid costs exceed a certain cumulative amount. Currently, the state opens a casualty case for a medicaid client when the cumulative cost for claims related to an accident/injury is \$50.00 and for ambulance claims is \$2,200.00. Also, ProviderOne automatically reviews the paid amount on an accident- or injury-related claim and sends a treatment questionnaire (TQ) to the client if the total claim payment is \$110.00 or more. The health care authority (HCA) intends to submit SPA 24-0006 to increase the cumulative paid amount on all types of claims to \$250.00 to open a casualty case and total claims payment to \$250.00 to send a TQ.

SPA 24-0006 is expected to have no effect on annual aggregate expenditures/reimbursement/payment.
