INTERPRETIVE STATEMENT ISSUED

The department of revenue (department) has issued the following excise tax advisory (ETA): **ETA 3014.2024 *Self-Produced Fuels***.

This ETA provides guidance on the application of state and local use tax on self-produced fuels. In addition, this ETA addresses the application of business and occupation tax on the production of self-produced fuels.

The department is updating this ETA to incorporate the value of refinery fuel gas for quarter 4, 2024. The value of refinery fuel gas is based on the average of the most recent 36 months of the "Henry Hub" natural gas spot prices, as by the federal Energy Information Administration. The 36-month average value is calculated and published by the department on a quarterly basis. See RCW 82.12.0203.

Title or Subject: Supplemental Notice for Medicaid State Plan Amendment (SPA) 24-0035 to Add Certified Behavioral Health Support Specialists as Collaborative Care Providers.

Effective Date: January 1, 2025.

Description: The health care authority (HCA) previously filed notice under WSR 24-18-012 of the intent to submit SPA 24-0035 to remove the requirement for physician assistants to be supervised by a physician when providing such services, add licensed mental health counselor associates, licensed marriage and family therapist associates, licensed advance social worker associates, licensed independent social worker associates, and certified behavioral health support specialists as providers of screening, brief interventions, and referral to treatment (SBIRT) services, simplify the existing list of providers, and update the title "chemical dependency professional" with "substance use disorder professional" in the list of health care professionals who can provide collaborative care services.

In addition, SPA 24-0035 will add certified behavioral health support specialists as collaborative care providers.

SPA 24-0035 is expected to increase annual aggregate expenditures/payments for certified behavioral health support specialists by \$619,000, and have no effect for physician assistants, certified behavioral health support specialists, and licensed mental health counselor associates, licensed marriage and family therapist associates, licensed advance social worker associates, and licensed independent social worker associates.

NOTICE OF REQUEST FOR ATTORNEY GENERAL'S OPINION
WASHINGTON ATTORNEY GENERAL

The Washington attorney general routinely publishes notice of an opportunity to comment for opinion requests that we receive from the heads of state agencies, state legislators, and county prosecuting attorneys if we anticipate publishing a formal opinion in response to the request. We do so in order to provide members of the public with a chance to provide any legal analysis that they would like us to consider as we develop our opinion. In preparing any comments, please be aware that our opinion will provide our considered legal analysis of the question presented, and therefore comments that address the interpretation of the law are more helpful than comments that express an opinion as to what the law should be.

Minimum Wage Calculations for 2025

As per RCW 49.46.020, the department of labor and industries (L&I) must calculate Washington state's minimum wage based on the consumer price index for urban wage earners and clerical workers index.

L&I has calculated the adjusted minimum wage rate for 2025 to \$16.66 per hour, effective January 1, 2025. This is a \$.38 per hour increase from 2024.

Calculations for the Executive, Administrative, and Professional (EAP)
Exemption Salary Threshold Calculations for 2025

The department of labor and industries recently updated the rule for overtime exemptions for EAP workers, including outside sales and computer professionals. To be exempt from overtime, EAP workers must be salaried, paid a minimum specified salary level, and must primarily perform executive, administrative, professional, outside sales, or computer professional duties as defined under chapter 296-128 WAC.

According to WAC 296-128-545, the salary thresholds for the EAP overtime exemption are calculated using a multiplier of the minimum wage for a 40-hour workweek and incrementally adjust through 2028. In 2028, the salary threshold will be 2.5 minimum wage for all employers.

Using the 2025 Washington minimum wage of \$16.66, the 2025 salary thresholds for EAP overtime exemption are as follows:

- For small employers with 50 or fewer employees, the applicable EAP salary threshold in 2025 is \$1,332.80 per week (\$69,305.60 annually), which is two times the minimum wage.
- For large employers with 51 or more employees, the applicable EAP salary threshold in 2025 is \$1,499.40 per week (\$77,968.80 annually), which is 2.25 times the minimum wage.
- For computer professionals, regardless of the size of the employer, the applicable wage rate for an exempt computer professional in 2025 is \$58.31 per hour, which is 3.5 times the minimum wage.

Noncompetition Enforceability Thresholds for 2025

As per RCW 49.62.040, the department of labor and industries required to adjust noncompete enforceability thresholds annually to account for inflation using the consumer price index for urban wage earners and clerical workers index. These thresholds determine whether a noncompetition clause or agreement is enforceable. There are two thresholds, one for employees (RCW 49.62.020) and one for independent contractors (RCW 49.62.030). The table below shows the previous and the new calculated figures.

Transportation Network Companies Adjustments for 2025

RCW 49.46.300 (4) (b) requires annual adjustments to Washington state's transportation network companies wage based on the consumer price index for urban wage earners and clerical workers (CPI-W) index. The Federal Bureau of Labor Statistics has determined that the CPI-W index increased to an August 2024 index level of 308.640 (1982-84=100). This change results in a 2.35 percent change over the last 12 months.

There are seven calculations specified under law for transportation network companies (RCW 49.46.300 (a) (i), (ii), or (iii)). The table below shows the new calculated figures.
