If a reviewer disagrees with an assessment decision, please provide comment on the listing with data and information to support the comment.

What Happens after the Public Review? Ecology will review all comments received and make needed changes to the assessment, which will then be submitted to the Environmental Protection Agency for approval of the Category 5 list of waters (i.e., the 303(d) list). Approved Category 5 listings will need to have a clean-up plan developed (also known as a total maximum daily load or TMDL) to improve water quality so that the water is meeting water quality standards.

# Announcing Ecology's Second Report on Safer Alternatives to Per- and Polyfluoroalkyl Substances (PFAS) in Food Packaging

RCW 70A.222.070 directs the department of ecology (ecology) to determine whether safer alternatives to per- and polyfluoroalkyl substances (PFAS) currently exist for food packaging applications. Ecology must also publish their findings in the Washington State Register and submit a report on alternatives to the legislature.

Final report under RCW 70A.222.070: Based on our findings, ecology does not believe there are food packaging products containing PFAS that require further review under RCW 70A.222.070. Therefore, ecology's 2024 food packaging report will be the final report under RCW 70A.222.070.
