AMENDATORY SECTION (Amending Order 2091, filed 7/25/91, effective 8/25/91)

WAC 16-122-001 Milk (~~vender~~) distributors license expiration. Milk (~~vender~~) distributors licenses issued under RCW (~~15.32.100~~) 15.36.061 shall expire on June 30th of each year.
