Description: The health care authority (HCA) intends to submit medicaid SPA 21-0032 in order to obtain medicaid funds to reimburse birthing hospitals to support the "rooming in" of the birth parent with their newborn following an in-utero exposure to substances that may lead to physiologic dependence, until the newborn is recovered from neonatal abstinence syndrome (NAS) or neonatal opioid withdrawal syndrome (NOWS) and/or is otherwise ready to be medically discharged. The intent is to provide a newborn administrative day rate or daily reimbursement to help offset the cost of providing the postpartum parent with room and board and limited additional services that are centered on the care and well-being of the newborn.

This SPA reflects HCA's response to SSB 5380 which directed HCA to make recommendations on ways to improve the care of birth parents with opioid use disorder and their newborns. Substantial research indicates that keeping the birth parent with the newborn during the exposed newborn's period of observation and potential withdrawal of neonatal NAS/NOWS as the first-line, nonmedication treatment is associated with better outcomes for both the birth parent and the newborn.

Based on this evidence, HCA recommended that the state authorize HCA to provide funds for the first-line nonmedication treatment of newborns by reimbursing birthing hospitals to support the "rooming in" and continuous care from the birth parent for their newborn when there has been in-utero exposure to substances that may lead to physiologic dependence.

SPA 21-0032 is expected to have no effect on the annual aggregate payment for this service. HCA anticipates the increased payment for the administrative day to be offset by a reduction in the length of stay required for infants with NAS/NOWS. Studies published by the National Association of Neonatal Nurses report a reduction in hospital stay days ranging from 35-74 percent. HCA anticipates shorter stays with a higher payment creating a net effect of \$0.

#### Technical Assistance Advisory (TAA) 2021-051

The purpose of this TAA is to provide guidance for health carriers<sup>2</sup> on the office of insurance commissioner's (OIC) implementation of the Federal No Surprises Act (FNSA).<sup>3</sup>

Background: Washington's Balance Billing Protection Act (BBPA) bans balance billing for emergency services provided by an out-of-network (OON) hospital or provider, and surgical and ancillary nonemergency services provided by an OON provider at in-network hospitals or ambulatory surgical facilities. 4 Balance billing refers to the practice of OON providers or facilities billing enrollees<sup>5</sup> for health care services provided to the enrollee after the provider or facility's billed amount is not fully reimbursed by the health carrier, exclusive of permitted enrollee cost-sharing. 6 The BBPA requires that the OON provider and health carrier negotiate OON payments in good faith without involving the enrollee. 7 Under the BBPA, the enrollee is only responsible for in-network cost sharing, which must be applied toward the enrollee's deductible and maximum out-of-pocket payment obligation.8

Congress recently passed FNSA, which also bans balance billing, but applies to a broader scope of plans and services than Washington's BBPA. This new law, enacted as part of the broader CCA of 2021, takes effect for health plans, beginning on or after January 1, 2022.9 It applies to nearly all private health plans offered by employers (including grandfathered health plans and the Federal Employees Health Benefits Program), as well as individual health insurance policies offered both on and off the exchange. $^{10}$  In addition to prohibiting balance billing for emergency services, the FNSA extends balance billing protections to post-stabilization services, 11 nonemergency services furnished by OON providers at in-network facilities without the enrollee's informed consent, 12 and services furnished by air ambulance providers. 13

Beyond banning balance bills by OON providers and facilities, the FNSA limits enrollee cost-sharing an enrollee must pay the issuer. 14 Enrollees who receive OON care will only have to pay the cost sharing amount that they would have paid if the provider had been in-network.<sup>15</sup> This limitation applies to emergency services, nonemergency services without the patient's informed consent, and air ambulance services.<sup>16</sup> It similarly limits cost-sharing when an enrollee relied on their issuer's provider directory's listing of a provider as innetwork, and that information turned out to be incorrect.<sup>17</sup> Any cost-sharing subject to the FNSA must be counted towards an enrollee's innetwork deductible and annual out-of-pocket maximum.<sup>18</sup>

Additionally, congress set up a regulatory framework for OON provider payment and dispute resolution, and added transparency measures, provider directory requirements, and continuity of care requirements.

**OIC Enforcement:** Aside from a few deferments described in the next section, OIC will enforce the FNSA provisions pertaining to health carriers for health plans starting on or after January 1, 2022. <sup>19</sup> This includes the following provisions of FNSA:

- Prohibition on balance billing for emergency services and nonemergency services under FNSA that are broader than the BBPA's scope of services protected from balance billing, including poststabilization care.<sup>20</sup>
- Prohibition on balance billing for grandfathered health plans.<sup>21</sup>
- Requirements for in-network cost-sharing for enrollees that relied on an issuer's databases, response protocols, or provider directory representations that a provider was in network.<sup>22</sup>
- Prohibition on balance billing for "continuing care patients" for 90 days after a provider becomes OON. 23
- Providing methods for calculating enrollee cost-sharing and provider payments, and dispute resolution, for: (1) Plans subject to OIC jurisdiction but not the BBPA, e.g., grandfathered health plans; and (2) services subject to the FNSA but not the BBPA, e.g., nonemergency services provided by neonatologists and intensivists. 24

The FNSA preempts state laws only when those laws impose a requirement that "prevents the application" of the FNSA.<sup>26</sup> Based upon this principle and a few FNSA provisions expressly deferring to state law, OIC will continue to enforce related state laws in four areas:

(1) BBPA provisions that exceed FNSA provisions;<sup>27</sup> (2) provider direc-

tories; $^{28}$  (3) calculation of enrollee cost-sharing; $^{29}$  and (4) OON provider payment and dispute resolution processes. $^{30}$

As a result, beginning January 1, 2022, until the effective date of any new legislation amending the BBPA, OIC will enforce the following state law provisions:

- Requirements on providers or insurers that go beyond what is required under the new federal law, including:
  - Prohibitions on asking an enrollee to waive their rights.<sup>31</sup>
  - Requirement that a health carrier must indicate in the Health Insurance Portability and Accountability Act (HIPAA) standard 271 transaction whether an enrollee's health plan is subject to the BBPA.<sup>32</sup>
  - Requirement that a health carrier must indicate in the HIPAA standard 835 transaction whether a claim was processed in accordance with the BBPA.<sup>33</sup>
- Requirements for provider directories.<sup>34</sup>
- BBPA's methods for calculating enrollee cost-sharing and OON provider payments, and dispute resolution.<sup>35</sup>

**Deferred Enforcement:** OIC will defer enforcement against some entities due to jurisdictional limitations, and with respect to some provisions of FNSA in alignment with deferment recently announced by the Departments of Health and Human Services, Labor, and Treasury (collectively referred to as "the departments").

Due to jurisdiction limitations, OIC will defer to other state or federal agencies for enforcement regarding the following entities:

- Air ambulances; 36
- Self-funded group health plans that have not elected to participate in the BBPA; and
- Health providers and facilities.<sup>37</sup>

Additionally, OIC will defer enforcement for some of the FNSA provisions in accordance with the deferred enforcement policy announced by the departments, Aug. 20, 2021, in a set of Frequently Asked Questions ("FAQs"). 38 In accordance with these FAQs, OIC will defer enforcement for the following FNSA provisions:

• Requirements for making available a price comparison tool (by internet website, in paper form, or telephone). Deferment will be up until plan years (in the individual market, policy years) beginning on or after January 1, 2023.

- Requirements for providing an advanced explanation of benefits. 40 Deferment will be until regulations fully implementing this requirement are adopted and applicable.

Additionally, the departments announced deferment of a few non-FNSA provisions, namely the requirement that issuers publish machine-readable files relating to prescription drug pricing. *Id.* at 1 (citing 85 Fed. OIC will continue to enforce any state law counterpart to these FNSA provisions, including, but not limited to the following:

- Requirements for transparency tools for price and quality information.<sup>42</sup>
- Requirements for enrollee notification upon termination of a provider by a health carrier. 43
- See RCW 48.43.007.
- WAC 284-170-421(10).

The departments also detailed provisions of FNSA44 that issuers must implement using a good faith, reasonable interpretation of the law, without the guidance of regulations. OIC will enforce the following provisions in the same manner as announced by the departments:

- Requirements to include on any insurance identification card issued to enrollees, any applicable deductibles, any applicable out-of-pocket maximum limitations, and a telephone number and website address for individuals to seek assistance. 45
- Requirements to establish a process to update and verify the accuracy of provider directory information and to establish a protocol for responding to requests by telephone and electronic communication from an enrollee about a provider's network participation status. 46
- Prohibition on cost-sharing when an enrollee relied on the issuer's provider directory or response protocol. 47
- Requirements to make certain disclosures regarding balance billing protections to enrollees. 48
- Requirements to apply continuity of care protections. 49
- Additionally, the departments detailed a few non-FNSA provisions it will expect issuers to implement using a good faith, reasonable interpretation of the law, including requirements prohibiting gag clauses. See FAQs at 7 (citing Code § 9824, ERISA § 724, and PHS Act § 2799A-9, as added by section 201 of division BB, title II, of CAA). OIC will enforce these provisions in the same manner as the departments. *Id.* at 4-5 (citing Code § 9816(e), ERISA § 716(e), and PHS Act § 2799A-1(e), as added by section 107 of the No Surprises Act).

Consumer Notice: OIC developed a consumer notice for balance billing rights that satisfies both FNSA and BBPA. 50 OIC's consumer notice should be used for fully insured health plans, PEBB/SEBB plans, and self-funded ERISA plans that have opted into BBPA. Under BBPA, this notice must be provided to enrollees in any communication that

authorizes nonemergency surgical or ancillary services at an in-network facility.  $^{51}$  Also, the issuer must indicate on the enrollee's explanation of benefits whether the service is subject to balance billing protections. 52 OIC will continue to enforce these BBPA consumer notice requirements against health carriers.

## Announcing the Reissuance of the Fresh Fruit Packing General Permit

The Washington state department of ecology (ecology) is reissuing the fresh fruit packing national pollutant discharge elimination system (NPDES) and state waste discharge general permit (permit). The permit becomes effective on January 1, 2022, and expires on December 31, 2026.

Purpose of the Permit: The permit addresses various legal requirements and responsibilities, and regulates the discharge of pollutants to protect water quality in Washington state. The permit authorizes the discharge of wastewater associated with the fresh fruit packing industry in Washington state. The permit is a combined NPDES and state waste discharge permit that limits the discharge of pollutants to surface waters under the authority of the Federal Water Pollution Control Act (33 U.S.C. 1251) and limits the discharge of pollutants to surface and groundwater under the authority of the State Water Pollution Control Act (chapter 90.48 RCW).

Public Notice Process and Comments: Ecology accepted public comments on the draft permit and fact sheet from September 1, 2021, through October 15, 2021. Ecology held informational public workshops and hearings during this time via online statewide webinars on October 6 and 7, 2021. Ecology received written public comments and emails. The comments and ecology's responses are included as Appendix C of the fact sheet.
