GR 40 INFORMAL FAMILY LAW TRIALS (IFLT)

[NEW]

- (1) Upon the consent of both parties and with approval of the court, Informal Family Law Trials (IFLT) may be held to resolve any or all issues in original actions or modification for dissolution of marriage, separate maintenance, invalidity, child support, parenting plans, residential schedules, relocation, child custody, and other family law matters as established by statute.
- (2) The parties may select an IFLT within 30 days before trial or trial setting if no trial date is set at filing, or as otherwise directed by local court rule. Parties must file a "Trial Process Selection" and Waiver for IFLT that is in substantial compliance with the attached model form. This form shall be accepted by all superior courts, but may be modified to conform to local rule practices, provided local rule practices do not nullify this rule and/or the implementation of this rule.
- (3) When a trial is conducted pursuant to this rule, in accordance with ordinary trial management, the trial judge shall retain discretion to modify any of these procedures as justice and fundamental fairness require, with prior notice to the parties.
- (a) At the beginning of an IFLT, the parties will be asked to affirm that they understand the rules and procedures of the IFLT process, they are consenting to this process freely and voluntarily, and they have not been threatened or promised anything for agreeing to the IFLT process. Parties must affirm that they waive the right to appeal the court's use of the IFLT process and the court's admission of evi-

dence pursuant to the IFLT process that is not consistent with the traditional court process, court rules, and Rules of Evidence. However, nothing in this rule prevents a party from filing a direct appeal of any final judgment or order at the conclusion of the IFLT.

- (b) The court may ask the parties or their lawyers for a brief summary of the issues to be decided.
- (c) The moving party will be allowed to address the court under oath concerning all issues in dispute. A represented party is not questioned by their counsel, but may be questioned by the court to develop evidence required by any statute or rule; for example, the applicable requirements of the Washington State Child Support Schedule if child support is at issue. A party may also present up to five declarations (limited to 20 pages total) from laypersons who would otherwise be called as witnesses.
- (d) The parties will not be subject to cross-examination unless permitted by the court. However, the court will ask the nonmoving party or their counsel whether there are any other areas the party wishes the court to inquire about. The court will inquire into these areas if requested and if relevant to an issue to be decided by the court.
- (e) The process in subsections (3)(c) and (3)(d) is then repeated for the other party.
- (f) Expert reports will be received as exhibits. Upon request of either party, the expert will be sworn and subjected to questioning by counsel, the parties, or the court.
- (g) The Rules of Evidence shall not apply to the proceedings. The judicial officer hearing the matter shall determine the credibility and weight of the evidence that is offered.
- (h) The court shall receive and admit exhibits offered by the parties. The court will determine what weight, if any, is given to each exhibit. The court may order the record to be supplemented. The process for submitting, filing, and storing exhibits shall be governed by local rule.
- (i) The parties or their counsel shall then be offered the opportunity to respond briefly to the statements of the other party.
- (j) The parties or their counsel shall be offered the opportunity to make a brief legal argument.
- (k) At the conclusion of the case, the court shall make its ruling or may take the matter under advisement, and make every effort to issue prompt rulings no later than the 90-day statutory requirement. Findings shall be made and orders entered consistent with statutes and case law.
- (1) The court may modify these trial procedures as justice and fundamental fairness requires.
- (4) The court may refuse to allow the parties to utilize the IFLT, or a party who has previously agreed to proceed with an IFLT may file a motion to opt out of the IFLT at any time, including after an IFLT has started but before a ruling has been issued.
- (a) If the parties request an IFLT after a traditional trial has started, the court should consider whether enforcement of traditional trial rules after the IFLT has started will prejudice either party or the best interests of any child. The decision to continue with a traditional trial shall be left to the discretion of the judicial officer hearing the matter.
- (b) A change in the type of trial to be held may result in a change of the trial date.

- There is no cross examination. The judge may ask questions.
- Most of the time, the two people in the case are the only witnesses in an Informal Trial. Sometimes a party needs an expert witness (someone with special training and education) to give an opinion, which is allowed in informal trials. The parties or their lawyers may ask experts questions. The expert's report will be received as an exhibit.
- Non-expert witnesses are not allowed. Instead, each party may submit up to 5 declarations from other people with a maximum page count of 20 pages. Also, each party can submit any document or other evidence they want the judge to review.
- The judge will decide what credibility and weight to give documents, physical evidence, and testimony that is entered as evidence during the Informal Trial. The judge is not bound by the Rules of Evidence.
- The judge will follow the same law to decide the case, whether it is an Informal or Traditional Trial.

TWO KINDS OF FAMILY LAW TRIALS

Do you have a family law trial coming up? If you do, you have a choice to make.

There are two different kinds of family law trials in Family Court. A family law trial is about divorce, legal separation, parenting plans, relocation, or child support. The two types of trials are called an Informal Family Law Trial (Informal Trial) and a Traditional Trial. You decide which type of trial is best for you.

Your trial will only be an Informal Trial if both parties agree to have one instead of a Traditional Trial.

What are the differences between Informal Trials and Traditional Trials?

	Informal Trials	Traditional Trials
How formal is the trial?	Less formal	More formal
How easy is this type of trial for a person who does not have a lawyer?	Easier	Harder
What evidence does the judge consider?	The judge decides what is important. You can talk to the judge about things that may not be allowed under the Rules of Evidence, like conversations you had with people outside the courtroom (hearsay). You can bring sworn statements from people who support your case, as well as other evidence or documents.	The parties need to follow the Rules of Evidence and make formal objections if they want to stop the judge from considering evidence.
Who asks questions?	Usually, only the judge.	Mainly the parties or their lawyers, but the judge can also ask witnesses questions.
Can I talk directly to the judge?	Yes.	Not usually. You can usually only talk to the judge during opening and closing arguments, and the other party can object while you are talking to the judge.
Who are the witnesses in the case?	Usually only the parties in the case and the Guardian ad Litem, if there is one. You can ask the judge to allow other expert witnesses, like a doctor or counselor.	Whoever you or the other party lists as a witness before trial starts.
Can I ask the witnesses questions?	No. This means that the other party or their law- yer can't interrupt you when you talk to the judge.	Yes. This means that you can ask the witness to talk about what you think is important.

TWO KINDS OF FAMILY LAW TRIALS

What do I need to know about my trial?

ALL TRIALS

- 1. Decide what type of trial you want. It will be a Traditional Trial unless both parties agree to an Informal Trial.
- 2. Before trial starts, both parties must prepare and give to the clerk, judge, and the other party:
 - If this is a divorce case, a list of everything you and your spouse own and owe and explain how you want the court to divide these properties and debts.
 - If child support or spousal support are an issue: a Financial Declaration, the last six months of pay stubs, and your tax returns for the last two years (with schedules, W2, and/or 1099).
 - If there are children, a proposed parenting plan.
- Before trial, each party must give the judge and the other party a copy of all of the documents and other evidence that you will give to the judge.
- 4. The judge will follow the same law to decide your case, whether you have an informal or formal trial.
- After trial, the judge will tell one party to draft the final orders. The final, written orders must contain all of the decisions that the judge made after trial. The case is not over until the judge signs the final orders.

INFORMAL TRIALS

- Before trial, the judge will make sure the parties understand how the informal trial works and that the parties volunteer to have that kind of trial.
- If there is a Guardian ad Litem (GAL), they will usually testify first.
- 8. The petitioner will speak to the judge under oath.
- The judge asks questions. If there is a lawyer, he or she can ask the judge to ask about certain topics.
- 10. The respondent then speaks to the judge under oath.
- The judge will review expert reports, if there are any, and may let experts testify.
- 12. The judge reviews evidence that was presented in court.
- 13. Each party can respond briefly to the other party.
- Each party can explain to the judge about how the laws apply in the case.
- The judge decides the case or sets another hearing for a decision.

TRADITIONAL TRIALS

- Both parties make an opening statement, telling the judge about the case and how they think the judge should rule.
 The petitioner goes first.
- The petitioner calls all of their witnesses. They ask the witnesses questions and may give the judge evidence. The respondent then asks the witnesses questions. The parties usually testify.
- The respondent then calls their witnesses and presents evidence. The petitioner can question the respondent's witnesses too.
- 9. The judge can allow a witness to be questioned again.
- The parties make closing argument. This summarizes the evidence, explains how the evidence means they should prevail, and tells the judge what is important.
- 11. The judge decides the case or sets a hearing for a decision.

 - 3. Purpose of Proposed Rule Amendment:

DMCJA is requesting expedited consideration for a technical change to CrRLJ 3.4(c).

When the current version of CrRLJ 3.4 was proposed, DMCJA struck through some language permitting judicial officers to allow remote appearances for several types of hearings including arraignments and sentencing. Remote appearances have proven to be a valuable tool in the administration of justice. Judicial officers should retain the discretion to permit remote appearances.

When the DMCJA proposed this change, we interpreted the "good cause" language of the rule to allow for courts to have discretion to continue to allow remote appearance for these types of hearings. However, we did not anticipate that some of our member courts would interpret the deletion of the remote appearance language to disallow those types of hearings.

DMCJA asks the Supreme Court Rules Committee to determine that this proposal is a technical change. GR 9(f) defines a technical change as "one which corrects a clerical mistake or an error arising from oversight or omission." Eliminating the remote appearance option from CrRLJ 3.4(c) was an oversight. A modest language change from the

rule is required because the term 'remote appearance' is used in the new rule.

Many judicial officers feel that the absence of the 'or remote appearance in the court's discretion" language from Rule 3.4 has limited their ability to permit a remote appearance. This technical change would clarify that remote appearances, in the court's discretion, are still permitted.

- 4. Is Expedited Consideration Requested? Yes. Expedited consideration is requested in order to avoid confusion and permit the current practice of remote appearances. As long as the Supreme Court Emergency Orders regarding COVID remain in place, Sections 8 and 10 of that Order permit remote appearances in the discretion of the Court. DMCJA requests expedited consideration to correct this oversight and requests a determination that this proposal is a technical change. This would promote a prompt amendment to the rule and clarification for judicial officers regarding remote hearings.
 - 5. Is a Public Hearing Recommended? No.

Crrlj 3.4 - APPEARANCE OF THE DEFENDANT

Sections (a) and (b): No changes.

(c) When Physical Appearance Is Required. The defendant's physical appearance (or remote appearance in the court's discretion) is required at the arraignment (if one is held), at every stage of the trial including empaneling the jury, returning the verdict, imposing the sentence, and at hearings set by the court upon a finding of good cause, except as otherwise provided by these rules, or as excused or excluded by the court for good cause shown.

Sections (d) and (e): No changes.

Suggested Amendment Rules of Appellate Procedure Rule 10.5 - Reproduction and Service of Briefs

- A. Proponent: Washington State Court of Appeals Rules Committee
- B. Spokesperson: Judge Bradley Maxa, Chair
- **C. Purpose:** RAP 10.5 provides that the appellate court clerk "will" arrange for the economic reproduction of each brief and charge the parties to pay the cost of reproduction. The rule also allows appellate court commissioner or clerk to permit a governmental party to reproduce and directly supply copies of briefs required by the court in lieu of the clerk's reproduction.

In light of the current status of electronic filings, reproduction of briefs may not be necessary. The proposed amendment to the rule will make the clerk's reproduction discretionary by changing the word "will" to "may" and will eliminate unnecessary copying of paper documents and reproduction charges. A separate proposed change to RAP 17.4 will also make reproduction of additional copies of all papers relating to motions or answers by appellate court commissioner or clerk discretionary. A separate proposed change to RAP 14.3(a) will

eliminate, from the list of recoverable costs for a prevailing party on review, cost of "preparation of a brief or other original document to be reproduced by the clerk," which is an amount per page fixed by the Supreme Court, while maintaining the cost of the clerk's reproduction charges. Additionally, in light of the current practice, the proposed amendment will remove the language that allows appellate court commissioner or clerk to permit a governmental party to directly supply copies of its briefs required by the court in lieu of reproduction. This is because the court has not utilized this practice and may not need this separate rule for a governmental party.

RAP 10.5 REPRODUCTION AND SERVICE OF BRIEFS

GENERAL PROVISIONS GOVERNING DISCOVERY

- (a) [Unchanged.]
- (b) Discovery Scope and Limits. Unless otherwise limited by order of the court in accordance with these rules, the scope of discovery is as follows:
 - (1) (4) [Unchanged.]
- (5) Trial Preparation: Experts. Discovery of facts known and opinions held by experts, otherwise discoverable under the provisions of subsection (b)(1) of this rule and acquired or developed in anticipation of litigation or for trial, may be obtained only as follows:
- (A) (i) A party may through interrogatories require any other party to identify each person whom the other party expects to call as an expert witness at trial, to state the subject matter on which the expert is expected to testify, to state the substance of the facts and opinions to which the expert is expected to testify and a summary of the grounds for each opinion, and to state such other information about the expert as may be discoverable under these rules. A case schedule deadline to disclose experts does not excuse a party timely responding to expert discovery. Delayed disclosure of an expert con-

stitutes a violation of CR 37 if the trial court finds the responding party delayed based on a case schedule deadline. (ii) Unless these rules impose an earlier deadline, and in no event later than the deadline for primary or rebuttal expert witness disclosures imposed by a case schedule or court order, each party shall identify each person whom that party expects to call as a primary or rebuttal expert witness at trial, state the subject matter on which the expert is expected to testify, state the substance of the facts and opinions to which the expert is expected to testify and a summary of the grounds for each opinion.

- (B) A party may, subject to the provisions of this rule and of rules 30 and 31, depose each person whom any other party expects to call as an expert witness at trial.
- (\underline{CB}) A party may discover facts known or opinions held by an expert who is not expected to be called as a witness at trial, only as provided in rule 35(b) or upon a showing of exceptional circumstances under which it is impracticable for the party seeking discovery to obtain facts or opinions on the same subject by other means.
- (DE) Unless manifest injustice would result, (i) the court shall require that the party seeking discovery pay the expert a reasonable fee for time spent in responding to discovery under subsections (b) (5) (B) (A) (ii) and (b) (5) (C) (B) of this rule; and (ii) with respect to discovery obtained under subsection (b) (5) (B) (A) (ii) of this rule the court may require, and with respect to discovery obtained under subsection (b) (5) (C) (B) of this rule the court shall require the party seeking discovery to pay the other party a fair portion of the fees and expenses reasonably incurred by the latter party in obtaining facts and opinions from the expert.

 - (c) (d) [Unchanged.]
- (e) Supplementation of Responses. A party who has responded to a request for discovery with a response has a duty to seasonably supplement or correct that response with information thereafter acquired. Supplementation or correction shall set forth only the information being supplemented or corrected. that was complete when made is under no duty to supplement the response to include information thereafter acquired, except as follows:
- (1) A party is under a duty seasonably to supplement their response with respect to any question directly addressed to:
- (A) the identity and location of persons having knowledge of discoverable matters, and
- (B) the identity of each person expected to be called as an expert witness at trial, the subject matter on which the expert witness is expected to testify, and the substance of the expert witness's testimony.
- (2) A party is under a duty seasonably to amend a prior response if the party obtains information upon the basis of which:
 - (A) the party knows that the response was incorrect when made, or
- (B) the party knows that the response though correct when made is no longer true and the circumstances are such that a failure to amend the response is in substance a knowing concealment.
- (3) A duty to supplement responses may be imposed by order of the court, agreement of the parties, or at any time prior to trial through new requests for supplementation of prior responses.
- (4) Failure to seasonably supplement or correct in accordance with this rule will subject the party to such terms and conditions as the trial court may deem appropriate.

- (g) Signing of Discovery Requests, Responses, and Objections. Every request for discovery or response or objection thereto made by a party represented party by an attorney shall be signed by at least one attorney of record in the attorney's individual name., whose address shall be stated. - 4. Does RCW 2.08.190 apply in San Juan County, a county in which the Superior Court Judge is not part of a district?

- 5. If a court hearing is held in a visiting judge's home county, is the clerk of the court for the county where the case is filed or the clerk of the court for the judge's home county responsible for keeping the minutes and the record of proceedings held?
- 6. Where a visiting judge is assigned pursuant to RCW 2.08.150, may the visiting judge delegate authority to a court commissioner or referee to conduct hearings as authorized by Chapter 2.24 RCW? If delegation to a court commissioner or referee is permitted, must the court commissioner or referee be a person appointed by the visiting judge or must it be a person appointed by the presiding judge the county where the case is filed?
