21 Concurrent Resolution No. 4443 (1990), shall continue to exist until
22 December 1, 1993, in order to undertake the following:

23 (1) Finalize the uniform benefits package design, which shall
24 include permissible deductible amounts and provision for point of
25 service cost-sharing by participants;

1 (2) Identify points at which point of service cost-sharing would be
2 a significant barrier to health services within the uniform benefits
3 package;

4 (3) Evaluate the extent to which racial and ethnic minorities have
5 access to and receive health services within the state;

6 (4) Establish the actual growth in total annual health services
7 costs from 1990 to 1993 and project future costs if no action is taken
8 and if recommended actions are taken;

9 (5) After consultation with health service providers, purchasers,
10 and consumers of health services, determine a method for adopting
11 practice guidelines in specific practice areas. Such practice
12 guidelines shall be used to promote appropriate use of technology,
13 services, drugs, and supplies and for cost containment and quality
14 assurance;

15 (6) Recommend guidelines to certified health plans for utilization
16 management, use of technology and methods of payment, such as
17 diagnosis-related groupings and a resource-based relative value scale.
18 Such guidelines shall be designed to promote improved management of
19 health services, and improved efficiency and effectiveness within the
20 health services delivery system;

21 (7) For services provided under the uniform benefits package, adopt
22 standards for a single billing and claims payment procedure. Such
23 standards shall ensure that these procedures are performed in a
24 simplified, streamlined, and economical manner for all parties
25 concerned. Except to the extent provided in section 7 of this act,
26 nothing in this subsection authorizes the commission to require any
27 specific claim or payment level or method.

28 (8) Adopt standards for personal health systems data and
29 information systems as provided in this act.

1 (9) Adopt standards that prevent conflict of interest by health
2 service providers as provided in section 10 of this act."
