7 county coordinating committee. The county coordinating committee shall  
8 consist of eight members. Each college board of trustees in Pierce  
9 county shall select two of its members to serve on the county  
10 coordinating committee. The county coordinating committee shall not  
11 employ its own staff, but shall instead utilize staff of the colleges  
12 in the county. The regional planning agreement adopted by the county  
13 coordinating committee shall include, but shall not be limited to: The  
14 times listed in this section, the transfer of credits between technical  
15 and community colleges, program articulation, and the avoidance of  
16 unnecessary duplication in programs, activities, and services."
