7 "NEW SECTION. **Sec. 5.** INTERAGENCY COORDINATION OF SERVICE  
8 DELIVERY. (1) The department of social and health services and the  
9 department of health shall assure that the delivery of available  
10 services to chemically dependent pregnant women and chemically  
11 dependent mothers and infants are coordinated so that (a) all available  
12 medical and support services offered through or paid by the agencies  
13 are provided to the extent of available resources, (b) existing  
14 community-based services are identified and utilized, (c) to the extent  
15 feasible, services be offered jointly to the mother and infant in a  
16 manner that promotes and preserves positive bonding of the mother and  
17 infant, (d) possible long-term developmental disabilities are  
18 identified early to minimize adverse health consequences, (e) the  
19 department of social and health services and the department of health  
20 are able to track clients and the services they receive across programs  
21 and agency lines using the high priority infant tracking system, as it  
22 is implemented, and (f) the department of health and the department of  
23 social and health services, in consultation with representatives from  
24 chemical dependency treatment programs and family planning agencies,  
25 shall jointly develop a curriculum and training format for substance  
26 abuse counselors and community service office line staff that includes:  
27 (i) Information to all clients on the risks to a fetus from exposure to

1 alcohol or drugs; (ii) a review of available birth control methods; and  
2 (iii) referral information to a family planning clinic.

3 (2) On or after January 1, 1993, qualified substance abuse  
4 counselors employed by state-approved chemical dependency treatment  
5 programs and community service office line staff shall receive the  
6 training described in subsection (1)(f) of this section. After  
7 receiving training, substance abuse counselors shall discuss these  
8 matters with and provide referral information to all of their clients.

9 (3) The department of health shall track referrals to family  
10 planning services from programs utilizing the curriculum developed  
11 under subsection (1)(f) of this section."

12 "NEW SECTION. **Sec. 6.** EDUCATION FOR HEALTH CARE PROFESSIONALS.  
13 The department of health may consult with the University of Washington  
14 and the disciplining authorities for each health care profession under  
15 RCW 18.130.040 whose license holders provide prenatal, obstetrical, and  
16 pediatric services and may prepare and distribute appropriate  
17 educational material to such license holders on the effects of  
18 substance abuse by pregnant women. The training and education may  
19 include information on identifying signs of drug usage, the effects of  
20 drug exposure, conducting medical assessments as provided for by this  
21 chapter, and referring patients to appropriate treatment and services."

22 "NEW SECTION. **Sec. 7.** CAPTIONS NOT LAW. Section captions as used  
23 in this act constitute no part of the law."

24 "NEW SECTION. **Sec. 8.** Sections 1 through 6 of this act shall  
25 constitute a new chapter in Title 70 RCW."

2   referencing this act by bill number, is not provided by June 30, 1992,
