- 6 "NEW SECTION. Sec. 4. Unless the context clearly requires
- 7 otherwise, the definitions in this section apply throughout this
- 8 chapter.
- 9 (1) "Department" means the department of community development.
- 10 (2) "Director" means the director of the department of community
- 11 development.
- 12 (3) "State fire marshal" means the assistant director of the
- 13 division of fire protection services in the department of community
- 14 development.
- 15 (4) "Fire chief" includes the chief officer of a statutorily
- 16 authorized fire agency, or the fire chief's authorized representative.
- 17 Also included are the department of natural resources fire control
- 18 chief, and the department of natural resources regional managers.
- 19 (5) "Jurisdiction" means state, county, city, fire district, or
- 20 port district fighting units, or other units covered by this chapter.
- 21 (6) "Mobilization" means that fire fighting resources beyond those
- 22 available through existing agreements will be requested and, when
- 23 available, sent to fight a fire that has or soon will exceed the
- 24 capabilities of available local resources. During a large scale fire
- 25 emergency, mobilization includes redistribution of regional or state-
- 26 wide fire fighting resources to either direct fire fighting assignments
- 27 or to assignment in communities where fire fighting resources are
- 28 needed. This chapter shall not reduce or suspend the authority or

- 1 responsibility of the department of natural resources under chapter
- 2 76.04 RCW.
- 3 (7) "Mutual aid" means emergency interagency assistance provided
- 4 without compensation under and agreement between jurisdictions under
- 5 chapter 39.34 RCW."
- 6 "NEW SECTION. Sec. 5. Because of the possibility of the
- 7 occurrence of disastrous fires or other disasters of unprecedented size
- 8 and destructiveness, the need to insure that the state is adequately
- 9 prepared to respond to such a fire or disaster, the need to establish
- 10 a mechanism and a procedure to provide for reimbursement to fire
- 11 fighting agencies that respond to help others in time of need, and
- 12 generally to protect the public peace, health, safety, lives, and
- 13 property of the people of Washington, it is hereby declared necessary
- 14 to:
- 15 (1) Provide the policy and organizational structure for large scale
- 16 mobilization of fire fighting resources in the state through creation
- 17 of the Washington state fire services mobilization plan;
- 18 (2) Confer upon the director of the department of community
- 19 development the powers provided herein; and
- 20 (3) Provide a means for reimbursement to fire jurisdictions that
- 21 incur expenses when mobilized by the director under the Washington
- 22 state fire services mobilization plan."
- 23 "NEW SECTION. Sec. 6. There is created the state fire defense
- 24 board consisting of the state fire marshal, a representative from the
- 25 department of natural resources appointed by the commissioner of public
- 26 lands, the assistant director of the emergency management division of
- 27 the department of community development, and one representative
- 28 selected by each regional fire defense board in the state. Members of

- 1 the state fire defense board shall select from among themselves a
- 2 chairperson. Members serving on the board do so in a voluntary
- 3 capacity and are not eligible for reimbursement for meeting-related
- 4 expenses from the state.
- 5 The state fire defense board shall develop and maintain the
- 6 Washington state fire services mobilization plan, which shall include
- 7 the procedures to be used during fire emergencies for coordinating
- 8 local, regional, and state fire jurisdiction resources. The Washington
- 9 state fire services mobilization plan shall be consistent with, and
- 10 made part of, the Washington state comprehensive emergency management
- 11 plan. The director shall review the fire services mobilization plan
- 12 as submitted by the state fire defense board and after consultation
- 13 with the fire protection policy board, recommend changes that may be
- 14 necessary, and approve the fire services mobilization plan for
- 15 inclusion within the state comprehensive emergency management plan.
- It is the responsibility of the director to mobilize jurisdictions
- 17 under the Washington state fire services mobilization plan. The state
- 18 fire marshal shall serve as the state fire resources coordinator when
- 19 the Washington state fire services mobilization plan is mobilized."
- 20 "NEW SECTION. Sec. 7. Regions within the state are initially
- 21 established as follows but may be adjusted as necessary by the
- 22 director:
- 23 (1) Northwest region Whatcom, Skagit, Snohomish, San Juan, and
- 24 Island counties;
- 25 (2) Northeast region Okanogan, Ferry, Stevens, Pend Oreille,
- 26 Spokane, and Lincoln counties;
- 27 (3) Olympic region Clallam and Jefferson counties;
- 28 (4) South Puget Sound region Kitsap, Mason, King, and Pierce
- 29 counties;

- 1 (5) Southeast region Chelan, Douglas, Kittitas, Grant, Adams,
- 2 Whitman, Yakima, Klickitat, Benton, Franklin, Walla Walla, Columbia,
- 3 Garfield, and Asotin counties;
- 4 (6) Central region Grays Harbor, Thurston, Pacific, and Lewis
- 5 counties; and
- 6 (7) Southwest region Wahkiakum, Cowlitz, Clark, and Skamania
- 7 counties.
- 8 Within each of these regions there is created a regional fire
- 9 defense board. The regional fire defense boards shall consist of two
- 10 members from each county in the region. One member from each county
- 11 shall be appointed by the county fire chiefs' association or, in the
- 12 event there is no such county association, by the county's legislative
- 13 authority. Each county's office of emergency management or, in the
- 14 event there is no such office, the county's legislative authority shall
- 15 select the second representative to the regional board. The department
- 16 of natural resources fire control chief shall appoint a representative
- 17 from each department of natural resources region to serve as a member
- 18 of the appropriate regional fire defense board. Members of each
- 19 regional board will select a chairperson and secretary as officers.
- 20 Members serving on the regional boards do so in a voluntary capacity
- 21 and are not eligible for reimbursement for meeting-related expenses
- 22 from the state.
- 23 Regional defense boards shall develop regional fire service plans
- 24 that include provisions for organized fire agencies to respond across
- 25 municipal, county, or regional boundaries. Each regional plan shall be
- 26 consistent with the incident command system, the Washington state fire
- 27 services mobilization plan, and regional response plans already adopted
- 28 and in use in the state. The regional boards shall work with the
- 29 relevant local government entities to facilitate development of
- 30 intergovernmental agreements if any such agreements are required to

- 1 implement a regional fire service plan. Each regional plan shall be
- 2 approved by the state fire defense board before implementation."
- 3 "NEW SECTION. Sec. 8. The department of community development
- 4 in consultation with the office of financial management shall develop
- 5 procedures to facilitate reimbursement to jurisdictions from
- 6 appropriate federal and state funds when jurisdictions are mobilized by
- 7 the director under the Washington state fire services mobilization
- 8 plan."
- 9 "NEW SECTION. Sec. 9. Sections 4 through 8 of this act shall
- 10 constitute a new chapter in Title 38 RCW."
