10 ~~pursuant to RCW 71.05.320(1),~~) and any interim period during which  
11 the person is awaiting trial or hearing on a new petition for  
12 involuntary treatment or involuntary medication. (~~Upon a request~~  
13 ~~timely filed, a review of any such medication order shall be~~  
14 ~~conducted by the court at the hearing on a petition filed pursuant~~  
15 ~~to RCW 71.05.300. If a succeeding involuntary treatment order is~~  
16 ~~entered pursuant to RCW 71.05.320(2), a person who refuses to~~  
17 ~~consent to the administration of antipsychotic medications shall be~~  
18 ~~entitled to an evidentiary hearing in accordance with this~~  
19 ~~section.~~)

20 (e) Any person detained pursuant to RCW 71.05.320(2), who  
21 subsequently refuses antipsychotic medication, shall be entitled to  
22 the procedures set forth in RCW 71.05.370(7).

23 (~~(e)~~) (f) Antipsychotic medication may be administered to a  
24 nonconsenting person detained or committed pursuant to this chapter  
25 without a court order under the following circumstances:

26 (i) A person presents an imminent likelihood of serious harm  
27 to self or others;

1 (ii) Medically acceptable alternatives to administration of  
2 antipsychotic medications are not available, have not been  
3 successful, or are not likely to be effective; and

4 (iii) In the opinion of the physician with responsibility for  
5 treatment of the person, or his or her designee, the person's  
6 condition constitutes an emergency requiring the treatment be  
7 instituted before a judicial hearing as authorized pursuant to this  
8 section can be held.

9 If antipsychotic medications are administered over a person's  
10 lack of consent pursuant to this subsection, a petition for an  
11 order authorizing the administration of antipsychotic medications  
12 shall be filed on the next judicial day. The hearing shall be held  
13 within two judicial days. If deemed necessary by the physician  
14 with responsibility for the treatment of the person, administration  
15 of antipsychotic medications may continue until the hearing is  
16 held;
