10 the vacancy occurs: PROVIDED, That the person appointed to fill the
11 vacancy must be from the same legislative district, county or county
12 commissioner district and the same political party as the legislator or
13 partisan county elective officer whose office has been vacated, and
14 shall be one of three persons who shall be nominated by the county
15 central committee of that party, and in case a majority of said county
16 commissioners do not agree upon the appointment within sixty days after
17 the vacancy occurs, the governor shall within thirty days thereafter,
18 and from the list of nominees provided for herein, appoint a person who
19 shall be from the same legislative district, county or county
20 commissioner district and of the same political party as the legislator
21 or partisan county elective officer whose office has been vacated, and
22 the person so appointed shall hold office until his successor is
23 elected at the next general election, and shall have qualified:
24 PROVIDED, That in case of a vacancy occurring in the office of joint
25 senator, or joint representative, the vacancy shall be filled from a
26 list of three nominees selected by the state central committee, by
27 appointment by the joint action of the boards of county commissioners
28 of the counties composing the joint senatorial or joint representative~~

13 person appointed to fill the vacancy must be from the same legislative
14 district, county or county commissioner district and the same political
15 party as the legislator or partisan county elective officer whose
16 office has been vacated. The person appointed shall be one of three
17 persons nominated by the precinct committee persons of that party and
18 from that legislative district, county or county commissioner district.
19 In case a majority of said county commissioners do not agree upon the
20 appointment within sixty days after the vacancy occurs, the governor
21 shall within thirty days thereafter, and from the list of nominees
22 provided for herein, appoint a person to fill the vacancy. The person
23 so appointed shall hold office until a successor is elected at the next
24 general election, and shall have qualified."
