- AN ACT Relating to elections; amending RCW 29.21.150, 29.21.180,

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 29.21.150 and 1975-'76 2nd ex.s. c 120 s 5 are each
- 6 amended to read as follows:
- 7 The name of the person who receives the greatest number of votes
- 8 and of the person who receives the next greatest number of votes at the
- 9 primary for a single nonpartisan position shall appear on the general
- 10 election ballot under the designation therefor((: PROVIDED, That in
- 11 elections for justices of the supreme court, judges of the court of
- 12 appeals and judges of the superior court, and for state superintendent
- 13 of public instruction, if any candidate in the primary receives a
- 14 majority of all the votes cast for the position, only the name of the
- 15 person receiving the highest vote shall be printed on the general

- 1 election ballot under the designation for that position, followed by a
- 2 space for the writing in of any other name by a voter.))
- 3 Sec. 2. RCW 29.21.180 and 1979 ex.s. c 183 s 8 are each amended to 4 read as follows:
- 5 No primary shall be held relating to the office of state
- 6 superintendent of public instruction or, except for any school district
- 7 of the first class having within its boundaries a city with a
- 8 population of four hundred thousand people or more in class AA
- 9 counties, officers of other first class school districts if, after the
- 10 last day allowed for candidates to withdraw, there are no more than two
- 11 candidates filed for each position to be filled. In such event all
- 12 candidates concerned shall be notified. Names of candidates that would
- 13 have been printed upon the primary ballot, but for the provisions of
- 14 this section, shall be printed upon the general election ballot in the
- 15 following order: For the superintendent of public instruction, in the
- order determined by lot under RCW 29.18.022; and for school district
- 17 <u>directors</u>, alphabetically in groups under the designation of the
- 18 respective titles of the offices for which they are candidates.
- 19 **Sec. 3.** RCW 29.30.085 and 1990 c 59 s 95 are each amended to read
- 20 as follows:
- 21 (((1) Except as provided under subsection (2) of this section,)) On
- 22 the ballot at the general election for a nonpartisan office for which
- 23 a primary was held, only the names of the candidate who received the
- 24 greatest number of votes and the candidate who received the next
- 25 greatest number of votes for that office shall appear under the title
- 26 of that office, and the names shall appear in that order. If a primary
- 27 was conducted, no candidate's name may be printed on the subsequent
- 28 general election ballot unless he or she receives at least one percent

- 1 of the total votes cast for that office at the preceding primary. On
- 2 the ballot at the general election for any ((other)) nonpartisan office
- 3 for which no primary was held, the names of the candidates shall be
- 4 listed in the order determined under RCW 29.30.025.
- 5 (((2) On the ballot at the general election for the office of
- 6 justice of the supreme court, judge of the court of appeals, judge of
- 7 the superior court, or state superintendent of public instruction, if
- 8 a candidate in a contested primary receives a majority of all the votes
- 9 cast for that office or position, only the name of that candidate may
- 10 be printed under the title of the office for that position.))
- 11 <u>NEW SECTION.</u> **Sec. 4.** A new section is added to chapter 29.21 RCW
- 12 to read as follows:
- 13 A primary shall be held as provided in RCW 29.13.070 for each
- 14 elective judicial office except as follows:
- 15 (1) No primary may be held for any single judicial position if,
- 16 after the last day allowed for candidates to withdraw, there are no
- 17 more than two candidates filed for the position. The county auditor
- 18 shall, as soon as possible, notify all the candidates so affected that
- 19 the office for which they have filed will not appear on the primary
- 20 ballot. The names of such candidates shall be printed upon the general
- 21 election ballot in the order determined by lot under RCW 29.18.022
- 22 (before July 1, 1992) or RCW 29.30.025 (beginning July 1, 1992).
- 23 (2) No primary may be held for a superior court judge position in
- 24 a county containing a population of one hundred thousand or more if,
- 25 after the last day provided by law for the withdrawal of declarations
- 26 of candidacy has expired, only one candidate has filed for the
- 27 position. A certificate of election shall be issued to such a
- 28 candidate as required by Article IV, section 29 of the Washington state
- 29 Constitution.
