- AN ACT Relating to the basic health plan; amending RCW 70.47.080
- 2 and 43.131.355; reenacting and amending RCW 43.131.356; and creating a
- 3 new section.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 70.47.080 and 1987 1st ex.s. c 5 s 10 are each amended
- 6 to read as follows:

State of Washington

- 7 On and after July 1, 1988, the administrator shall accept for
- 8 enrollment applicants eligible to receive covered basic health care
- 9 services from the respective managed health care systems which are then
- 10 participating in the plan. The administrator shall not allow the total
- 11 enrollment of those eligible for subsidies to exceed ((thirty)) sixty
- 12 thousand.

- 1 Thereafter, total enrollment shall not exceed the number
- 2 established by the legislature in any act appropriating funds to the
- 3 plan.
- 4 Before July 1, 1988, the administrator shall endeavor to secure
- 5 participation contracts from managed health care systems in discrete
- 6 geographic areas within at least five congressional districts of the
- 7 state and in such manner as to allow residents of both urban and rural
- 8 areas access to enrollment in the plan. The administrator shall make
- 9 a special effort to secure agreements with health care providers in one
- 10 such area that meets the requirements set forth in RCW 70.47.060(4).
- 11 The administrator shall at all times closely monitor growth
- 12 patterns of enrollment so as not to exceed that consistent with the
- 13 orderly development of the plan as a whole, in any area of the state or
- 14 in any participating managed health care system.
- 15 <u>NEW SECTION.</u> **Sec. 2.** The school of public health and
- 16 community medicine, of the University of Washington shall, consistent
- 17 with its ongoing evaluation of the basic health plan, submit an interim
- 18 report on the plan to the governor and appropriate committees of the
- 19 legislature by December 1, 1991. The report shall address: A
- 20 description of enrollees; enrollment and disenrollment patterns;
- 21 utilization rates; costs; and issues of implementation.
- 22 Sec. 3. RCW 43.131.355 and 1987 1st ex.s. c 5 s 24 are each
- 23 amended to read as follows:
- 24 The Washington basic health plan administrator and its powers and
- 25 duties shall be terminated on June 30, ((1992)) 1995, as provided in
- 26 RCW 43.131.356.
