By Representatives Peery, Brough, Ebersole, Holland, Dorn, Vance and Inslee; by request of Superintendent of Public Instruction and Board of Education.

Read first time February 14, 1991. Referred to Committee on Education.

- 1 AN ACT Relating to education; amending RCW 28A.150.200,
- 2 28A.150.220, 28A.150.230, 28A.150.260, 28A.150.290, 28A.195.010,
- 3 28A.230.090, 28A.230.100, and 28A.170.100; adding new sections to
- 4 chapter 28A.150 RCW; and repealing RCW 28A.150.210, 28A.230.110,
- 5 28A.305.140, 28A.320.210, and 28A.320.220.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 7 NEW SECTION. Sec. 1. RCW 28A.150.200 through 28A.150.295 and
- 8 sections 1 through 3, 5, and 14 of this act shall be known and cited as
- 9 the local control of education act.
- 10 <u>NEW SECTION.</u> **Sec. 2.** The public policy purpose of the local
- 11 control of education act is to provide local school district boards of
- 12 directors greater authority to determine the fundamental policies and
- 13 practices related to education, including the authority to structure
- 14 the education program to meet the needs of students as defined by the

- 1 patrons in local communities. In order to accomplish this public
- 2 policy goal it is necessary, within the local control of education act,
- 3 to repeal or amend laws that impede local control of schools.
- 4 Specifically, under the local control of education act, unnecessary
- 5 state control components of the basic education act of 1977 are
- 6 repealed and replaced with basic program of education requirements, as
- 7 specified in RCW 28A.150.220.
- 8 <u>NEW SECTION.</u> **Sec. 3.** The board of directors of each school
- 9 district may exercise the following powers:
- 10 (1) Such powers as expressly authorized by law;
- 11 (2) Such powers as are necessary or fairly implied in powers
- 12 expressly authorized by law; and
- 13 (3) The additional broad discretionary power to determine and adopt
- 14 written policies and rules not in conflict with other law that provide
- 15 for the development and implementation of programs, activities,
- 16 services, or practices that the board determines will:
- 17 (a) Benefit the education, health, or safety of citizens; or
- 18 (b) Promote the effective, efficient, or safe maintenance and
- 19 operation of school district programs, activities, services, or
- 20 practices.
- 21 The adoption of any such policy or rule shall be preceded by notice
- 22 in accordance with the open public meeting law of chapter 42.30 RCW
- 23 which furthermore sets forth or reasonably describes the proposed
- 24 policy or regulation, plus a reasonable opportunity for public written
- 25 and oral comment and consideration of the comment by the board of
- 26 directors.
- 27 **Sec. 4.** RCW 28A.150.200 and 1990 c 33 s 104 are each amended to
- 28 read as follows:

- 1 ((This 1977 amendatory act shall be known and may be cited as "The
- 2 Washington Basic Education Act of 1977. The program evolving from the
- 3 Basic Education Act shall include (1) the goal of the school system as
- 4 defined in RCW 28A.150.210, (2) those program requirements enumerated
- 5 in RCW 28A.150.220, and (3) the determination and distribution of state
- 6 resources as defined in RCW 28A.150.250 and 28A.150.260.))
- 7 The requirements of the ((Basic Education Act)) local control of
- 8 education act are deemed by the legislature to comply with the
- 9 requirements of Article IX, section 1 of the state Constitution, which
- 10 states that "It is the paramount duty of the state to make ample
- 11 provision for the education of all children residing within its
- 12 borders, without distinction or preference on account of race, color,
- 13 caste, or sex," and are adopted pursuant to Article IX, section 2 of
- 14 the state Constitution, which states that "The legislature shall
- 15 provide for a general and uniform system of public schools."
- 16 <u>NEW SECTION.</u> **Sec. 5.** Unless the context clearly requires
- 17 otherwise, the definitions in the section shall apply throughout RCW
- 18 28A.150.200 through 28A.150.295 and sections 1 through 3 and 14 of this
- 19 act.
- 20 (1) "Instructional hours" means those hours students are provided
- 21 the opportunity to engage in educational activity planned by and under
- 22 the direction of school district staff, as directed by the
- 23 administration and board of directors of the district, inclusive of
- 24 intermissions for class changes, recess, and teacher/parent-guardian
- 25 conferences that are planned and scheduled by the district for the
- 26 purpose of discussing students' educational needs or progress, and
- 27 exclusive of time actually spent for meals.
- 28 (2) "Instruction in work force skills" means applied learning that
- 29 strengthens and reinforces an individual's academic knowledge, critical

- 1 thinking, problem-solving skills, and work ethics, and thereby develops
- 2 employability, occupational skills, and the ability to manage home and
- 3 work responsibilities necessary for economic independence. Such
- 4 instruction shall include but is not limited to technology education/
- 5 industrial arts, home and family life education, business education,
- 6 marketing education, agricultural education, health occupations
- 7 education, trade and industrial education, and technical education.
- 8 Sec. 6. RCW 28A.150.220 and 1990 c 33 s 105 are each amended to
- 9 read as follows:
- 10 (1) ((For the purposes of this section and RCW 28A.150.250 and
- 11 28A.150.260:
- 12 (a) The term "total program hour offering" shall mean those hours
- 13 when students are provided the opportunity to engage in educational
- 14 activity planned by and under the direction of school district staff,
- 15 as directed by the administration and board of directors of the
- 16 district, inclusive of intermissions for class changes, recess and
- 17 teacher/parent-guardian conferences which are planned and scheduled by
- 18 the district for the purpose of discussing students' educational needs
- 19 or progress, and exclusive of time actually spent for meals.
- 20 (b) "Instruction in work skills" shall include instruction in one
- 21 or more of the following areas: Industrial arts, home and family life
- 22 education, business and office education, distributive education,
- 23 agricultural education, health occupations education, vocational
- 24 education, trade and industrial education, technical education and
- 25 career education.
- 26 (2))) The basic program of education provided by the state, in
- 27 conformance with Article IX, section 1 of the state Constitution, shall
- 28 <u>consist of the following:</u>

- 1 (a) The basic education allowance to school districts as provided
- 2 <u>in RCW 28A.150.100, 28A.150.250, 28A.150.260, and 28A.150.410;</u>
- 3 (b) The appropriation for handicapped programs as provided in RCW
- 4 28A.150.390 and the requirements related therein within chapter 28A.155
- 5 RCW;
- 6 (c) The part-time student enrollment as provided in RCW
- 7 <u>28A.150.350;</u>
- 8 (d) The student transportation allocations as provided in RCW
- 9 <u>28A.160.150</u>, <u>28A.160.160</u>, <u>28A.160.180</u>, <u>28A.160.190</u>, and <u>28A.160.200</u>;
- 10 (e) The learning assistance program as provided in chapter 28A.165
- 11 <u>RCW;</u>
- 12 <u>(f) The transitional bilingual instructional program as provided in</u>
- 13 <u>chapter 28A.180 RCW;</u>
- 14 (q) A program of education in school districts with high schools of
- 15 sufficient size, scope, and quality to permit students enrolled therein
- 16 to meet graduation requirements established by law or rule of the state
- 17 board of education;
- 18 (h) Satisfaction of the basic education ((goal)) program
- 19 requirements identified in ((RCW 28A.150.210)) section 2 of this 1991
- 20 <u>act</u> shall be considered to be implemented by the following program
- 21 ((requirements)):
- 22 $((\frac{a}{a}))$ (i) Each school district shall make available to all
- 23 students <u>enrolled</u> in kindergarten at least a total ((program))
- 24 <u>instructional</u> offering of four hundred fifty hours. The program shall
- 25 include <u>instruction in</u> reading, arithmetic, <u>and</u> language skills ((and
- 26 such other subjects and such activities as the school district shall
- 27 determine to be appropriate for the education of the school district's
- 28 students enrolled in such program));
- 29 (((b))) (ii) Each school district shall make available to students
- 30 <u>enrolled</u> in grades one through ((three)) twelve, at least a <u>district</u>-

The remaining ten percent of the total program hour 1 offerings may include such subjects and activities as the school 2 3 district shall determine to be appropriate for the education of the 4 school district's students in such grades; (d) Each school district shall make available to students in grades 5 6 seven through eight, at least a total program hour offering of one thousand nine hundred eighty hours. A minimum of eighty-five percent 7 of the total program hour offerings shall be in the basic skills areas 8 9 of reading/language arts (which may include foreign languages), 10 mathematics, social studies, science, music, art, health and physical 11 education. A minimum of ten percent of the total program hour offerings shall be in the area of work skills. The remaining five 12 13 percent of the total program hour offerings may include such subjects 14 and activities as the school district shall determine to be appropriate for the education of the school district's students in such grades; 15 (e) Each school district shall make available to students in grades 16 17 nine through twelve at least a total program hour offering of four 18 thousand three hundred twenty hours. A minimum of sixty percent of the 19 total program hour offerings shall be in the basic skills areas of 20 language arts, foreign language, mathematics, social studies, science, music, art, health and physical education. A minimum of twenty percent 21 22 of the total program hour offerings shall be in the area of work

thousand three hundred twenty hours. A minimum of sixty percent of the total program hour offerings shall be in the basic skills areas of language arts, foreign language, mathematics, social studies, science, music, art, health and physical education. A minimum of twenty percent of the total program hour offerings shall be in the area of work skills. - 4 (3) In order to provide flexibility to the local school districts
- 5 in the setting of their curricula, and in order to maintain the intent
- 6 of this legislation, which is to stress the instruction of basic skills
- 7 and work skills, any local school district may establish minimum course
- 8 mix percentages that deviate by up to five percentage points above or
- 9 below those minimums required by subsection (2) of this section, so
- 10 long as the total program hour requirement is still met.
- 11 $\frac{(4)}{(2)}$ Nothing contained in subsection $((\frac{(2)}{(2)}))$ $\frac{(1)(h)}{(1)}$ of this

- 15 $((\frac{5}{1}))$ (3) Each school district's kindergarten through twelfth

- 19 eighty school days per school year in such grades as are conducted by

- (((6))) The state board of education shall adopt rules to 1 2 implement and ensure compliance with the program requirements imposed by this section, RCW 28A.150.250 and 28A.150.260, and such related 3 4 supplemental program approval requirements as the state board may 5 establish((: PROVIDED, That each school district board of directors 6 shall establish the basis and means for determining and monitoring the district's compliance with the basic skills and work skills percentage 7 and course requirements of this section. The certification of the 8 9 board of directors and the superintendent of a school district that the 10 district is in compliance with such basic skills and work skills 11 requirements may be accepted by the superintendent of public instruction and the state board of education. 12
- (7) Handicapped education programs, vocational-technical institute
 programs, state institution and state residential school programs, all
 of which programs are conducted for the common school age, kindergarten
 through secondary school program students encompassed by this section,
 shall be exempt from the basic skills and work skills percentage and
 course requirements of this section in order that the unique needs,
 abilities or limitations of such students may be met.
 - (8) Any school district may petition the state board of education for a reduction in the total program hour offering requirements for one or more of the grade level groupings specified in this section. The state board of education shall grant all such petitions that are accompanied by an assurance that the minimum total program hour offering requirements in one or more other grade level groupings will be exceeded concurrently by no less than the number of hours of the reduction)).

28 **Sec. 7.** RCW 28A.150.230 and 1990 c 33 s 106 are each amended to 29 read as follows:

- 1 (1) It is the intent and purpose of this section to guarantee that
- 2 each common school district board of directors, whether or not acting
- 3 through its respective administrative staff, be held accountable for
- 4 the proper operation of their district to the local community and its
- 5 electorate. In accordance with the provisions of Title 28A RCW, as now
- 6 or hereafter amended, each common school district board of directors
- 7 shall be vested with the final responsibility for the setting of
- 8 policies ensuring quality in the content and extent of its educational
- 9 program and that such program provide students with the opportunity to
- 10 achieve those skills which are generally recognized as requisite to
- 11 learning.
- 12 (2) In conformance with the provisions of Title 28A RCW, as now or
- 13 hereafter amended, it shall be the responsibility of each common school
- 14 district board of directors, acting through its respective
- 15 administrative staff, to:
- 16 (a) Establish programs, pursuant to RCW 28A.230.130, for students
- 17 whose educational plans include application for entrance to a
- 18 baccalaureate degree-granting institution after being granted a high
- 19 school diploma. In addition, programs shall be established, directly
- 20 or otherwise, that prepare students for employment or further technical
- 21 training after being granted a high school diploma;
- 22 <u>(b) Establish policies and procedures that provide for the results</u>
- 23 of the Washington state high school and beyond assessment program to be
- 24 used to assist each student to plan and prepare for high school and
- 25 posthigh school career steps;
- 26 (c) Establish performance criteria and an evaluation process for
- 27 its certificated personnel, including administrative staff, and for all
- 28 programs constituting a part of such district's curriculum;
- 29 $((\frac{b}{b}))$ (d) Determine the final assignment of staff, certificated
- 30 or classified, according to board enumerated classroom and program

- 1 needs. Persons employed by such a district in positions requiring
- 2 certification shall possess the appropriate, current, and valid
- 3 certificate;
- 4 (((c))) <u>(e)</u> Determine the amount of instructional hours necessary
- 5 for any student to acquire a quality education in such district, in not
- 6 less than an amount otherwise required in RCW 28A.150.220, or rules and
- 7 regulations of the state board of education;
- 8 $((\frac{d}{d}))$ (f) Determine the allocation of staff time, whether
- 9 certificated or classified;
- 10 $((\frac{e}{e}))$ (g) Establish final curriculum standards consistent with
- 11 law and rules and regulations of the state board of education, relevant
- 12 to the particular needs of district students or the unusual
- 13 characteristics of the district, and ensuring a quality education for
- 14 each student in the district; and
- 15 $((\frac{f}{f}))$ (h) Evaluate teaching materials, including text books,
- 16 teaching aids, handouts, or other printed material, in public hearing
- 17 upon complaint by parents, guardians or custodians of students who
- 18 consider dissemination of such material to students objectionable.
- 19 (3) In keeping with the accountability purpose expressed in this
- 20 section and to insure that the local community and electorate have
- 21 access to information on the educational programs in the school
- 22 districts, each school district's board of directors shall ensure
- 23 compliance with the provisions of the self-study process as required by
- 24 RCW 28A.320.200. The school district board of directors shall also
- 25 annually publish a descriptive guide to the district's common schools
- 26 pursuant to rules that may be developed by the state board of
- 27 education. This guide shall be made available at each school in the
- 28 district for examination by the public. ((The guide shall include, but
- 29 not be limited to, the following:

- 1 (a) Criteria used for written evaluations of staff members pursuant
- 2 to RCW 28A.405.100;

- 14 instructional support, building and central administration, and support
- 15 services, including itemization of such personnel by program;
- 16 (iv) Total number of full time equivalent personnel itemized by
- 17 classroom teachers, instructional support, building and central
- 18 administration, and support services, including itemization of such
- 19 personnel by program; and
- 20 (v) Special levy budget request presented by program and
- 21 expenditure for purposes over and above those requirements identified
- 22 in RCW 28A.150.220.))
- 23 Sec. 8. RCW 28A.150.260 and 1990 c 33 s 108 are each amended to
- 24 read as follows:
- 25 The basic education allocation for each annual average full time
- 26 equivalent student shall be determined in accordance with the following
- 27 procedures:
- 28 (1) The governor shall and the superintendent of public instruction
- 29 may recommend to the legislature a formula based on a ratio of students

- 1 to staff for the distribution of a basic education allocation for each
- 2 annual average full time equivalent student enrolled in a common
- 3 school. The distribution formula shall have the primary objective of
- 4 equalizing educational opportunities and shall provide appropriate
- 5 recognition of the following costs among the various districts within
- 6 the state:
- 7 (a) Certificated instructional staff and their related costs;
- 8 (b) Certificated administrative staff and their related costs;
- 9 (c) Classified staff and their related costs;
- 10 (d) Nonsalary costs;
- 11 (e) Extraordinary costs of remote and necessary schools and small
- 12 high schools, including costs of additional certificated and classified
- 13 staff; and
- 14 (f) The attendance of students pursuant to RCW 28A.335.160 and
- 15 28A.225.250 who do not reside within the servicing school district.
- 16 (2)(a) This formula for distribution of basic education funds shall
- 17 be reviewed biennially by the superintendent and governor. The
- 18 recommended formula shall be subject to approval, amendment or
- 19 rejection by the legislature. The formula shall be for allocation
- 20 purposes only. While the legislature intends that the allocations for
- 21 additional instructional staff be used to increase the ratio of such
- 22 staff to students, nothing in this section shall require districts to
- 23 reduce the number of administrative staff below existing levels.
- 24 (b) The formula adopted by the legislature for the 1987-88 school
- 25 year shall reflect the following ratios at a minimum: (i) Forty-eight
- 26 certificated instructional staff to one thousand annual average full
- 27 time equivalent students enrolled in grades kindergarten through three;
- 28 (ii) forty-six certificated instructional staff to one thousand annual
- 29 average full time equivalent students enrolled in grades four through
- 30 twelve; (iii) four certificated administrative staff to one thousand

- 1 annual average full time equivalent students enrolled in grades
- 2 kindergarten through twelve; and (iv) sixteen and sixty-seven
- 3 one-hundredths classified personnel to one thousand annual average full
- 4 time equivalent students enrolled in grades kindergarten through
- 5 twelve.
- 6 (c) Commencing with the 1988-89 school year, the formula adopted by
- 7 the legislature shall reflect the following ratios at a minimum: (i)
- 8 Forty-nine certificated instructional staff to one thousand annual
- 9 average full time equivalent students enrolled in grades kindergarten
- 10 through three; (ii) forty-six certificated instructional staff to one
- 11 thousand annual average full time equivalent students in grades four
- 12 through twelve; (iii) four certificated administrative staff to one
- 13 thousand annual average full time equivalent students in grades
- 14 kindergarten through twelve; and (iv) sixteen and sixty-seven
- one-hundredths classified personnel to one thousand annual average full
- 16 time equivalent students enrolled in grades kindergarten through
- 17 twelve.
- 18 (d) In the event the legislature rejects the distribution formula
- 19 recommended by the governor, without adopting a new distribution
- 20 formula, the distribution formula for the previous school year shall
- 21 remain in effect: PROVIDED, That the distribution formula developed
- 22 pursuant to this section shall be for state apportionment and
- 23 equalization purposes only and shall not be construed as mandating
- 24 specific operational functions of local school districts other than
- 25 those program requirements identified in RCW 28A.150.220 and
- 26 28A.150.100. The enrollment of any district shall be the annual
- 27 average number of full time equivalent students and part time students
- 28 as provided in RCW 28A.150.350, enrolled on the first school day of
- 29 each month and shall exclude full time equivalent handicapped students
- 30 recognized for the purposes of allocation of state funds for programs

- 1 under RCW 28A.155.010 through 28A.155.100. The definition of full time
- 2 equivalent student shall be determined by rules and regulations of the
- 3 superintendent of public instruction: PROVIDED, That the definition
- 4 shall be included as part of the superintendent's biennial budget
- 5 request: PROVIDED, FURTHER, That any revision of the present
- 6 definition shall not take effect until approved by the house
- 7 appropriations committee and the senate ways and means committee:
- 8 PROVIDED, FURTHER, That the office of financial management shall make
- 9 a monthly review of the superintendent's reported full time equivalent
- 10 students in the common schools in conjunction with RCW 43.62.050.
- 11 (3)(a) Certificated instructional staff shall include those persons
- 12 employed by a school district who are nonsupervisory employees within
- 13 the meaning of RCW 41.59.020(8): PROVIDED, That in exceptional cases,
- 14 people of unusual competence but without certification may teach
- 15 students so long as a certificated person exercises general
- 16 supervision: PROVIDED, FURTHER, That the hiring of such
- 17 noncertificated people shall not occur during a labor dispute and such
- 18 noncertificated people shall not be hired to replace certificated
- 19 employees during a labor dispute.
- 20 (b) Certificated administrative staff shall include all those
- 21 persons who are chief executive officers, chief administrative
- 22 officers, confidential employees, supervisors, principals, or assistant
- 23 principals within the meaning of RCW 41.59.020(4).
- 24 ((4) Each annual average full time equivalent certificated
- 25 classroom teacher's direct classroom contact hours shall average at
- 26 least twenty five hours per week. Direct classroom contact hours shall
- 27 be exclusive of time required to be spent for preparation, conferences,
- 28 or any other nonclassroom instruction duties. Up to two hundred
- 29 minutes per week may be deducted from the twenty-five contact hour
- 30 requirement, at the discretion of the school district board of

- directors, to accommodate authorized teacher/parent-guardian 1 2 conferences, recess, passing time between classes, and informal 3 instructional activity. Implementing rules to be adopted by the state 4 board of education pursuant to RCW 28A.150.220(6) shall provide that compliance with the direct contact hour requirement shall be based upon 5 6 teachers' normally assigned weekly instructional schedules, as assigned by the district administration. Additional record-keeping by classroom 7 8 teachers as a means of accounting for contact hours shall not be 9 required. However, upon request from the board of directors of any 10 school district, the provisions relating to direct classroom contact 11 hours for individual teachers in that district may be waived by the state board of education if the waiver is necessary to implement a 12 13 locally approved plan for educational excellence and the waiver is 14 limited to those individual teachers approved in the local plan for 15 educational excellence.
