- 1 AN ACT Relating to chiropractic; amending RCW 18.25.005 and
- 2 18.25.006; and declaring an emergency.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 18.25.005 and 1974 ex.s. c 97 s 7 are each amended to
- 5 read as follows:
- 6 ((For the purpose of chapters 18.25 and 18.26 RCW, the term
- 7 "chiropractic" shall mean and include that practice of health care
- 8 which deals with the detection of subluxations, which shall be defined
- 9 as any alteration of the biomechanical and physiological dynamics of
- 10 contiguous spinal structures which can cause neuronal disturbances, the
- 11 chiropractic procedure preparatory to, and complementary to the
- 12 correction thereof, by adjustment or manipulation of the articulations
- 13 of the vertebral column and its immediate articulations for the
- 14 restoration and maintenance of health; it includes the normal regimen

- 1 and rehabilitation of the patient, physical examination to determine
- 2 the necessity for chiropractic care, the use of x-ray and other
- 3 analytical instruments generally used in the practice of chiropractic:
- 4 PROVIDED, That no chiropractor shall prescribe or dispense any medicine
- 5 or drug nor practice obstetrics or surgery nor use x-rays for
- 6 therapeutic purposes: PROVIDED, HOWEVER, That the term "chiropractic"
- 7 as defined in this act shall not prohibit a practitioner licensed under
- 8 chapter 18.71 RCW from performing accepted medical procedures, except
- 9 such procedures shall not include the adjustment by hand of any
- 10 articulation of the spine: AND PROVIDED FURTHER, That nothing herein
- 11 shall be construed to prohibit the rendering of dietary advice.))
- 12 (1) Chiropractic is the practice of health care that deals with the
- 13 <u>diagnosis or analysis and care or treatment of the vertebral</u>
- 14 subluxation complex and its effects, articular dysfunction, and
- 15 musculoskeletal disorders, all for the restoration and maintenance of
- 16 health and recognizing the recuperative powers of the body.
- 17 (2) Chiropractic treatment or care includes the use of procedures
- 18 involving spinal adjustments, extremity manipulation, heat, cold,
- 19 water, exercise, massage, trigger point therapy, dietary advice and
- 20 recommendation of nutritional supplementation, the normal regimen and
- 21 rehabilitation of the patient, first aid, and counseling on hygiene,
- 22 <u>sanitation</u>, and preventive measures. Chiropractic care also includes
- 23 such physiological therapeutic procedures as traction and light, but
- 24 does not include procedures involving the application of sound,
- 25 <u>diathermy</u>, or electricity.
- 26 (3) As part of a chiropractic differential diagnosis, a
- 27 chiropractor shall perform a physical examination, which may include
- 28 <u>diagnostic x-rays</u>, to determine the appropriateness of chiropractic
- 29 care or the need for referral to other health care providers. The
- 30 chiropractic disciplinary board shall provide by rule for the type and

- 1 use of diagnostic and analytical devices and procedures consistent with
- 2 this chapter.
- 3 (4) Chiropractic care shall not include the prescription or
- 4 dispensing of any medicine or drug, the practice of obstetrics or
- 5 surgery, the use of x-rays or any other form of radiation for
- 6 therapeutic purposes, colonic irrigation, or any form of venipuncture.
- 7 (5) Nothing in this chapter prohibits or restricts any other
- 8 practitioner of a "health profession" defined in RCW 18.120.020(4) from
- 9 performing any functions or procedures the practitioner is licensed or
- 10 permitted to perform, and the term "chiropractic" as defined in this
- 11 <u>chapter shall not prohibit a practitioner licensed under chapter 18.71</u>
- 12 RCW from performing medical procedures, except such procedures shall
- 13 not include the adjustment by hand of any articulation of the spine.
- 14 Sec. 2. RCW 18.25.006 and 1991 c 3 s 36 are each amended to read
- 15 as follows:
- 16 Unless the context clearly requires otherwise, the definitions in
- 17 this section apply throughout this chapter.
- 18 (1) "Department" means the department of health.
- 19 (2) "Secretary" means the secretary of the department of health or
- 20 the secretary's designee.
- 21 (3) "Chiropractor" means an individual licensed under this chapter.
- 22 (4) "Board" means the Washington state board of chiropractic
- 23 examiners.
- 24 (5) "Vertebral subluxation complex" means a functional defect or
- 25 alteration of the biomechanical and physiological dynamics in a joint
- 26 that may cause neuronal disturbances, with or without displacement
- 27 <u>detectable by x-ray</u>. The effects of the vertebral subluxation complex
- 28 may include, but are not limited to, any of the following: Fixation,

- 1 hypomobility, hypermobility, periarticular muscle spasm, edema, or
- 2 inflammation.
- 3 (6) "Articular dysfunction" means an alteration of the
- 4 biomechanical and physiological dynamics of a joint of the axial or
- 5 <u>appendicular skeleton</u>.
- 6 (7) "Musculoskeletal disorders" means abnormalities of the muscles,
- 7 bones, and connective tissue.
- 8 (8) "Chiropractic differential diagnosis" means a diagnosis to
- 9 determine the existence of a vertebral subluxation complex, articular
- 10 dysfunction, or musculoskeletal disorder, and the appropriateness of
- 11 chiropractic care or the need for referral to other health care
- 12 providers.
- 13 (9) "Chiropractic adjustment" means chiropractic care of a
- 14 <u>vertebral</u> <u>subluxation</u> <u>complex</u>, <u>articular</u> <u>dysfunction</u>, <u>or</u>
- 15 musculoskeletal disorder. Such care includes manual or mechanical
- 16 <u>adjustment of any vertebral articulation and contiguous articulations</u>
- 17 beyond the normal passive physiological range of motion.
- 18 (10) "Extremity manipulation" means a corrective thrust or maneuver
- 19 applied to a joint of the appendicular skeleton. The use of extremity
- 20 manipulation is complementary and preparatory to a chiropractic spinal
- 21 adjustment to support correction of a vertebral subluxation complex.
- 22 <u>NEW SECTION.</u> **Sec. 3.** This act is necessary for the immediate
- 23 preservation of the public peace, health, or safety, or support of the
- 24 state government and its existing public institutions, and shall take
- 25 effect immediately.
