- 1 AN ACT Relating to structural pest control inspectors; and amending
- 2 RCW 15.58.030, 15.58.040, 15.58.150, and 15.58.210.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 Sec. 1. RCW 15.58.030 and 1989 c 380 s 1 are each amended to read
- 5 as follows:
- 6 As used in this chapter the words and phrases defined in this
- 7 section shall have the meanings indicated unless the context clearly
- 8 requires otherwise.
- 9 (1) "Active ingredient" means any ingredient which will prevent,
- 10 destroy, repel, control, or mitigate pests, or which will act as a
- 11 plant regulator, defoliant, desiccant, or spray adjuvant.
- 12 (2) "Antidote" means the most practical immediate treatment in case
- 13 of poisoning and includes first aid treatment.
- 14 (3) "Arthropod" means any invertebrate animal that belongs to the
- 15 phylum arthropoda, which in addition to insects, includes allied

- 1 classes whose members are wingless and usually have more than six legs;
- 2 for example, spiders, mites, ticks, centipedes, and isopod crustaceans.
- 3 (4) "Defoliant" means any substance or mixture of substances
- 4 intended to cause the leaves or foliage to drop from a plant with or
- 5 without causing abscission.
- 6 (5) "Department" means the Washington state department of
- 7 agriculture.
- 8 (6) "Desiccant" means any substance or mixture of substances
- 9 intended to artificially accelerate the drying of plant tissues.
- 10 (7) "Device" means any instrument or contrivance intended to trap,
- 11 destroy, control, repel, or mitigate pests, or to destroy, control,
- 12 repel or mitigate fungi, nematodes, or such other pests, as may be
- 13 designated by the director, but not including equipment used for the
- 14 application of pesticides when sold separately from the pesticides.
- 15 (8) "Director" means the director of the department or a duly
- 16 authorized representative.
- 17 (9) "Distribute" means to offer for sale, hold for sale, sell,
- 18 barter, or supply pesticides in this state.
- 19 (10) "EPA" means the United States environmental protection agency.
- 20 (11) "EPA restricted use pesticide" means any pesticide with
- 21 restricted uses as classified for restricted use by the administrator,
- 22 EPA.
- 23 (12) "FIFRA" means the federal insecticide, fungicide, and
- 24 rodenticide act as amended (61 Stat. 163, 7 U.S.C. Sec. 136 et seq.).
- 25 (13) "Fungi" means all nonchlorophyll-bearing thallophytes (all
- 26 nonchlorophyll-bearing plants of a lower order than mosses and
- 27 liverworts); for example, rusts, smuts, mildews, molds, yeasts, and
- 28 bacteria, except those on or in living persons or other animals.
- 29 (14) "Fungicide" means any substance or mixture of substances
- 30 intended to prevent, destroy, repel, or mitigate any fungi.

- 1 (15) "Herbicide" means any substance or mixture of substances
- 2 intended to prevent, destroy, repel, or mitigate any weed.
- 3 (16) "Inert ingredient" means an ingredient which is not an active
- 4 ingredient.
- 5 (17) "Ingredient statement" means a statement of the name and
- 6 percentage of each active ingredient together with the total percentage
- 7 of the inert ingredients in the pesticide, and when the pesticide
- 8 contains arsenic in any form, the ingredient statement shall also
- 9 include percentages of total and water soluble arsenic, each calculated
- 10 as elemental arsenic. In the case of a spray adjuvant the ingredient
- 11 statement need contain only the names of the principal functioning
- 12 agents and the total percentage of the constituents ineffective as
- 13 spray adjuvants. If more than three functioning agents are present,
- 14 only the three principal ones need by named.
- 15 (18) "Insect" means any of the numerous small invertebrate animals
- 16 whose bodies are more or less obviously segmented, and which for the
- 17 most part belong to the class insecta, comprising six-legged, usually
- 18 winged forms, for example, beetles, bugs, bees, flies, and to other
- 19 allied classes of arthropods whose members are wingless and usually
- 20 have more than six legs, for example, spiders, mites, ticks,
- 21 centipedes, and isopod crustaceans.
- 22 (19) "Insecticide" means any substance or mixture of substances
- 23 intended to prevent, destroy, repel, or mitigate any insects which may
- 24 be present in any environment whatsoever.
- 25 (20) "Label" means the written, printed, or graphic matter on, or
- 26 attached to, the pesticide, device, or immediate container, and the
- 27 outside container or wrapper of the retail package.
- 28 (21) "Labeling" means all labels and other written, printed, or
- 29 graphic matter:

- 1 (a) Upon the pesticide, device, or any of its containers or 2 wrappers;
- 3 (b) Accompanying the pesticide, or referring to it in any other
- 4 media used to disseminate information to the public; and
- 5 (c) To which reference is made on the label or in literature
- 6 accompanying or referring to the pesticide or device except when
- 7 accurate nonmisleading reference is made to current official
- 8 publications of the department, United States departments of
- 9 agriculture; interior; education; health and human services; state
- 10 agricultural colleges; and other similar federal or state institutions
- 11 or agencies authorized by law to conduct research in the field of
- 12 pesticides.
- 13 (22) "Land" means all land and water areas, including airspace and
- 14 all plants, animals, structures, buildings, devices and contrivances,
- 15 appurtenant thereto or situated thereon, fixed or mobile, including any
- 16 used for transportation.
- 17 (23) "Master license system" means the mechanism established by
- 18 chapter 19.02 RCW by which master licenses, endorsed for individual
- 19 state-issued licenses, are issued and renewed using a master
- 20 application and a master license expiration date common to each
- 21 renewable license endorsement.
- 22 (24) "Nematocide" means any substance or mixture of substances
- 23 intended to prevent, destroy, repel, or mitigate nematodes.
- 24 (25) "Nematode" means any invertebrate animal of the phylum
- 25 nemathelminthes and class nematoda, that is, unsegmented round worms
- 26 with elongated, fusiform, or saclike bodies covered with cuticle, and
- 27 inhabiting soil, water, plants or plant parts, may also be called nemas
- 28 or eelworms.
- 29 (26) "Person" means any individual, partnership, association,
- 30 corporation, or organized group of persons whether or not incorporated.

- 1 (27) "Pest" means, but is not limited to, any insect, rodent,
- 2 nematode, snail, slug, weed and any form of plant or animal life or
- 3 virus, except virus on or in a living person or other animal, which is
- 4 normally considered to be a pest or which the director may declare to
- 5 be a pest.
- 6 (28) "Pest control consultant" means any individual who acts as a
- 7 <u>structural pest control inspector</u>, who sells or offers for sale at
- 8 other than a licensed pesticide dealer outlet or location, or who
- 9 offers or supplies technical advice, supervision, or aid, or makes
- 10 recommendations to the user of:
- 11 (a) Highly toxic pesticides, as determined under RCW 15.58.040;
- 12 (b) EPA restricted use pesticides or restricted use pesticides
- 13 which are restricted by rule to distribution by licensed pesticide
- 14 dealers only; or
- 15 (c) Any other pesticide except those pesticides which are labeled
- 16 and intended for home and garden use only.
- 17 (29) "Pesticide" means, but is not limited to:
- 18 (a) Any substance or mixture of substances intended to prevent,
- 19 destroy, control, repel, or mitigate any insect, rodent, snail, slug,
- 20 fungus, weed, and any other form of plant or animal life or virus,
- 21 except virus on or in a living person or other animal which is normally
- 22 considered to be a pest or which the director may declare to be a pest;
- 23 (b) Any substance or mixture of substances intended to be used as
- 24 a plant regulator, defoliant or desiccant; and
- 25 (c) Any spray adjuvant.
- 26 (30) "Pesticide advisory board" means the pesticide advisory board
- 27 as provided for in the Washington pesticide application act.
- 28 (31) "Pesticide dealer" means any person who distributes any of the
- 29 following pesticides:
- 30 (a) Highly toxic pesticides, as determined under RCW 15.58.040;

- 1 (b) EPA restricted use pesticides or restricted use pesticides
- 2 which are restricted by rule to distribution by licensed pesticide
- 3 dealers only; or
- 4 (c) Any other pesticide except those pesticides which are labeled
- 5 and intended for home and garden use only.
- 6 (32) "Pesticide dealer manager" means the owner or other individual
- 7 supervising pesticide distribution at one outlet holding a pesticide
- 8 dealer license.
- 9 (33) "Plant regulator" means any substance or mixture of substances
- 10 intended through physiological action, to accelerate or retard the rate
- 11 of growth or maturation, or to otherwise alter the behavior of
- 12 ornamental or crop plants or their produce, but shall not include
- 13 substances insofar as they are intended to be used as plant nutrients,
- 14 trace elements, nutritional chemicals, plant inoculants, or soil
- 15 amendments.
- 16 (34) "Registrant" means the person registering any pesticide under
- 17 the provisions of this chapter.
- 18 (35) "Restricted use pesticide" means any pesticide or device
- 19 which, when used as directed or in accordance with a widespread and
- 20 commonly recognized practice, the director determines, subsequent to a
- 21 hearing, requires additional restrictions for that use to prevent
- 22 unreasonable adverse effects on the environment including people,
- 23 lands, beneficial insects, animals, crops, and wildlife, other than
- 24 pests.
- 25 (36) "Rodenticide" means any substance or mixture of substances
- 26 intended to prevent, destroy, repel, or mitigate rodents, or any other
- 27 vertebrate animal which the director may declare by rule to be a pest.
- 28 (37) "Spray adjuvant" means any wetting agent, spreading agent,
- 29 deposit builder, adhesive, emulsifying agent, deflocculating agent,
- 30 water modifier, or similar agent with or without toxic properties of

- 1 its own, intended to be used with any other pesticide as an aid to the
- 2 application or to the effect of the pesticide, and which is in a
- 3 package or container separate from that of the pesticide with which it
- 4 is to be used.
- 5 (38) "Special local needs registration" means a registration issued
- 6 by the director pursuant to provisions of section 24(c) of FIFRA.
- 7 (39) <u>Structural pest control inspector" means any individual who</u>
- 8 commercially performs the service of inspecting a building for the
- 9 presence of pests destructive to its structural components.
- 10 (40) "Unreasonable adverse effects on the environment" means any
- 11 unreasonable risk to people or the environment taking into account the
- 12 economic, social, and environmental costs and benefits of the use of
- 13 any pesticide, or as otherwise determined by the director.
- (((40))) (41) "Weed" means any plant which grows where not wanted.
- 15 **Sec. 2.** RCW 15.58.040 and 1989 c 380 s 2 are each amended to read
- 16 as follows:
- 17 (1) The director shall administer and enforce the provisions of
- 18 this chapter and rules adopted under this chapter. All the authority
- 19 and requirements provided for in chapter 34.05 RCW (Administrative
- 20 Procedure Act) and chapter 42.30 RCW shall apply to this chapter in the
- 21 adoption of rules including those requiring due notice and a hearing
- 22 for the adoption of permanent rules.
- 23 (2) The director is authorized to adopt appropriate rules for
- 24 carrying out the purpose and provisions of this chapter, including but
- 25 not limited to rules providing for:
- 26 (a) Declaring as a pest any form of plant or animal life or virus
- 27 which is injurious to plants, people, animals (domestic or otherwise),
- 28 land, articles, or substances;

- 1 (b) Determining that certain pesticides are highly toxic to people.
- 2 For the purpose of this chapter, highly toxic pesticide means any
- 3 pesticide that conforms to the criteria in 40 C.F.R. Sec. 162.10 for
- 4 toxicity category I due to oral inhalation or dermal toxicity. The
- 5 director shall publish a list of all pesticides, determined to be
- 6 highly toxic, by their common or generic name and their trade or brand
- 7 name if practical. Such list shall be kept current and shall, upon
- 8 request, be made available to any interested party;
- 9 (c) Determining standards for denaturing pesticides by color,
- 10 taste, odor, or form;
- 11 (d) The collection and examination of samples of pesticides or
- 12 devices;
- 13 (e) The safe handling, transportation, storage, display,
- 14 distribution, and disposal of pesticides and their containers;
- 15 (f) Restricting or prohibiting the use of certain types of
- 16 containers or packages for specific pesticides. These restrictions may
- 17 apply to type of construction, strength, and/or size to alleviate
- 18 danger of spillage, breakage, misuse, or any other hazard to the
- 19 public. The director shall be guided by federal regulations concerning
- 20 pesticide containers;
- 21 (g) Procedures in making of pesticide recommendations;
- 22 (h) Adopting a list of restricted use pesticides for the state or
- 23 for designated areas within the state if the director determines that
- 24 such pesticides may require rules restricting or prohibiting their
- 25 distribution or use. The director may include in the rule the time and
- 26 conditions of distribution or use of such restricted use pesticides and
- 27 may, if it is found necessary to carry out the purpose and provisions
- 28 of this chapter, require that any or all restricted use pesticides
- 29 shall be purchased, possessed, or used only under permit of the
- 30 director and under the director's direct supervision in certain areas

- 1 and/or under certain conditions or in certain quantities or
- 2 concentrations. The director may require all persons issued such
- 3 permits to maintain records as to the use of all the restricted use
- 4 pesticides;
- 5 (i) Label requirements of all pesticides required to be registered
- 6 under provisions of this chapter; ((and))
- 7 (j) Regulating the labeling of devices; and
- 8 (k) The establishment of criteria governing the conduct of a
- 9 structural pest control inspection.
- 10 (3) For the purpose of uniformity and to avoid confusion
- 11 endangering the public health and welfare the director may adopt rules
- 12 in conformity with the primary pesticide standards, particularly as to
- 13 labeling, established by the United States environmental protection
- 14 agency or any other federal agency.
- 15 **Sec. 3.** RCW 15.58.150 and 1989 c 380 s 11 are each amended to read
- 16 as follows:
- 17 (1) It is unlawful for any person to distribute within the state or
- 18 deliver for transportation or transport in intrastate commerce or
- 19 between points within this state through any point outside this state
- 20 any of the following:
- 21 (a) Any pesticide which has not been registered pursuant to the
- 22 provisions of this chapter;
- 23 (b) Any pesticide if any of the claims made for it or any of the
- 24 directions for its use or other labeling differs from the
- 25 representations made in connection with its registration, or if the
- 26 composition of a pesticide differs from its composition as represented
- 27 in connection with its registration: PROVIDED, That at the discretion
- 28 of the director, a change in the labeling or formula of a pesticide may

- 1 be made within a registration period without requiring reregistration
- 2 of the product;
- 3 (c) Any pesticide unless it is in the registrant's or the
- 4 manufacturer's unbroken immediate container and there is affixed to
- 5 such container, and to the outside container or wrapper of the retail
- 6 package, if there is one through which the required information on the
- 7 immediate container cannot be clearly read, a label bearing the
- 8 information required in this chapter and the rules adopted under this
- 9 chapter;
- 10 (d) Any pesticide including arsenicals, fluorides, fluosilicates,
- 11 and/or any other white powdered pesticides unless they have been
- 12 distinctly denatured as to color, taste, odor, or form if so required
- 13 by rule;
- 14 (e) Any pesticide which is adulterated or misbranded, or any device
- 15 which is misbranded;
- 16 (f) Any pesticide in containers, violating rules adopted pursuant
- 17 to RCW 15.58.040(2)(f) or pesticides found in containers which are
- 18 unsafe due to damage.
- 19 (2) It shall be unlawful:
- 20 (a) To sell or deliver any pesticide to any person who is required
- 21 by law or rules promulgated under such law to be certified, licensed,
- 22 or have a permit to use or purchase the pesticide unless such person or
- 23 the person's agent, to whom sale or delivery is made, has a valid
- 24 certification, license, or permit to use or purchase the kind and
- 25 quantity of such pesticide sold or delivered: PROVIDED, That, subject
- 26 to conditions established by the director, such permit may be obtained
- 27 immediately prior to sale or delivery from any person designated by the
- 28 director;
- 29 (b) For any person to detach, alter, deface or destroy, wholly or
- 30 in part, any label or labeling provided for in this chapter or rules

- 1 adopted under this chapter, or to add any substance to, or take any
- 2 substance from, a pesticide in a manner that may defeat the purpose of
- 3 this chapter or the rules adopted thereunder;
- 4 (c) For any person to use or cause to be used any pesticide
- 5 contrary to label directions or to regulations of the director if those
- 6 regulations differ from or further restrict the label directions:
- 7 PROVIDED, The compliance to the term "contrary to label directions" is
- 8 enforced by the director consistent with the intent of this chapter;
- 9 (d) For any person to use for his or her own advantage or to
- 10 reveal, other than to the director or proper officials or employees of
- 11 the state, or to the courts of the state in response to a subpoena, or
- 12 to physicians, or in emergencies to pharmacists and other qualified
- 13 persons for use in the preparation of antidotes, any information
- 14 relative to formulas of products acquired by authority of RCW
- 15 15.58.060;
- 16 (e) For any person to make false, misleading, or erroneous
- 17 statements or reports concerning any pest during or after a
- 18 ((structural)) pest inspection or to fail to comply with criteria
- 19 <u>established by rule for structural pest control inspections;</u>
- 20 <u>(f) For any person to make false, misleading, or erroneous</u>
- 21 statements or reports in connection with any pesticide complaint or
- 22 investigation.
- 23 Sec. 4. RCW 15.58.210 and 1989 c 380 s 16 are each amended to read
- 24 as follows:
- 25 Except as provided in subsection (2) of this section, no individual
- 26 may perform services as a pest control consultant without obtaining
- 27 from the director an annual license, which license shall expire on the
- 28 final day of February of each year. No individual may act as a
- 29 structural pest control inspector without first obtaining from the

- 1 director a pest control consultant license in the special category of
- 2 structural pest control inspector. Application for a license shall be
- 3 on a form prescribed by the director and shall be accompanied by a fee
- 4 of thirty dollars.
- 5 (2) The following are exempt from the licensing requirements of
- 6 <u>subsection (1) of this section when acting within the authorities of</u>
- 7 their existing licenses issued under chapter 17.21 RCW: Licensed
- 8 commercial pesticide applicators and operators; licensed private-
- 9 commercial applicators; and licensed demonstration and research
- 10 applicators  $((\dot{\tau}))$ . The following are also exempt from the licensing
- 11 requirements of subsection (1) of this section: Employees of federal,
- 12 state, county, or municipal agencies when acting in their official
- 13 governmental capacities; and pesticide dealer managers and employees
- 14 working under the direct supervision of the pesticide dealer manager
- 15 and only at a licensed pesticide dealer's outlet((, are exempt from
- 16 this licensing provision)).
