- AN ACT Relating to acupuncture; amending RCW 18.06.010, 18.06.080,
- 2 and 18.06.120; adding a new section to chapter 18.06 RCW; and repealing
- 3 RCW 18.06.030, 18.06.040, 18.06.910, and 18.06.911.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 18.06.010 and 1991 c 3 s 4 are each amended to read as
- 6 follows:
- 7 The following terms in this chapter shall have the meanings set
- 8 forth in this section unless the context clearly indicates otherwise:
- 9 (1) "Acupuncture" means a health care service based on a
- 10 traditional Oriental system of medical theory utilizing Oriental
- 11 diagnosis and treatment to promote health and treat organic or
- 12 functional disorders by treating specific acupuncture points or
- 13 meridians. Acupuncture includes but is not necessarily limited to the
- 14 following techniques:

- 1 (a) Use of acupuncture needles to stimulate acupuncture points and
- 2 meridians;
- 3 (b) Use of electrical, mechanical, or magnetic devices to stimulate
- 4 acupuncture points and meridians;
- 5 (c) Moxibustion;
- 6 (d) Acupressure;
- 7 (e) Cupping;
- 8 (f) Dermal friction technique (((gwa hsa)));
- 9 (g) Infra-red;
- 10 (h) Sonopuncture;
- 11 (i) Laserpuncture;
- 12 (j) Dietary advice based on traditional ((Chinese)) Oriental
- 13 medical theory; and
- (k) Point injection therapy (aquapuncture).
- 15 (2) "Acupuncturist" means a person certified under this chapter.
- 16 (3) "Department" means the department of health.
- 17 (4) "Secretary" means the secretary of health or the secretary's
- 18 designee.
- 19 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 18.06 RCW
- 20 to read as follows:
- 21 Nothing in this chapter shall be construed to prohibit or restrict:
- 22 (1) The practice licensed, certified, or registered under the laws
- 23 of this state and performing services within such individual's
- 24 authorized scope of practice;
- 25 (2) The practice by an individual employed by the government of the
- 26 United States while engaged in the performance of duties prescribed by
- 27 the laws of the United States;
- 28 (3) The practice by a person who is a regular student in an
- 29 educational program approved by the secretary, and whose performance of

- 1 services is pursuant to a regular course of instruction or assignments
- 2 from an instructor and under the general supervision of the instructor;
- 3 (4) The practice of acupuncture by any person licensed or certified
- 4 to perform acupuncture in any other jurisdiction where such person is
- 5 doing so in the course of regular instruction of a school of
- 6 acupuncture approved by the secretary or in an educational seminar by
- 7 a professional organization of acupuncture, provided that in the latter
- 8 case, the practice is supervised directly by a person certified
- 9 pursuant to this chapter or licensed under any other healing art whose
- 10 scope of practice includes acupuncture.
- 11 **Sec. 3.** RCW 18.06.080 and 1991 c 3 s 10 are each amended to read
- 12 as follows:
- 13 (1) The secretary is hereby authorized and empowered to execute the
- 14 provisions of this chapter and shall offer examinations in acupuncture
- 15 at least twice a year at such times and places as the secretary may
- 16 select. The examination shall be a written examination ((in English))
- 17 and may include a practical examination.
- 18 (2) The secretary shall develop or approve a ((licensure))
- 19 <u>certification</u> examination in the subjects that the secretary determines
- 20 are within the scope of and commensurate with the work performed by
- 21 certified acupuncturists and shall include but not necessarily be
- 22 limited to anatomy, physiology, ((bacteriology)) microbiology,
- 23 biochemistry, pathology, hygiene, and acupuncture. All application
- 24 papers shall be deposited with the secretary and there retained for at
- 25 least one year, when they may be destroyed.
- 26 (3) If the examination is successfully passed, the secretary shall
- 27 confer on such candidate the title of Certified Acupuncturist.

- 1 Sec. 4. RCW 18.06.120 and 1991 c 3 s 12 are each amended to read
- 3 (1) Every person certified in acupuncture shall register with the
- 4 secretary annually and pay an annual renewal registration fee
- 5 determined by the secretary as provided in RCW 43.70.250 on or before
- 6 the certificate holder's birth anniversary date. The certificate of
- 7 the person shall be renewed for a period of one year or longer in the
- 8 discretion of the secretary. A person whose practice is exclusively
- 9 <u>out-of-state or who is on sabbatical shall be granted an inactive</u>
- 10 <u>certification status and pay a reduced registration fee</u>. The reduced
- 11 fee shall be set by the secretary under RCW 43.70.250.
- 12 (2) Any failure to register and pay the annual renewal registration
- 13 fee shall render the certificate invalid. The certificate shall be
- 14 reinstated upon: (a) Written application to the secretary; (b) payment
- 15 to the state of a penalty fee determined by the secretary as provided
- 16 in RCW 43.70.250; and (c) payment to the state of all delinquent annual
- 17 certificate renewal fees.

- 18 (3) Any person who fails to renew his or her certification for a
- 19 period of three years shall not be entitled to renew such certification
- 20 under this section. Such person, in order to obtain a certification in
- 21 acupuncture in this state, shall file a new application under this
- 22 chapter, along with the required fee, and shall meet examination or
- 23 continuing education requirements as the secretary, by rule, provides.
- 24 (4) All fees collected under this section and RCW ((18.06.060))
- 25 <u>18.06.070</u> shall be credited to the health professions account as
- 26 required under RCW 43.70.320.
