1 AN ACT Relating to motor vehicle insurance and safety courses; 2 amending RCW 28A.220.900 and 46.82.420; and adding a new section to 3 chapter 28A.220 RCW.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 Sec. 1. RCW 28A.220.900 and 1969 ex.s. c 218 s 7 are each amended 6 to read as follows:

7 It is the purpose of this act to provide the financial assistance necessary to enable each high school district to offer a course in 8 9 traffic safety education and by that means to develop in the youth of 10 this state a knowledge of the motor vehicle laws, an acceptance of 11 personal responsibility on the public highways, and an understanding of the causes and consequences of traffic accidents, with an emphasis on 12 13 the consequences, both physical and legal, of the use of drugs or 14 alcohol in relation to operating a motor vehicle. The course in 15 traffic safety education shall further provide to the youthful drivers

of this state training in the skills necessary for the safe operation
 of motor vehicles.

3 <u>NEW SECTION.</u> Sec. 2. A new section is added to chapter 28A.220
4 RCW to read as follows:

5 The superintendent of public instruction shall include information 6 on the effects of alcohol and drug use on motor vehicle operators, 7 including information on drug and alcohol related traffic injury and 8 mortality rates in the state of Washington, and current penalties for 9 driving under the influence of drugs or alcohol in instructional 10 material used in traffic safety education courses.

Sec. 3. RCW 46.82.420 and 1979 ex.s. c 51 s 15 are each amended to read as follows:

13 The advisory committee shall compile and furnish to each qualifying applicant for an instructor's license or a driver training school 14 15 license a basic minimum required curriculum. The basic minimum required curriculum shall also include information on the effects of 16 17 alcohol and drug use on motor vehicle operators, including information 18 on drug and alcohol related traffic injury and mortality rates in the 19 state of Washington, and current penalties for driving under the influence of drugs or alcohol. Should the director be presented with 20 acceptable proof that any licensed instructor or driver training school 21 22 is not showing proper diligence in teaching such basic minimum 23 curriculum as required, the instructor or school shall be required to appear before the advisory committee and show cause why the license of 24 the instructor or school should not be revoked for such negligence. If 25 26 the committee does not accept such reasons as may be offered, the 27 director may revoke the license of the instructor or school, or both.
