By House Committee on Higher Education (originally sponsored by Representatives Dorn, Ferguson, Jacobsen, Orr, Grant, Roland, Rasmussen, Winsley, Broback and Rayburn).

Read first time March 6, 1991.

- 1 AN ACT Relating to college and university admission standards;
- 2 creating a new section; and declaring an emergency.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 NEW SECTION. Sec. 1. By May 15, 1991, or as soon as possible
- 5 thereafter, the higher education coordinating board, the state board of
- 6 education, and the superintendent of public instruction shall jointly
- 7 convene a task force to recommend a process for evaluating and
- 8 accepting a student's high school coursework for entrance into a state
- 9 university, regional university, or state college. In selecting or
- 10 adding task force members, the agencies shall consult with the work
- 11 force training and education coordinating board and other appropriate
- 12 organizations. The process shall be designed to accomplish the
- 13 following goals:

- 1 (1) Give college freshmen a reasonable assurance that their high
- 2 school coursework has prepared them to successfully proceed through
- 3 college.
- 4 (2) Recognize the changing nature of high school crediting and
- 5 instruction and award appropriate credit for curriculum and
- 6 competencies learned in a variety of ways, including through
- 7 interdisciplinary classes, equivalency classes, and the academic
- 8 components of vocational and technical classes.
- 9 (3) Recognize and award appropriate credit to measurable student
- 10 competencies.
- 11 (4) Achieve decisions within a reasonable amount of time.
- 12 (5) Under special circumstances, provide for on-site program or
- 13 coursework reviews.
- 14 (6) Provide an appeal process that, under special circumstances,
- 15 may provide an additional review of competencies, coursework, or
- 16 classes.
- 17 By December 20, 1991, the higher education coordinating board and
- 18 the superintendent of public instruction shall report recommendations
- 19 to the governor and the house of representatives and senate higher
- 20 education and education committees. In the event that the two agencies
- 21 are unable to reach agreement on a process, the report may include
- 22 points of agreement and disagreement.
- 23 <u>NEW SECTION.</u> **Sec. 2.** This act is necessary for the immediate
- 24 preservation of the public peace, health, or safety, or support of the
- 25 state government and its existing public institutions, and shall take
- 26 effect immediately.
