- 1 AN ACT Relating to the joint center for higher education; amending
- 2 RCW 28B.10.060, 28B.25.010, 28B.25.020, 28B.25.030, 28B.25.040,
- 3 28B.25.050, and 28B.45.050; adding new sections to chapter 28B.25 RCW;
- 4 repealing RCW 28B.25.060; providing an effective date; and declaring an
- 5 emergency.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 7 **Sec. 1.** RCW 28B.10.060 and 1989 1st ex.s. c 7 s 10 are each
- 8 amended to read as follows:
- 9 (1) The Spokane intercollegiate research and technology institute
- 10 is hereby created.
- 11 (2) The institute shall be operated and administered as a multi-
- 12 institutional education and research center, housing appropriate
- 13 programs conducted in Spokane under the authority of Washington State
- 14 University, Eastern Washington University, and the community colleges
- 15 of Spokane. Gonzaga University and Whitworth College may participate

- 1 as full partners in any academic and research activities of the
- 2 institute. ((Washington State University shall act as administrative
- 3 and fiscal agent for the institute.
- 4 (3) The institute shall be operated and administered through a
- 5 cooperative arrangement of the institutions of higher education
- 6 participating in the institute.
- 7 $\frac{(4)}{(3)}$ The institute shall house education and research programs
- 8 specifically designed to meet the needs of the greater Spokane area.
- 9 (((5))) (4) The coordination of programs and activities at the
- 10 institute shall be subject to the authority of the ((Spokane)) joint
- 11 center for higher education under RCW 28B.25.020. The institute shall
- 12 <u>be administered by the joint center.</u>
- (((6))) The establishment of any education or research programs
- 14 at the institute and the lease, purchase, or construction of any site
- 15 or facility for the institute shall be subject to the approval of the
- 16 higher education coordinating board pursuant to RCW 28B.80.340.
- 17 (6) All cabinets, furniture, office equipment, other tangible
- 18 property acquired by Washington State University for the institute, all
- 19 <u>funds</u>, <u>credits</u>, <u>or other assets held by Washington State University for</u>
- 20 the institute shall be assigned to the joint center for higher
- 21 education.
- 22 **Sec. 2.** RCW 28B.25.010 and 1985 c 370 s 97 are each amended to
- 23 read as follows:
- 24 ((Washington State and Eastern Washington Universities shall
- 25 establish, in cooperation with the council for postsecondary education
- 26 or its successor agency,)) A joint center for higher education is
- 27 <u>hereby established</u>. The center shall be located in Spokane ((on or
- 28 before January 1, 1986)).

- 1 Sec. 3. RCW 28B.25.020 and 1989 1st ex.s. c 7 s 11 are each
- 2 amended to read as follows:
- 3 (1) The joint center shall have authority over all fiscal
- 4 <u>activities related to the land and facilities known as the Spokane</u>
- 5 <u>higher education park subject to the approval of the higher education</u>
- 6 coordinating board pursuant to RCW 28B.80.330 through 28B.80.350.
- 7 (2) The joint center for higher education shall coordinate all
- 8 ((undergraduate)) baccalaureate and graduate degree programs, and all
- 9 other ((seminars,)) courses((,)) and programs ((of any type)) offered
- 10 in the Spokane area by Washington State University and by Eastern
- 11 Washington University outside of its Cheney campus. The joint center
- 12 for higher education shall not coordinate the intercollegiate center
- 13 for nursing.
- $((\frac{2}{2}))$ (3) The joint center for higher education shall coordinate
- 15 the following higher education activities in the Spokane area outside
- 16 of the Eastern Washington University Cheney campus:
- 17 (a) Articulation between lower division and upper division
- 18 programs;
- 19 (b) The participation of Washington State University and Eastern
- 20 <u>Washington University</u> in ((its)) joint ((engineering)) programs with
- 21 Gonzaga University and Whitworth College and in ((its)) joint
- 22 ((engineering management)) programs with ((Eastern Washington
- 23 University and Gonzaga University)) each other;
- 24 (c) All contractual negotiations between public and independent
- 25 colleges and universities; and
- 26 (d) Programs offered through the intercollegiate research and
- 27 technology institute created by RCW 28B.10.060.
- (((3))) (4) The participating institutions in the joint center for
- 29 higher education shall maintain jurisdiction over the content of the
- 30 course offerings and the entitlement to degrees. However, before any

- 1 degree is authorized under this section it shall be subject to review
- 2 and approval of the higher education coordinating board.
- 3 ((4) Disputes regarding which programs are to be coordinated by
- 4 the joint center for higher education shall be arbitrated by the higher
- 5 education coordinating board or its successor agency. The decision of
- 6 the arbitrating agency shall be binding.))
- 7 (5) The joint center shall develop a master plan for the Spokane
- 8 higher education park. The plan shall be developed in cooperation with
- 9 the participating institutions and submitted to the higher education
- 10 coordinating board, legislature, and office of financial management.
- 11 (6) The joint center shall adopt rules as necessary to implement
- 12 this chapter.
- 13 (7) Title to or all interest in real estate and other assets,
- 14 including but not limited to assignable contracts, cash, equipment,
- 15 buildings, facilities, and appurtenances thereto held as of the
- 16 effective date of this section shall vest in the joint center for
- 17 <u>higher education</u>.
- 18 **Sec. 4.** RCW 28B.25.030 and 1985 c 370 s 99 are each amended to
- 19 read as follows:
- 20 (1) The joint center for higher education shall be ((administered))
- 21 governed by a board consisting of the following twelve voting members:
- 22 (a) ((Two representatives)) One member of the Eastern Washington
- 23 University ((appointed by the)) board of trustees;
- 24 (b) ((Two representatives)) <u>One member</u> of <u>the</u> Washington State
- 25 University ((appointed by the)) board of regents;
- 26 (c) One ((representative of the community colleges in the Spokane
- 27 area appointed by)) member of the board of trustees of the Spokane
- 28 community college district; ((and))

- 1 (d) ((Two)) Six citizens residing in Spokane county. ((The)
- 2 governor, with the consent of the senate, shall appoint the initial
- 3 members, one for a two-year term and one for a four-year term.
- 4 Subsequent citizen board members shall be appointed for four-year terms
- 5 by the remaining voting members of the board.)) Of the six citizen
- 6 members, no more than two may be regents or trustees of Eastern
- 7 Washington University, Washington State University, or the Spokane
- 8 community college district; and
- 9 <u>(e) The presidents of Washington State University and Eastern</u>
- 10 Washington University, and the chief executive officer of the Spokane
- 11 community college district shall serve as ex officio members of the
- 12 board.
- 13 (2) The executive ((coordinator or designee of the council for
- 14 postsecondary education or its successor agency)) director of the
- 15 higher education coordinating board, the president of Gonzaga
- 16 <u>University</u>, and the president of <u>Whitworth College</u> shall serve as ((a))
- 17 nonvoting <u>ex officio</u> members of the board.
- 18 (3) Each of the ((seven)) twelve voting members shall have one
- 19 vote. The voting members shall select a chairperson from among the
- 20 <u>nine appointed members</u>. A majority of the <u>twelve</u> voting members shall
- 21 constitute a quorum for conducting business.
- 22 <u>NEW SECTION.</u> **Sec. 5.** A new section is added to chapter 28B.25 RCW
- 23 to read as follows:
- Nine members of the board shall be appointed by the governor and
- 25 approved by the senate. The appointed members of the board shall serve
- 26 for terms of four years, the terms expiring on September 30th of the
- 27 fourth year except that, in the case of initial members, three shall be
- 28 appointed to two-year terms, three shall be appointed to three-year
- 29 terms, and three shall be appointed to four-year terms. The term of

- 1 any board member who is a trustee or regent shall automatically expire
- 2 when the member's term as trustee or regent expires.
- 3 NEW SECTION. Sec. 6. A new section is added to chapter 28B.25 RCW
- 4 to read as follows:
- 5 A vacancy among appointed board members shall be filled by the
- 6 governor subject to confirmation by the senate then in session, or, if
- 7 not in session, at the next session. Board members appointed under
- 8 this section shall have full authority to act as a board member prior
- 9 to the time the senate acts on the member's confirmation. Appointments
- 10 to fill vacancies shall be only for such terms as remain unexpired.
- 11 Sec. 7. RCW 28B.25.040 and 1985 c 370 s 100 are each amended to
- 12 read as follows:
- 13 The board of the joint center for higher education shall hire a
- 14 director who may hire other staff under chapter 28B.16 RCW as necessary
- 15 to carry out the center's duties. ((The director shall have the status
- 16 of resident dean at the center and of dean at both Washington State and
- 17 Eastern Washington Universities.)) The director shall exercise such
- 18 additional powers, other than rule making, as may be delegated by the
- 19 board by resolution.
- 20 **Sec. 8.** RCW 28B.25.050 and 1985 c 370 s 101 are each amended to
- 21 read as follows:
- 22 ((Washington State University and Eastern Washington University
- 23 shall each allocate at least fifty thousand dollars per year to
- 24 implement RCW 28B.25.010 through 28B.25.060.)) The board shall have
- 25 <u>authority to</u> contract for ((financial and personnel)) services((, or
- 26 provide such services through other means as agreed upon by the board))
- 27 <u>as deemed appropriate to carry out its functions. Such services shall</u>

- 1 include, but not be limited to, facilities and project management,
- 2 grants and contract development and monitoring, personnel services, and
- 3 accounting.
- 4 NEW SECTION. Sec. 9. A new section is added to chapter 28B.25 RCW
- 5 to read as follows:
- 6 The board is authorized to receive and expend federal funds and any
- 7 private gifts or grants to further the purpose of the center. The
- 8 funds are to be expended in accordance with federal and state law and
- 9 any conditions contingent in the grant of those funds.
- 10 NEW SECTION. Sec. 10. A new section is added to chapter 28B.25
- 11 RCW to read as follows:
- 12 Washington State University is authorized to represent state
- 13 interests in acquiring additional property at the site known as the
- 14 Riverpoint higher education park. This authority will transfer to the
- 15 joint center for higher education upon the first meeting held by the
- 16 joint center board.
- 17 **Sec. 11.** RCW 28B.45.050 and 1989 1st ex.s. c 7 s 6 are each
- 18 amended to read as follows:
- 19 Washington State University and Eastern Washington University are
- 20 responsible for providing upper-division and graduate level programs to
- 21 the citizens of the Spokane area, under rules or guidelines adopted by
- 22 the joint center for higher education. However, before any degree is
- 23 <u>authorized under this section it shall be subject to the review and</u>
- 24 approval of the higher education coordinating board. Washington State
- 25 University shall meet its responsibility through the operation of a
- 26 branch campus in the Spokane area. Eastern Washington University shall

- 1 meet its responsibility through the operation of ((collocated))
- 2 programs and facilities in Spokane.
- 3 <u>NEW SECTION.</u> **Sec. 12.** RCW 28B.25.060 and 1985 c 370 s 102 are
- 4 each repealed.
- 5 <u>NEW SECTION.</u> **Sec. 13.** This act is necessary for the immediate
- 6 preservation of the public peace, health, or safety, or support of the
- 7 state government and its existing public institutions, and shall take
- 8 effect July 1, 1991.
