- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 9 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that:
- 10 Enhancement and protection of the state's environment demands more
- 11 resources than government funding can provide;
- 12 A critical underutilized asset to society is the knowledge, skills,
- 13 abilities, and wisdom of our expanding, able senior population;

- 1 Central to the well-being and continued connection to society of
- 2 Washington's senior citizens is the opportunity for them to voluntarily
- 3 continue to provide meaningful contributions and to share their
- 4 professional training, lifelong skills, talents, and wisdom with
- 5 Washington state's citizens;
- 6 It will benefit all the citizens of the state of Washington to
- 7 create a partnership between our senior citizens and the state's
- 8 natural resource agencies to augment our capability to protect,
- 9 enhance, and appreciate the environment.
- 10 <u>NEW SECTION.</u> **Sec. 2.** Unless the context clearly requires
- 11 otherwise, the definitions in this section apply throughout sections 1
- 12 through 7 of this act.
- 13 "Agency" means one of the agencies or organizations participating
- 14 in the activities of the senior environmental corps.
- 15 "Coordinator" means the person designated by the director of the
- 16 department of community development with the advice of the council to
- 17 administer the activities of the senior environmental corps.
- 18 "Corps" means the senior environmental corps.
- 19 "Council" means the senior environmental corps coordinating
- 20 council.
- 21 "Department" means the department of community development.
- 22 "Director" means the director of the department of community
- 23 development or the director's authorized representative.
- 24 "Representative" means the person who represents an agency on the
- 25 council and is responsible for the activities of the senior
- 26 environmental corps in his or her agency.
- 27 "Senior" means any person who is fifty-five years of age or over.

- 1 "Volunteer" means a person who is willing to work without
- 2 expectation of salary or financial reward, and who chooses where he or
- 3 she provides services and the type of services he or she provides.
- 4 <u>NEW SECTION.</u> **Sec. 3.** The senior environmental corps is
- 5 created within the department of community development. The
- 6 departments of agriculture, community development, ecology, fisheries,
- 7 health, natural resources, and wildlife, the parks and recreation
- 8 commission, and the Puget Sound water quality authority shall
- 9 participate in the administration and implementation of the corps and
- 10 shall appoint representatives to the council.
- 11 <u>NEW SECTION.</u> **Sec. 4.** The goals of the corps shall be to:
- 12 Provide resources and a support structure to facilitate corps
- 13 activities and accomplish goals;
- 14 Carry out professional and paraprofessional projects that focus on
- 15 conservation, protection, rehabilitation, and enhancement of the
- 16 state's natural, environmental, and recreational resources and that
- 17 otherwise would not be implemented because of limited financial
- 18 resources;
- 19 Provide meaningful opportunities for senior volunteers to continue
- 20 to utilize their professional training, lifelong skills, abilities,
- 21 experience, and wisdom through participation in corps projects;
- 22 Assist agencies in carrying out statutory assignments with limited
- 23 funding resources;
- 24 Enhance community understanding of environmental issues through
- 25 educational outreach; and
- 26 Enhance the state's ability to provide needed public services in
- 27 both urban and rural settings.

- 1 <u>NEW SECTION.</u> **Sec. 5.** The department shall convene a senior
- 2 environmental corps coordinating council to meet as needed to establish
- 3 and assess policies, define standards for projects, evaluate and select
- 4 projects, develop recruitment, training, and placement procedures,
- 5 receive and review project status and completion reports, and provide
- 6 for recognition of volunteer activity. The council shall include
- 7 representatives appointed by the departments of agriculture, community

- 21 the agreement may be canceled.

- 9 persons or circumstances is not affected.
- 10 <u>NEW SECTION.</u> **Sec. 17.** Sections 1 through 7 of this act are
- 11 each added to chapter 43.63A RCW.
- 12 <u>NEW SECTION.</u> **Sec. 18.** This act is necessary for the immediate
- 13 preservation of the public peace, health, or safety, or support of the
- 14 state government and its existing public institutions, and shall take
- 15 effect immediately.
