## SENATE BILL 5283

State of Washington 52nd Legislature 1991 Regular Session

- 1 AN ACT Relating to blood donors; and adding new sections to chapter
- 2 70.54 RCW.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 70.54 RCW
- 5 to read as follows:
- 6 Any blood donor program established in this state for receiving
- 7 blood donations for medical or health purposes shall establish a
- 8 program and procedure to honor requests by donors to have the blood
- 9 donations directed for use to persons as specified by such donors for
- 10 a period of fourteen days following the donation. The blood donor
- 11 program may charge reasonable fees for such directed blood donations to
- 12 cover administrative costs.
- NEW SECTION. Sec. 2. A new section is added to chapter 70.54 RCW
- 14 to read as follows:

- 1 The program aspects established under section 1 of this act shall
- 2 include, but not be limited to:
- 3 (1) Designated donations may be accepted only on written request of
- 4 the patient's responsible physician and with the written consent of the
- 5 patient or legal guardian. The physician request shall state the
- 6 required blood components;
- 7 (2) Designated donations may be permitted only for a specific
- 8 patient who is scheduled for a procedure that has a reasonable
- 9 likelihood of requiring transfusion;
- 10 (3) Directed donations may be accepted prior to testing the blood
- 11 type of the designated recipient;
- 12 (4) The blood bank may separate blood donated into its component
- 13 parts;
- 14 (5) The blood components may be directed only if they are viable
- 15 for at least fourteen days; and
- 16 (6) Cryoprecipitate may be directed only upon special request by
- 17 the donor with written request by the physician.
- 18 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 70.54 RCW
- 19 to read as follows:
- 20 The procedural aspects established under section 1 of this act
- 21 shall include, but not be limited to:
- 22 (1) The donor shall designate the recipient of the blood. Only one
- 23 recipient may be named;
- 24 (2) The donor will make an appointment with the blood donor program
- 25 for the donation;
- 26 (3) The donor will sign a release when the blood is donated which
- 27 includes an acknowledgement that the designated recipient may not
- 28 receive the directed blood donation due to emergencies, incompatibility
- 29 in blood type, breakage, contamination, or other unforeseen problems.

- 1 Therefore, there is no guarantee that designated blood will be suitable
- 2 or made available for transfusion; and
- 3 (4) The physician request shall be submitted to the blood bank one
- 4 week in advance and no less than forty-eight work week hours prior to
- 5 the expected transfusion date.
