## SENATE BILL 5695

State of Washington 52nd Legislature 1991 Regular Session

By Senators Barr, Anderson, McMullen, Matson and Johnson.

Read first time February 15, 1991. Referred to Committee on Law & Justice.

- AN ACT Relating to prosecuting attorneys; amending RCW 36.17.020;
- 2 and creating new sections.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** The legislature recognizes that the
- 5 incidence of crime is increasing in Washington state and finds that (1)
- 6 an adequate salary for the prosecuting attorney is indispensable to
- 7 attracting and retaining qualified attorneys in public service, (2)
- 8 this is in the state interest given the nature of the duties required
- 9 of the prosecutor in RCW 36.27.020, and (3) state legislation and
- 10 fiscal assistance is needed to obtain this result in light of: (a)
- 11 Unprecedented resignations from the office to seek judicial office or
- 12 other employment; (b) a dearth of qualified candidates seeking offices
- 13 held by incumbents; and (c) recent actions of the Washington citizens'
- 14 commission on salaries for elected officials that have resulted in

- 1 district court judges receiving salaries significantly higher than
- 2 full-time prosecutors.
- 3 Sec. 2. RCW 36.17.020 and 1973 1st ex.s. c 88 s 2 are each amended

- 23 The county legislative authority of such county is authorized to
- 24 increase or decrease the salary of such office but may not decrease the
- 25 salary of the prosecuting attorney below the amount specified in
- 26 <u>subsection (3) of this section</u>: PROVIDED, That the legislative
- 27 authority of the county shall not reduce the salary of any official
- 28 below the amount which such official was receiving on January 1, 1973.
- 29 (3) The salary of the prosecuting attorney in class AA and A
- 30 counties and in counties of the first, second, third, and fourth

- 1 classes shall be no less than the amount prescribed for superior court
- 2 judges in RCW 43.03.012. The salary of a full-time prosecuting
- 3 attorney in counties of the fifth, sixth, seventh, eighth, and ninth
- 4 <u>classes shall be no less than the amount prescribed for a full-time</u>
- 5 judge of the district court in RCW 43.03.012. The salary of a part-
- 6 time prosecuting attorney shall be no less than such percentage of the
- 7 salary for a full-time judge of the district court that the prosecuting
- 8 attorney certifies, at the end of each month, is the same as the
- 9 percentage of hours he or she has worked as the prosecuting attorney
- 10 compared to the hours that would be worked for that month by a full-
- 11 time prosecuting attorney, based on a forty-hour work week.
- 12 One-half of the salary of each prosecuting attorney shall be paid
- 13 by the state. During the biennium ending June 30, 1993, the state
- 14 shall reimburse each county for all of the additional salary
- 15 obligations and other costs incurred in the implementation of this
- 16 <u>subsection (3) above the amounts each county was responsible for prior</u>
- 17 to the effective date of this act.
- 18 <u>NEW SECTION</u>. **Sec. 3.** The Washington association of prosecuting
- 19 attorneys shall report to the Washington state legislature by December
- 20 1, 1994, as to the changes achieved by the signing into law of this act
- 21 as measured by the decrease in voluntary departure from office of
- 22 prosecuting attorneys and the increase in the number of attorneys
- 23 seeking election to the office of prosecuting attorney.
