## SUBSTITUTE SENATE BILL 5782

State of Washington 52nd Legislature 1991 Regular Session

**By** Senate Committee on Health & Long-Term Care (originally sponsored by Senators Barr, Hansen, Snyder, L. Smith and Amondson).

Read first time March 6, 1991.

AN ACT Relating to rural health care; amending RCW 70.175.020 and 70.175.030; adding a new section to chapter 70.175 RCW; creating a new section; and making an appropriation.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. Sec. 1. The legislature finds that there are barriers to providing residents of rural areas with access to 6 7 affordable health care coverage through both public and private The legislature further finds that the report on these 8 programs. 9 barriers requested by the legislature in 1990 was prepared by the insurance commissioner's committee on the availability of affordable 10 11 health insurance in rural areas of Washington state and declares that 12 the regulatory and voluntary actions identified in this report should be pursued within the public and private sectors. 13 The legislature intends through this act to foster the development and implementation 14 15 of one community-based pilot project aimed at demonstrating the

viability of providing health care services to residents of a rural
 area within the state.

3 <u>NEW SECTION.</u> Sec. 2. A new section is added to chapter 70.175 RCW 4 to read as follows:

5 In administering and making awards for rural health projects under RCW 70.175.050, the secretary shall establish a process for selecting б and making an award to a single participant for the development, 7 8 design, and implementation of a project designed to provide a rural 9 health care services program to residents of a rural community. Applications for rural health care services pilot programs shall 10 include only contiguous health care catchment areas of the state that 11 are designated as rural. Project funds may be used for any purposes 12 related to the development, design, implementation, or introduction of 13 a rural health care services program except that funds shall not be 14 15 used to directly contribute to any program reserves used to assure the 16 financial viability of the program. Final approval of a project funded and authorized under this section must be obtained from the secretary 17 18 before final implementation.

19 Sec. 3. RCW 70.175.020 and 1989 1st ex.s. c 9 s 702 are each 20 amended to read as follows:

21 Unless the context clearly requires otherwise, the definitions in 22 this section apply throughout this chapter.

(1) "Administrative structure" means a system of contracts or formal agreements between organizations and persons providing health services in an area that establishes the roles and responsibilities each will assume in providing the services of the rural health care facility.

(3) "Health care delivery system" means services and personnel 1 2 involved in providing health care to a population in a geographic area. (4) "Health care facility" means any land, structure, system, 3 4 machinery, equipment, or other real or personal property or appurtenances useful for or associated with delivery of inpatient or 5 б outpatient health care service or support for such care or any combination thereof which is operated or undertaken in connection with 7 a hospital, clinic, health maintenance organization, diagnostic or 8 9 treatment center, extended care facility, or any facility providing or 10 designed to provide therapeutic, convalescent or preventive health care services. 11

12 (5) "Health care system strategic plan" means a plan developed by 13 the participant and includes identification of health care service 14 needs of the participant, services and personnel necessary to meet 15 health care service needs, identification of health status outcomes and 16 outcome measures, identification of funding sources, and strategies to 17 meet health care needs including measures of effectiveness.

18 (6) "Institutions of higher education" means educational19 institutions as defined in RCW 28B.10.016.

20 (7) "Local administrator" means an individual or organization 21 representing the participant who may enter into legal agreements on 22 behalf of the participant.

(8) "Participant" means communities, counties, and regions that serve as a health care catchment area where the project site is located.

26 (9) "Project" means the Washington rural health system project.

(10) "Project site" means a site selected to participate in theproject.

(11) "Rural health care facility" means a facility, group, or other
formal organization or arrangement of facilities, equipment, and

1 personnel capable of providing or assuring availability of health 2 services in a rural area. The services to be provided by the rural 3 health care facility may be delivered in a single location or may be 4 geographically dispersed in the community health service catchment area 5 so long as they are organized under a common administrative structure 6 or through a mechanism that provides appropriate referral, treatment, 7 and follow-up.

(12) "Secretary" means the secretary of health.

9 (13) "Rural health care services program" means an arrangement 10 sponsored by a health care organization, municipal corporation, or 11 combination of public and private entities that provides, exclusively 12 for rural residents of its health care catchment area, access to 13 primary, acute, or secondary health care services, either by contract 14 or through the direct delivery of the services.

15 Sec. 4. RCW 70.175.030 and 1989 1st ex.s. c 9 s 703 are each 16 amended to read as follows:

17 (1) The department shall establish the Washington rural health 18 system project to provide financial and technical assistance to 19 participants. The goal of the project is to help assure access to 20 affordable health care services to citizens in the rural areas of 21 Washington state.

(2) Administrative costs necessary to implement this project shall
be kept at a minimum to insure the maximum availability of funds for
participants.

(3) The secretary may appoint such technical or advisory committees as he or she deems necessary consistent with the provisions of RCW 43.70.040. In appointing an advisory committee the secretary should assure representation by health care professionals, health care providers, and those directly involved in the purchase, provision, or

delivery of health care services as well as consumers, rural community leaders, and those knowledgeable of the issues involved with health care public policy. Individuals appointed to any technical advisory committee shall serve without compensation for their services as members, but may be reimbursed for their travel expenses pursuant to RCW 43.03.050 and 43.03.060.

7 (4) The secretary may contract with third parties for services 8 necessary to carry out activities to implement this chapter where this 9 will promote economy, avoid duplication of effort, and make the best 10 use of available expertise.

11 (5) The secretary may apply for, receive, <u>participate in</u>, and 12 accept gifts<u>, grants</u>, and other payments, including property and 13 service, from any governmental or other public or private entity or 14 person, and may make arrangements as to the use of these receipts, 15 including the undertaking of special studies and other projects related 16 to the delivery of health care in rural areas.

17 (6) In designing and implementing the project the secretary shall 18 consider the report of the Washington rural health care commission 19 established under chapter 207, Laws of 1988, and for purposes of 20 section 2 of this act, the report of the committee on the availability of affordable health insurance in rural areas of Washington state 21 established under chapter 271, Laws of 1990. Nothing in this chapter 22 requires the secretary to follow any specific recommendation contained 23 24 in that report except as it may also be included in this chapter.

25 (7) The secretary shall appoint a special advisory committee for 26 the purpose of assisting in establishing standards, making awards, 27 designing the final project, coordinating technical assistance, and 28 providing oversight of the demonstration project authorized under 29 section 2 of this act. This committee shall include the director of 30 the medical assistance program of the department of social and health

services, the administrator of the state health care authority, the
 administrator of the basic health plan, and the director of the
 department of labor and industries, and may include any other
 representatives deemed necessary by the secretary.

5 (8) The successful applicant for implementation of a project under 6 section 2 of this act is exempt from all provisions of Title 48 RCW 7 after the secretary makes a specific determination that the applicant: 8 (a) Has obtained an actuarial study through a consultant approved 9 by the secretary which concludes that the rural health care services 10 program is financially viable;

11 (b) Has demonstrated public support from the citizens residing 12 within the catchment area of the rural health care services program 13 through an affirmative vote on that issue presented to them at a 14 general or special election; and

15 (c) Has verified that all provider contracts within the rural 16 health care services program hold individual beneficiaries harmless for 17 charges for services arising in the event of a failure of the plan.

18 <u>NEW SECTION.</u> Sec. 5. The sum of one hundred fifty thousand 19 dollars, or as much thereof as may be necessary, is appropriated for 20 the biennium ending June 30, 1993, from the insurance commissioner's 21 regulatory account to the department of health for the purpose of 22 making a project award under section 2 of this act.
