1 AN ACT Relating to clarifying the department of agriculture's  
2 authority to regulate pesticides; amending RCW 15.58.020 and 17.21.010;  
3 adding a new section to chapter 15.58 RCW; adding a new section to  
4 chapter 17.21 RCW; and declaring an emergency.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 **Sec. 1.** RCW 15.58.020 and 1971 ex.s. c 190 s 2 are each amended to  
7 read as follows:

8 The formulation, distribution, storage, transportation, and  
9 disposal of any pesticide and the dissemination of accurate scientific  
10 information as to the proper use, or nonuse, of any pesticide, is  
11 important and vital to the maintenance of a high level of public health  
12 and welfare both immediate and future, and is hereby declared to be a  
13 business affected with the public interest. A system of pesticide  
14 regulation that is consistent, coordinated, and comports with both

1 federal and state technical expertise is essential in maintaining the  
2 level of public health and welfare, and local regulation of pesticides  
3 does not materially assist in achieving this goal. The provisions of  
4 this chapter are enacted in the exercise of the police powers of the  
5 state for the purpose of protecting the immediate and future health and  
6 welfare of the people of the state.

7 NEW SECTION. **Sec. 2.** A new section is added to chapter 15.58 RCW  
8 to read as follows:

9 A city, town, county, or political subdivision of this state may  
10 not adopt or continue in effect an ordinance, rule, regulation, or  
11 statute regarding pesticide sale or use, including without limitation:  
12 Registration, advertising and marketing, distribution, storage,  
13 transportation, disposal, disclosure of confidential information, or  
14 product composition.

15 **Sec. 3.** RCW 17.21.010 and 1967 c 177 s 1 are each amended to read  
16 as follows:

17 The application and the control of the use of various pesticides is  
18 important and vital to the maintenance of a high level of public health  
19 and welfare both immediate and future, and is hereby declared to be  
20 affected with the public interest. A system of pesticide regulation  
21 that is consistent, coordinated, and comports with both federal and  
22 state technical expertise is essential in maintaining the level of  
23 public health and welfare, and local regulation of pesticides does not  
24 materially assist in achieving this goal. The provisions of this  
25 chapter are enacted in the exercise of the police power of the state  
26 for the purpose of protecting the immediate and future health and  
27 welfare of the people of the state.

1        NEW SECTION.    **Sec. 4.**    A new section is added to chapter 17.21 RCW  
2 to read as follows:

3        A city, town, county, or political subdivision of this state may  
4 not adopt or continue in effect an ordinance, rule, regulation, or  
5 statute regarding pesticide sale or use, including without limitation:  
6 Method and manner of application, notification of use, applicator  
7 training and certification, or storage.

8        NEW SECTION.    **Sec. 5.**        This act is necessary for the immediate  
9 preservation of the public peace, health, or safety, or support of the  
10 state government and its existing public institutions, and shall take  
11 effect immediately.
