## SUBSTITUTE SENATE BILL 6335

State of Washington 52nd Legislature 1992 Regular Session

1 AN ACT Relating to a commercial salmon producers commodity 2 commission; amending RCW 15.66.010; adding a new section to chapter 3 15.66 RCW; and creating a new section.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. Sec. 1. The legislature finds that the marketing 6 of salmon in the state of Washington is affected by the public interest 7 and that there is a willingness and ability on the part of the commercial salmon industry to participate more fully in the production, 8 protection, improvement, and restoration of the public salmon resource. 9 10 The policies that justify the creation of other agricultural commodity 11 commissions as provided for in chapter 15.66 RCW apply as well to the commercial salmon industry. Moreover, the particular nature of the 12 public salmon resource makes it publicly desirable that those who 13 14 participate in its commercial harvest be encouraged to also participate

in its production, protection, improvement, and restoration. Nothing
 herein shall be construed to imply more favorable treatment by the
 state of Washington of commercial over recreational fisheries.

4 Sec. 2. RCW 15.66.010 and 1986 c 203 s 16 are each amended to read 5 as follows:

6 For the purposes of this chapter:

7 (1) "Director" means the director of agriculture of the state of 8 Washington or any qualified person or persons designated by the 9 director of agriculture to act for him concerning some matter under 10 this chapter.

(2) "Department" means the department of agriculture of the stateof Washington.

13 (3) "Marketing order" means an order issued by the director14 pursuant to this chapter.

15 (4) "Agricultural commodity" means any animal or any distinctive 16 type of agricultural, horticultural, viticultural, vegetable, and/or animal product, including, but not limited to, commercially harvested 17 18 salmon, products qualifying as organic food products under chapter 19 15.86 RCW and private sector cultured aquatic products as defined in RCW 15.85.020 and other fish and fish products, within its natural or 20 processed state, including bees and honey and Christmas trees but not 21 including timber or timber products. The director is authorized to 22 23 determine what kinds, types or subtypes should be classed together as 24 an agricultural commodity for the purposes of this chapter.

(5) "Producer" means any person engaged in the business of producing or causing to be produced for market in commercial quantities any agricultural commodity, including commercial harvesters and processors of salmon harvested in the waters of the state of Washington or pursuant to a commercial fishing license issued by the state of

1 <u>Washington</u>. For the purposes of RCW 15.66.060, 15.66.090, and 2 15.66.120, as now or hereafter amended "producer" shall include bailees 3 who contract to produce or grow any agricultural product on behalf of 4 a bailor who retains title to the seed and its resulting agricultural 5 product or the agricultural product delivered for further production or 6 increase.

7 (6) "Affected producer" means any producer of an affected 8 commodity.

9 (7) "Affected commodity" means any agricultural commodity for which 10 the director has established a list of producers pursuant to RCW 11 15.66.060.

12 (8) "Commodity commission" or "commission" means a commission 13 formed to carry out the purposes of this chapter under a particular 14 marketing order concerning an affected commodity.

15 (9) "Unit" means a unit of volume, quantity or other measure in 16 which an agricultural commodity is commonly measured.

17 (10) "Unfair trade practice" means any practice which is unlawful or prohibited under the laws of the state of Washington including but 18 19 not limited to Titles 15, 16 and 69 RCW and chapters 9.16, 19.77, 20 19.80, 19.84, and 19.83 RCW, or any practice, whether concerning interstate or intrastate commerce that is unlawful under the provisions 21 of the act of Congress of the United States, September 26, 1914, 22 chapter 311, section 5, 38 U.S. Statutes at Large 719 as amended, known 23 24 as the "Federal Trade Commission Act of 1914", or the violation of or 25 failure accurately to label as to grades and standards in accordance with any lawfully established grades or standards or labels. 26

(11) "Person" includes any individual, firm, corporation, trust,
 association, partnership, society, or any other organization of
 individuals.

"Cooperative association" means 1 (12)any incorporated or 2 unincorporated association of producers which conforms to the qualifications set out in the act of Congress of the United States, 3 4 Feb. 18, 1922, chapter 57, sections 1 and 2, 42 U.S. Statutes at Large 5 388 as amended, known as the "Capper-Volstead Act" and which is engaged 6 in making collective sales or in marketing any agricultural commodity or product thereof or in rendering service for or advancing the 7 interests of the producers of such commodity on a nonprofit cooperative 8 9 basis.

10 (13) "Member of a cooperative association" or "member" means any 11 producer of an agricultural commodity who markets his product through 12 such cooperative association and who is a voting stockholder of or has 13 a vote in the control of or is under a marketing agreement with such 14 cooperative association with respect to such product.

15 <u>NEW SECTION.</u> Sec. 3. A new section is added to chapter 15.66 RCW 16 to read as follows:

17 If Washington commercial salmon producers elect under the 18 provisions of this chapter to form a commodity commission as authorized 19 under that chapter, such a commission may, if it so elects, in addition 20 to the marketing and other powers and purposes granted and provided 21 for, also engage in the following activities and expend commission 22 funds for the following purposes:

(1) Salmon habitat restoration and improvement under the direction
of the department of fisheries;

(2) Recovery of lost or abandoned commercial fishing net that may
pose an environmental or safety hazard;

(3) Harvest recovery of hatchery surpluses, test fishing, and other
salmon production, management, improvement, and conservation work under
the direction of the department of fisheries;

1 (4) Providing fully or partially compensated interns or other 2 personnel to the department of fisheries for use in the department's 3 production, improvement, management, or conservation of the salmon 4 resource;

5 (5) Any other purpose that advances or benefits the Washington6 salmon resource; and

7 (6) The solicitation and expenditure of grant funds from private
8 and governmental sources for the activities and purposes in subsections
9 (1) through (5) of this section.
