1 AN ACT Relating to youth and family services; amending RCW
2 74.13.034, 70.96A.020, 70.96A.095, 70.96A.140, 71.05.210, 71.34.060,
3 and 13.32A.196; adding a new section to chapter 43.20A RCW; and
4 creating new sections.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 NEW SECTION. **Sec. 1.** Evaluation of programs is essential in
7 determining their effectiveness and cost benefit and in obtaining data
8 for improving services. The department of social and health services
9 shall conduct an evaluation of the family reconciliation services
10 program. The study shall include the following information:

- 11 (1) A description of services offered in phase I and phase II;
12 (2) The number and characteristics of youth and families served in
13 family reconciliation services phase I and phase II and the outcome of
14 services provided to youth and families;

1 (3) A description of outreach services including program
2 information provided to referring agencies and the general public;

3 (4) The number and type of referrals to family reconciliation
4 services from law enforcement, juvenile courts, schools, and community
5 agencies and their perception of its effectiveness;

6 (5) Follow-up contact with a random sample of youth and families
7 receiving family reconciliation services assistance and their
8 perception of the effectiveness of these services;

9 (6) The number of youth referred again after services were
10 terminated and outcome of services provided;

11 (7) The number of youth and families who requested specific
12 services but who did not receive services because they were not
13 available, including a list of the services requested but not
14 available; and

15 (8) Recommendations for improving services to at-risk youth and
16 families.

17 NEW SECTION. **Sec. 2.** The demand for family reconciliation
18 services continues to increase. The number of families served by the
19 family reconciliation services program has nearly doubled in the past
20 ten years while the number of staff providing these services has
21 decreased. The department of social and health services shall expand
22 family reconciliation services to serve an additional one thousand
23 families per year.

24 NEW SECTION. **Sec. 3.** The behavioral sciences institute
25 homebuilders intensive in-home counseling program has been highly
26 successful in serving at-risk youth and families. This program shall
27 expand to serve an additional one hundred twenty-six youth and families
28 while preserving program integrity and quality.

1 NEW SECTION. **Sec. 4.** There is a lack of knowledge of existing
2 laws and services on the part of those agencies and organizations
3 serving at-risk youth and on the part of the general public. The
4 office of the administrator for the courts is requested to develop a
5 curriculum on at-risk youth for superior court judges and court
6 personnel to be presented at a regularly scheduled educational session.
7 The department of social and health services is directed to produce a
8 videotape on at-risk youth laws and services for use by law
9 enforcement, family reconciliation services staff, prosecuting and
10 defense attorneys, other agencies and organizations dealing with at-
11 risk youth, and the general public. The department shall consult with
12 other agencies and organizations providing services to at-risk youth in
13 the production of the videotape.

14 **Sec. 5.** RCW 74.13.034 and 1981 c 298 s 17 are each amended to read
15 as follows:

16 (1) A child taken into custody and taken to a crisis residential
17 center established pursuant to RCW 74.13.032(2) may, if the center is
18 unable to provide appropriate treatment, supervision, and structure to
19 the child, be taken at department expense to another crisis residential
20 center or the nearest regional crisis residential center. Placement in
21 both centers shall not exceed seventy-two hours from the point of
22 intake as provided in RCW 13.32A.130.

23 (2) A child taken into custody and taken to a crisis residential
24 center established by this chapter may be placed physically by the
25 department or the department's designee and, at departmental expense
26 and approval, in a secure juvenile detention facility operated by the
27 county in which the center is located for a maximum of forty-eight
28 hours, including Saturdays, Sundays, and holidays, if (~~the person in~~
29 ~~charge of the crisis residential center finds that the child is~~

1 ~~seriously assaultive or seriously destructive towards others and the~~
2 ~~center is unable to provide appropriate supervision and structure. Any~~
3 ~~child who takes unauthorized leave from the center, if)) the child has~~
4 ~~taken unauthorized leave from the center and the person in charge of~~
5 ~~the center determines that the center cannot provide supervision and~~
6 ~~structure adequate to ensure that the child will not again take~~
7 ~~unauthorized leave((, may be taken to a secure juvenile detention~~
8 ~~facility subject to the provisions of this section: PROVIDED, That)).~~
9 Juveniles placed in such a facility pursuant to this section may not,
10 to the extent possible, come in contact with alleged or convicted
11 juvenile or adult offenders.

12 (3) Any child placed in secure detention pursuant to this section
13 shall, during the period of confinement, be provided with appropriate
14 treatment by the department or the department's designee, which shall
15 include the services defined in RCW 74.13.033(2). If the child placed
16 in secure detention is not returned home or if an alternative living
17 arrangement agreeable to the parent and the child is not made within
18 twenty-four hours after the child's admission, the child shall be taken
19 at the department's expense to a crisis residential center. Placement
20 in the crisis residential center or centers plus placement in juvenile
21 detention shall not exceed seventy-two hours from the point of intake
22 as provided in RCW 13.32A.130.

23 (4) Juvenile detention facilities used pursuant to this section
24 shall first be certified by the department to ensure that juveniles
25 placed in the facility pursuant to this section are provided with
26 living conditions suitable to the well-being of the child. Where space
27 is available, juvenile courts, when certified by the department to do
28 so, shall provide secure placement for juveniles pursuant to this
29 section, at department expense.

1 (5) It is the intent of the legislature that by July 1, 1982,
2 crisis residential centers, supplemented by community mental health
3 programs and mental health professionals, will be able to respond
4 appropriately to children admitted to centers under this chapter and
5 will be able to respond to the needs of such children with appropriate
6 treatment, supervision, and structure.

7 NEW SECTION. **Sec. 6.** A new section is added to chapter 43.20A RCW
8 to read as follows:

9 The department shall ensure that the administration of chapter
10 13.32A RCW and applicable portions of chapter 74.13 RCW relating to
11 runaway youth, at-risk youth, and families in conflict is consistent in
12 all areas of the state and in accordance with statutory requirements.

13 NEW SECTION. **Sec. 7.** The legislature finds that the use of
14 alcohol and illicit drugs continues to be a primarycrippler of our
15 youth. This translates into incredible costs to individuals, families,
16 and society in terms of traffic fatalities, suicides, criminal activity
17 including homicides, sexual promiscuity, familial incorrigibility, and
18 conduct disorders, and educational fallout. Among children of all
19 socioeconomic groups lower expectations for the future, low motivation
20 and self-esteem, alienation, and depression are associated with alcohol
21 and drug abuse.

22 Studies reveal that deaths from alcohol and other drug-related
23 injuries rise sharply through adolescence, peaking in the early
24 twenties. But second peak occurs in later life, where it accounts for
25 three times as many deaths from chronic diseases. A young victim's
26 life expectancy is likely to be reduced by an average of twenty-six
27 years.

1 Yet the cost of treating alcohol and drug addicts can be recouped
2 in the first three years of abstinence in health care savings alone.
3 Public money spent on treatment saves not only the life of the chemical
4 abuser, it makes us safer as individuals, and in the long-run costs
5 less.

6 The legislature further finds that many children who abuse alcohol
7 and other drugs may not require involuntary treatment, but still are
8 not adequately served. These children remain at risk for future
9 chemical dependency, and may become mentally ill or a juvenile offender
10 or need out-of-home placement. Children placed at risk because of
11 chemical abuse may be better served by the creation of a comprehensive
12 integrated system for children in crisis.

13 The legislature declares that an emphasis on the treatment of youth
14 will pay the largest dividend in terms of preventable costs to
15 individuals themselves, their families, and to society. The provision
16 of augmented involuntary alcohol treatment services to youths, as well
17 as involuntary treatment for youths addicted by other drugs, is in the
18 interest of the public health and safety.

19 **Sec. 8.** RCW 70.96A.020 and 1990 c 151 s 2 are each amended to read
20 as follows:

21 For the purposes of this chapter the following words and phrases
22 shall have the following meanings unless the context clearly requires
23 otherwise:

24 (1) "Alcoholic" means a person who suffers from the disease of
25 alcoholism.

26 (2) "Alcoholism" means a disease, characterized by a dependency on
27 alcoholic beverages, loss of control over the amount and circumstances
28 of use, symptoms of tolerance, physiological or psychological

1 withdrawal, or both, if use is reduced or discontinued, and impairment
2 of health or disruption of social or economic functioning.

3 (3) "Approved treatment program" means a discrete program of
4 chemical dependency treatment provided by a treatment program certified
5 by the department of social and health services as meeting standards
6 adopted under this chapter.

7 (4) "Chemical dependency" means alcoholism or drug addiction, or
8 dependence on alcohol and one or more other psychoactive chemicals, as
9 the context requires.

10 (5) "Chemical dependency program" means expenditures and activities
11 of the department designed and conducted to prevent or treat alcoholism
12 and other drug addiction, including reasonable administration and
13 overhead.

14 (6) "Department" means the department of social and health
15 services.

16 (7) "Designated chemical dependency specialist" means a person
17 designated by the county alcoholism and other drug addiction program
18 coordinator designated under RCW 70.96A.310 to perform the commitment
19 duties described in RCW 70.96A.140 and qualified to do so by meeting
20 standards adopted by the department.

21 (8) "Director" means the person administering the chemical
22 dependency program within the department.

23 (9) "Drug addict" means a person who suffers from the disease of
24 drug addiction.

25 (10) "Drug addiction" means a disease characterized by a dependency
26 on psychoactive chemicals, loss of control over the amount and
27 circumstances of use, symptoms of tolerance, physiological or
28 psychological withdrawal, or both, if use is reduced or discontinued,
29 and impairment of health or disruption of social or economic
30 functioning.

1 (11) "Emergency service patrol" means a patrol established under
2 RCW 70.96A.170.

3 (12) "Gravely disabled by alcohol or other drugs" means that a
4 person, as a result of the use of alcohol or other drugs: (a) Is in
5 danger of serious physical harm resulting from a failure to provide for
6 his or her essential human needs of health or safety; or (b) manifests
7 severe deterioration in routine functioning evidenced by a repeated and
8 escalating loss of cognition or volitional control over his or her
9 actions and is not receiving care as essential for his or her health or
10 safety.

11 (13) "Incapacitated by alcohol or other psychoactive chemicals"
12 means that a person, as a result of the use of alcohol or other
13 psychoactive chemicals, has his or her judgment so impaired that he or
14 she is incapable of realizing and making a rational decision with
15 respect to his or her need for treatment and constitutes a danger to
16 himself or herself, to any other person, or to property.

17 (14) "Incompetent person" means a person who has been adjudged
18 incompetent by the superior court.

19 (15) "Intoxicated person" means a person whose mental or physical
20 functioning is substantially impaired as a result of the use of alcohol
21 or other psychoactive chemicals.

22 (16) "Licensed physician" means a person licensed to practice
23 medicine or osteopathy in the state of Washington.

24 (17) "Minor" means a person less than eighteen years of age.

25 (18) "Peace officer" means a law enforcement official of a public
26 agency or governmental unit, and includes persons specifically given
27 peace officer powers by any state law, local ordinance, or judicial
28 order of appointment.

29 ~~((18))~~ (19) "Person" means an individual, including a minor.

1 (20) "Secretary" means the secretary of the department of social
2 and health services.

3 (~~(19)~~) (21) "Treatment" means the broad range of emergency,
4 detoxification, residential, and outpatient services and care,
5 including diagnostic evaluation, chemical dependency education and
6 counseling, medical, psychiatric, psychological, and social service
7 care, vocational rehabilitation and career counseling, which may be
8 extended to alcoholics and other drug addicts and their families,
9 persons incapacitated by alcohol or other psychoactive chemicals, and
10 intoxicated persons.

11 (~~(20)~~) (22) "Treatment program" means an organization,
12 institution, or corporation, public or private, engaged in the care,
13 treatment, or rehabilitation of alcoholics or other drug addicts.

14 **Sec. 9.** RCW 70.96A.095 and 1989 c 270 s 24 are each amended to
15 read as follows:

16 Any person fourteen years of age or older may give consent for
17 himself or herself to the furnishing of counseling, care, treatment, or
18 rehabilitation by a treatment program or by any person. Consent of the
19 parent, parents, or legal guardian of a person less than eighteen years
20 of age is not necessary to authorize the care, except that the person
21 shall not become a resident of the treatment program without such
22 permission except as provided in RCW 70.96A.120 or 70.96A.140. The
23 parent, parents, or legal guardian of a person less than eighteen years
24 of age are not liable for payment of care for such persons pursuant to
25 this chapter, unless they have joined in the consent to the counseling,
26 care, treatment, or rehabilitation.

27 **Sec. 10.** RCW 70.96A.140 and 1990 c 151 s 3 are each amended to
28 read as follows:

1 (1) When a designated chemical dependency specialist((7)) receives
2 information alleging that a person is incapacitated as a result of
3 alcoholism, or in the case of a minor incapacitated by alcoholism
4 and/or other drug addiction, the designated chemical dependency
5 specialist, after investigation and evaluation of the specific facts
6 alleged and of the reliability and credibility of the information, may
7 file a petition for commitment of such person with the superior court
8 or district court. If the designated chemical dependency
9 specialist((7)) finds that the initial needs of such person would be
10 better served by placement within the mental health system, the person
11 shall be referred to an evaluation and treatment facility as defined in
12 RCW 71.05.020 or 71.34.020. If placement in an alcohol treatment
13 program is available and deemed appropriate, the petition shall allege
14 that: The person is an alcoholic who is incapacitated by alcohol, or
15 in the case of a minor incapacitated by alcoholism and/or other drug
16 addiction, or that the person has twice before in the preceding twelve
17 months been admitted for detoxification or treatment for alcoholism
18 pursuant to RCW 70.96A.110, or in the case of a minor, detoxification
19 or treatment for alcohol or drug addiction, and is in need of a more
20 sustained treatment program, or that the person is an alcoholic, or in
21 the case of a minor, an alcoholic or other drug addict, who has
22 threatened, attempted, or inflicted physical harm on another and is
23 likely to inflict physical harm on another unless committed. A refusal
24 to undergo treatment, by itself, does not constitute evidence of lack
25 of judgment as to the need for treatment. The petition shall be
26 accompanied by a certificate of a licensed physician who has examined
27 the person within five days before submission of the petition, unless
28 the person whose commitment is sought has refused to submit to a
29 medical examination, in which case the fact of refusal shall be alleged
30 in the petition. The certificate shall set forth the licensed

1 physician's findings in support of the allegations of the petition. A
2 physician employed by the petitioning program or the department is
3 eligible to be the certifying physician.

4 (2) Upon filing the petition, the court shall fix a date for a
5 hearing no less than two and no more than seven days after the date the
6 petition was filed unless the person petitioned against is presently
7 being detained in a program, pursuant to RCW 70.96A.120 ~~((or))~~,
8 71.05.210, or 71.34.050, as now or hereafter amended, in which case the
9 hearing shall be held within seventy-two hours of the filing of the
10 petition: PROVIDED, HOWEVER, That the above specified seventy-two
11 hours shall be computed by excluding Saturdays, Sundays, and holidays:
12 PROVIDED FURTHER, That, the court may, upon motion of the person whose
13 commitment is sought, or upon motion of petitioner with written
14 permission of the person whose commitment is sought, or his or her
15 counsel and, upon good cause shown, extend the date for the hearing.
16 A copy of the petition and of the notice of the hearing, including the
17 date fixed by the court, shall be served by the designated chemical
18 dependency specialist on the person whose commitment is sought, his or
19 her next of kin, a parent or his or her legal guardian if he or she is
20 a minor, and any other person the court believes advisable. A copy of
21 the petition and certificate shall be delivered to each person
22 notified.

23 (3) At the hearing the court shall hear all relevant testimony,
24 including, if possible, the testimony, which may be telephonic, of at
25 least one licensed physician who has examined the person whose
26 commitment is sought. Communications otherwise deemed privileged under
27 the laws of this state are deemed to be waived in proceedings under
28 this chapter when a court of competent jurisdiction in its discretion
29 determines that the waiver is necessary to protect either the detained
30 person or the public. The waiver of a privilege under this section is

1 limited to records or testimony relevant to evaluation of the detained
2 person for purposes of a proceeding under this chapter. Upon motion by
3 the detained person, or on its own motion, the court shall examine a
4 record or testimony sought by a petitioner to determine whether it is
5 within the scope of the waiver.

6 The record maker shall not be required to testify in order to
7 introduce medical, nursing, or psychological records of detained
8 persons so long as the requirements of RCW 5.45.020 are met, except
9 that portions of the record that contain opinions as to whether the
10 detained person is an alcoholic, or in the case of a minor
11 incapacitated by alcoholism and/or other drug addiction, must be
12 deleted from the records unless the person offering the opinions is
13 available for cross-examination. The person shall be present unless
14 the court believes that his or her presence is likely to be injurious
15 to him or her; in this event the court may deem it appropriate to
16 appoint a guardian ad litem to represent him or her throughout the
17 proceeding. If deemed advisable, the court may examine the person out
18 of courtroom. If the person has refused to be examined by a licensed
19 physician, he or she shall be given an opportunity to be examined by a
20 court appointed licensed physician. If he or she refuses and there is
21 sufficient evidence to believe that the allegations of the petition are
22 true, or if the court believes that more medical evidence is necessary,
23 the court may make a temporary order committing him or her to the
24 department for a period of not more than five days for purposes of a
25 diagnostic examination.

26 (4) If after hearing all relevant evidence, including the results
27 of any diagnostic examination, the court finds that grounds for
28 involuntary commitment have been established by clear, cogent, and
29 convincing proof, it shall make an order of commitment to an approved
30 treatment program. It shall not order commitment of a person unless it

1 determines that an approved treatment program is available and able to
2 provide adequate and appropriate treatment for him or her.

3 (5) A person committed under this section shall remain in the
4 program for treatment for a period of sixty days unless sooner
5 discharged. At the end of the sixty-day period, he or she shall be
6 discharged automatically unless the program, before expiration of the
7 period, files a petition for his or her recommitment upon the grounds
8 set forth in subsection (1) of this section for a further period of
9 ninety days unless sooner discharged. If a person has been committed
10 because he or she is an alcoholic, or, in the case of a minor, an
11 alcoholic or other drug addict, likely to inflict physical harm on
12 another, the program shall apply for recommitment if after examination
13 it is determined that the likelihood still exists.

14 (6) Upon the filing of a petition for recommitment under subsection
15 (5) of this section, the court shall fix a date for hearing no less
16 than two and no more than seven days after the date the petition was
17 filed: PROVIDED, That, the court may, upon motion of the person whose
18 commitment is sought and upon good cause shown, extend the date for the
19 hearing. A copy of the petition and of the notice of hearing,
20 including the date fixed by the court, shall be served by the treatment
21 program on the person whose commitment is sought, his or her next of
22 kin, the original petitioner under subsection (1) of this section if
23 different from the petitioner for recommitment, one of his or her
24 parents or his or her legal guardian if he or she is a minor, and his
25 or her attorney and any other person the court believes advisable. At
26 the hearing the court shall proceed as provided in subsection (3) of
27 this section.

28 (7) The approved treatment program shall provide for adequate and
29 appropriate treatment of a person committed to its custody. A person

1 committed under this section may be transferred from one approved
2 public treatment program to another if transfer is medically advisable.

3 (8) A person committed to the custody of a program for treatment
4 shall be discharged at any time before the end of the period for which
5 he or she has been committed and he or she shall be discharged by order
6 of the court if either of the following conditions are met:

7 (a) In case of an alcoholic committed on the grounds of likelihood
8 of infliction of physical harm upon himself, herself, or another, or,
9 in the case of a minor, an alcoholic or other drug addict, the
10 likelihood no longer exists; or further treatment will not be likely to
11 bring about significant improvement in the person's condition, or
12 treatment is no longer adequate or appropriate.

13 (b) In case of an alcoholic committed on the grounds of the need of
14 treatment and incapacity or, in the case of a minor, incapacitated by
15 alcoholism and/or other drug addiction, that the incapacity no longer
16 exists.

17 (9) The court shall inform the person whose commitment or
18 recommitment is sought of his or her right to contest the application,
19 be represented by counsel at every stage of any proceedings relating to
20 his or her commitment and recommitment, and have counsel appointed by
21 the court or provided by the court, if he or she wants the assistance
22 of counsel and is unable to obtain counsel. If the court believes that
23 the person needs the assistance of counsel, the court shall require, by
24 appointment if necessary, counsel for him or her regardless of his or
25 her wishes. The person shall, if he or she is financially able, bear
26 the costs of such legal service; otherwise such legal service shall be
27 at public expense. The person whose commitment or recommitment is
28 sought shall be informed of his or her right to be examined by a
29 licensed physician of his or her choice. If the person is unable to

1 obtain a licensed physician and requests examination by a physician,
2 the court shall employ a licensed physician.

3 (10) A person committed under this chapter may at any time seek to
4 be discharged from commitment by writ of habeas corpus in a court of
5 competent jurisdiction.

6 (11) The venue for proceedings under this section is the county in
7 which person to be committed resides or is present.

8 (12) When in the opinion of the professional person in charge of
9 the program providing involuntary treatment under this chapter, the
10 committed patient can be appropriately served by less restrictive
11 treatment before expiration of the period of commitment, then the less
12 restrictive care may be required as a condition for early release for
13 a period which, when added to the initial treatment period, does not
14 exceed the period of commitment. If the program designated to provide
15 the less restrictive treatment is other than the program providing the
16 initial involuntary treatment, the program so designated must agree in
17 writing to assume such responsibility. A copy of the conditions for
18 early release shall be given to the patient, the designated chemical
19 dependency specialist of original commitment, and the court of original
20 commitment. The program designated to provide less restrictive care
21 may modify the conditions for continued release when the modifications
22 are in the best interests of the patient. If the program providing
23 less restrictive care and the designated chemical dependency specialist
24 determine that a conditionally released patient is failing to adhere to
25 the terms and conditions of his or her release, or that substantial
26 deterioration in the patient's functioning has occurred, then the
27 designated chemical dependency specialist shall notify the court of
28 original commitment and request a hearing to be held no less than two
29 and no more than seven days after the date of the request to determine
30 whether or not the person should be returned to more restrictive care.

1 The designated chemical dependency specialist shall file a petition
2 with the court stating the facts substantiating the need for the
3 hearing along with the treatment recommendations. The patient shall
4 have the same rights with respect to notice, hearing, and counsel as
5 for the original involuntary treatment proceedings. The issues to be
6 determined at the hearing are whether the conditionally released
7 patient did or did not adhere to the terms and conditions of his or her
8 release to less restrictive care or that substantial deterioration of
9 the patient's functioning has occurred and whether the conditions of
10 release should be modified or the person should be returned to a more
11 restrictive program. The hearing may be waived by the patient and his
12 or her counsel and his or her guardian or conservator, if any, but may
13 not be waived unless all such persons agree to the waiver. Upon
14 waiver, the person may be returned for involuntary treatment or
15 continued on conditional release on the same or modified conditions.

16 **Sec. 11.** RCW 71.05.210 and 1989 c 120 s 6 are each amended to read
17 as follows:

18 Each person involuntarily admitted to an evaluation and treatment
19 facility shall, within twenty-four hours of his or her admission, be
20 examined and evaluated by a licensed physician who may be assisted by
21 a physician(~~s~~) assistant according to chapter 18.71A RCW or a nurse
22 practitioner according to chapter 18.88 RCW and a mental health
23 professional as defined in this chapter, and shall receive such
24 treatment and care as his or her condition requires including treatment
25 on an outpatient basis for the period that he or she is detained,
26 except that, beginning twenty-four hours prior to a court proceeding,
27 the individual may refuse all but emergency life-saving treatment, and
28 the individual shall be informed at an appropriate time of his or her
29 right to such refusal of treatment. Such person shall be detained up

1 to seventy-two hours, if, in the opinion of the professional person in
2 charge of the facility, or his or her professional designee, the person
3 presents a likelihood of serious harm to himself or herself or others,
4 or is gravely disabled. A person who has been detained for seventy-two
5 hours shall no later than the end of such period be released, unless
6 referred for further care on a voluntary basis, or detained pursuant to
7 court order for further treatment as provided in this chapter.

8 If, after examination and evaluation, the licensed physician and
9 mental health professional determine that the initial needs of the
10 person would be better served by placement in ~~((an alcohol))~~ a chemical
11 dependency treatment facility, then the person shall be referred to an
12 approved treatment ~~((facility))~~ program defined under RCW 70.96A.020.

13 An evaluation and treatment center admitting any person pursuant to
14 this chapter whose physical condition reveals the need for
15 hospitalization shall assure that such person is transferred to an
16 appropriate hospital for treatment. Notice of such fact shall be given
17 to the court, the designated attorney, and the designated county mental
18 health professional and the court shall order such continuance in
19 proceedings under this chapter as may be necessary, but in no event may
20 this continuance be more than fourteen days.

21 **Sec. 12.** RCW 71.34.060 and 1985 c 354 s 6 are each amended to read
22 as follows:

23 (1) Each minor approved by the facility for inpatient admission
24 shall be examined and evaluated by a children's mental health
25 specialist as to the child's mental condition and by a physician as to
26 the child's physical condition within twenty-four hours of admission.
27 Reasonable measures shall be taken to ensure medical treatment is
28 provided for any condition requiring immediate medical attention.

1 (2) If, after examination and evaluation, the children's mental
2 health specialist and the physician determine that the initial needs of
3 the minor would be better served by placement in a chemical dependency
4 treatment facility, then the minor shall be referred to an approved
5 treatment program defined under RCW 70.96A.020.

6 (3) The admitting facility shall take reasonable steps to notify
7 immediately the minor's parent of the admission.

8 (~~(3)~~) (4) During the initial seventy-two hour treatment period,
9 the minor has a right to associate or receive communications from
10 parents or others unless the professional person in charge determines
11 that such communication would be seriously detrimental to the minor's
12 condition or treatment and so indicates in the minor's clinical record,
13 and notifies the minor's parents of this determination. In no event
14 may the minor be denied the opportunity to consult an attorney.

15 (~~(4)~~) (5) If the evaluation and treatment facility admits the
16 minor, it may detain the minor for evaluation and treatment for a
17 period not to exceed seventy-two hours from the time of provisional
18 acceptance. The computation of such seventy-two hour period shall
19 exclude Saturdays, Sundays, and holidays. This initial treatment
20 period shall not exceed seventy-two hours except when an application
21 for voluntary inpatient treatment is received or a petition for
22 fourteen-day commitment is filed.

23 (~~(5)~~) (6) Within twelve hours of the admission, the facility
24 shall advise the minor of his or her rights as set forth in this
25 chapter.

26 NEW SECTION. **Sec. 13.** The purpose of sections 7 through 12 of
27 this act is solely to provide authority for the involuntary commitment
28 of minors addicted by drugs within available funds and current programs
29 and facilities. Nothing in sections 7 through 12 of this act shall be

1 construed to require the addition of new facilities nor affect the
2 department's authority for the uses of existing programs and facilities
3 authorized by law. Nothing in sections 7 through 12 of this act shall
4 prevent a parent or guardian from requesting the involuntary commitment
5 of a minor through a county designated chemical dependency specialist
6 on an ability to pay basis.

9 (1) At the dispositional hearing regarding an adjudicated at-risk
10 youth, the court shall consider the recommendations of the parties and

12 department. The court may enter a dispositional order that will assist
13 the parent in maintaining the care, custody, and control of the child
14 and assist the family to resolve family conflicts or problems.

15 (2) The court may set conditions of supervision for the child that

18 (b) Counseling;

19 (c) Participation in a substance abuse treatment program;

20 (d) Reporting on a regular basis to the department or any other

8 court supervision of the child unless a contempt action is pending in
9 the case. The court may retain jurisdiction over the matter for the
10 purpose of concluding any pending contempt proceedings, including the
11 full satisfaction of any penalties imposed as a result of a contempt

14 compliance with the dispositional order, assist in coordinating the
15 provision of court-ordered services, and submit reports at subsequent
16 review hearings regarding the status of the case.

18 in conflict with federal requirements that are a prescribed condition
19 to the allocation of federal funds to the state, the conflicting part
20 of this act is inoperative solely to the extent of the conflict and
21 with respect to the agencies directly affected, and this finding does
22 not affect the operation of the remainder of this act in its
23 application to the agencies concerned. The rules under this act shall
24 meet federal requirements that are a necessary condition to the receipt
25 of federal funds by the state.
