- 1 AN ACT Relating to school construction standards for fire
- 2 prevention and safety; amending RCW 48.48.045; and adding a new section
- 3 to chapter 19.27 RCW.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 NEW SECTION. Sec. 1. A new section is added to chapter 19.27 RCW
- 6 to read as follows:
- 7 The building code council shall adopt rules by December 1, 1991,
- 8 requiring that all buildings classed as E-1 occupancies, as defined in
- 9 the state building code, except portable school classrooms, constructed
- 10 after the effective date of this act, be provided with an automatic
- 11 fire-extinguishing system. Rules adopted by the council shall consider
- 12 applicable nationally recognized fire and building code standards and
- 13 local conditions.
- 14 By December 15, 1991, the council shall transmit to the
- 15 superintendent of public instruction, the state board of education, and

- 1 the fire protection policy board copies of the rules as adopted. The
- 2 superintendent of public instruction, the state board of education, and
- 3 the fire protection policy board shall respond to the council by
- 4 February 15, 1992, with any recommended changes to the rule. If
- 5 changes are recommended the council shall immediately consider those

- 13 be established by the state fire protection board. ((The director of
- 14 community development, through the director of fire protection, shall
- 15 adopt such nationally recognized fire and building codes and standards
- 16 as may be applicable to local conditions. After the approval of such
- 17 standards by the superintendent of public instruction and the state
- 18 board of education, the director of community development, through))
- 19 The director of fire protection ((-)) shall make or cause to be made
- 20 plan reviews and construction inspections for all E-1 occupancies as
- 21 may be necessary to insure compliance with ((said codes)) the state
- 22 <u>building code</u> and standards <u>for schools adopted under chapter 19.27</u>
- 23 RCW. Nothing in this section prohibits the director of fire protection
- 24 from delegating construction inspection authority to any local
