- 1 AN ACT Relating to schools for the twenty-first century; amending
- 2 RCW 28A.630.140; and adding a new section to chapter 28A.630 RCW.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 Sec. 1. RCW 28A.630.140 and 1988 c 1 s 1 are each amended to read
- 5 as follows:
- 6 Initial applications to participate in the schools for the twenty-
- 7 first century pilot program shall be submitted by the school district
- 8 board of directors to the state board of education not later than May
- 9 31, 1988. Subject to available funding, additional applications may be
- 10 submitted for board consideration by November 1 of subsequent years.
- 11 Each application shall contain a proposed plan which:
- 12 (1) Enumerates specific activities to be carried out as part of the
- 13 pilot school(s) project;

- 1 (2) Commits all parties to work cooperatively during the term of
- 2 the pilot project;
- 3 (3) Includes provisions for some or all certificated school staff,
- 4 <u>including certificated administrative staff</u>, and classified school
- 5 employees whose primary duties are the daily educational instruction of
- 6 students, to be employed on supplemental contracts with additional
- 7 compensation for a minimum of <u>an average of</u> ten additional days beyond
- 8 the general state funded school year allocations for the participating
- 9 employees, and staff development time as provided by legislative
- 10 appropriation, and, notwithstanding ((the provisions of RCW
- 28A.58.095(1)) RCW 28A.400.200, district resources may be used to fund
- 12 the employment of staff beyond the <u>average of</u> ten additional days for
- 13 the purposes of the pilot project;
- 14 (4) Includes budget plans for the project and additional
- 15 anticipated sources of funding, including private grants and
- 16 contributions, if any;
- 17 (5) Identifies the technical resources desired, the potential costs
- 18 of those resources, and the institutions of higher education,
- 19 educational service districts, or consultants available to provide such
- 20 services;
- 21 (6) Identifies the evaluation and accountability processes to be
- 22 used to measure school-wide student and project performance, and
- 23 identifies a model which provides the basis for a staff incentive pay
- 24 system. Implementation of the staff incentive pay system is not
- 25 required;
- 26 (7) Justifies each request for waiver of specific state statutes or
- 27 administrative rules during at least the first two years of the
- 28 project;

- 1 (8) Includes a written statement that school directors and
- 2 administrators are willing to exempt the pilot school(s) from
- 3 specifically identified local rules, as needed;
- 4 (9) Includes a written statement that the school directors and the
- 5 local bargaining agents will modify those portions of their local
- 6 agreements as applicable for the pilot school(s) project; and
- 7 (10) Includes written statements of support from the district's
- 8 board of directors, the district superintendent, the principal and
- 9 staff of the building requesting to become a pilot school; and
- 10 statements of support, willingness to participate, or concerns from any
- 11 interested parent, business, or community organization.
- 12 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 28A.630
- 13 RCW to read as follows:
- 14 (1) The state board of education shall submit by January 15, 1995,
- 15 to the legislature and the governor, a final report on the schools for
- 16 the twenty-first century program. This report shall include but is not
- 17 limited to the following information:
- 18 (a) Improvements in student performance resulting from activities
- 19 carried out under the schools for the twenty-first century program;
- 20 (b) The relationship between improvements in student performance
- 21 and increasing local decision-making authority under the schools for
- 22 the twenty-first century program; and
- 23 (c) Identification of restructuring that occurred with and without
- 24 the granting of waivers of state statutes or administrative rules.
- 25 (2) The state board of education and the superintendent of public
- 26 instruction, from available funds, may contract for an independent
- 27 evaluation of the schools for the twenty-first century program.
- 28 (3) This section shall expire January 30, 1995.
